1 moves to amend the bill on page 2, lines 40-48, by rewriting those lines to read:

3 **""§ 106-678. Authority to regulate fertilizers.**

4 No county, city, or other political subdivision of the State shall adopt or continue in effect
5 any ordinance, rule, regulation, or resolution regulating the use, sale, distribution, storage,
6 transportation, disposal, formulation, labeling, registration, manufacture, or application of
7 fertilizer. Nothing in this section shall prohibit a county, city, or other political subdivision of
8 the State from exercising its planning and zoning authority under Article 19 of Chapter 160A of
9 the General Statutes or Article 18 of Chapter 153A of the General Statutes, or from exercising
10 its fire prevention or inspection authority. Nothing in this section shall limit the authority of the
11 Department of Environment and Natural Resources or the Environmental Management
12 Commission to enforce water quality standards. Nothing in this section shall prohibit a county,
13 city, or other political subdivision of the State from adopting ordinances regulating fertilizers to
14 protect water quality, provided that the ordinances have been approved by the Environmental
15 Management Commission or the Department of Environment and Natural Resources as part of
16 a local plan or NPDES permit application and do not exceed the State's minimum requirements
17 to protect water quality as established by the Environmental Management Commission under
18 Part 1, Article 21 of Chapter 143 of the General Statutes."; and

20 on page 22, lines 9-10 by rewriting those lines to read:

22 "Environmental Management Commission on or after January 1, 2013, and prior to January 1,
23 2014. Subsection (a) of this section expires when the Commission issues"; and

25 on page 43, lines 24-30, by rewriting those lines to read:

27 "(6) A general contractor licensed under Article 1 of Chapter 87 of the General
28 Statutes who possesses a classification under G.S. 87-10(b) as a building
29 contractor, a residential contractor, or a public utilities contractor."
