AN ACT TO ESTABLISH A NEW SALARY SCHEDULE FOR CERTIFIED PERSONNEL OF THE NORTH CAROLINA PUBLIC SCHOOLS.

The General Assembly of North Carolina enacts:

Section 1. (a) Effective July 1, 1989, the following salary schedule shall be applicable to certified personnel of the public schools who are classified as "A" teachers:

The 1988-89 salary amount in the salary schedules for both "A"and "G"teachers includes longevity payments as follows: one and one-half percent (1.50%) of gross annual salary for the 10-14 year service interval, two and one-fourth percent (2.25%) of gross annual salary for the 15-19 year service interval, three and one-fourth percent (3.25%) of gross annual salary for the 20-24 year service interval, and four and one-half percent (4.50%) of gross annual salary for the 25-30 year service interval. Longevity payments for years 1989-90 and beyond are included in the salary increase for those years.

- (c) Educators shall be placed on the new salary schedule based on years of experience and shall receive the salary increases necessary to bring them to the appropriate level on the schedule; provided, however, that no educator shall receive less than a five hundred dollar (\$500.00) salary increase in 1990-91, and no educator's salary may be reduced as a result of the educator's placement on the salary schedule.
- (d) Enactment of this salary schedule may not be construed to diminish or rescind additions to salary amounts provided by law for teacher participation in the Career Development Pilot Program, or for a teacher's possession of an advanced certificate or earned doctorate degree; nor may enactment of this salary schedule be construed to diminish or rescind rights or benefits conferred upon teachers by law, other than those which expressly refer to salary matters.
- (e) The State Board of Education shall adopt rules and regulations necessary to implement this act.
- Sec. 2. There is appropriated from the General Fund to the Department of Public Education the sum of one hundred eighty-two million nine hundred fifty-five thousand dollars (\$182,955,000) for the 1989-90 fiscal year, and the sum of three hundred sixty-four million six hundred ten thousand dollars (\$364,610,000) for the 1990-91 fiscal year, to be used for the implementation of this act.
 - Sec. 3. This act shall become effective July 1, 1989.
