Sec. 2. Funds raised from the increase in fees enacted in Section 1 of this act shall be used by the North Carolina State Board of Opticians for the employment of a person to investigate violations of Article 17, Chapter 90 of the General Statutes.

Sec. 3. G.S. 89A-2(c) reads as rewritten:

"(c) Each landscape architect shall, upon registration, obtain a seal of the design authorized by the Board, bearing the name of the registrant, date of registration, number of certificate and the legend 'N.C. Registered Landscape Architect'. Such seal may be used only while the registrant's certificate is in full force and effect.

Nothing in this Chapter shall be construed as authorizing the use or acceptance of the seal of a landscape architect in lieu of or substitute for the seal of an architect, engineer or land surveyor."

Sec. 4. G.S. 89A-6 reads as rewritten:

"§ 89A-6. Fees.
