1 A JOINT RESOLUTION HONORING HUGH CALE, A FORMER MEMBER OF  
2 THE GENERAL ASSEMBLY, AND COMMENDING ELIZABETH CITY STATE  
3 UNIVERSITY FOR ITS CONTRIBUTIONS TO THE ADVANCEMENT OF  
4 EDUCATION ON THE ONE HUNDREDTH YEAR OF THE UNIVERSITY'S  
5 FOUNDING.

6       Whereas, Hugh Cale was a black man born in 1835, in Perquimans County to  
7 John and Betsy Cale; and

8       Whereas, as a young man, Hugh Cale moved to Elizabeth City where he  
9 became a very influential and well-respected resident; and

10       Whereas, Hugh Cale was active in the Mt. Lebanon Church and the local  
11 Masons; and

12       Whereas, Hugh Cale, a leader in civic affairs, was elected justice of the peace,  
13 served two terms on the board of county commissioners, was a member of the county  
14 board of education, and was treasurer of Elizabeth City; and

15       Whereas, Hugh Cale helped petition to get the town's first fire engine, was a  
16 trustee for the first local black cemetery, and was president of the first fair held by  
17 blacks in Pasquotank County; and

18       Whereas, Hugh Cale's aspirations to achieve a higher office became a reality  
19 when he was elected to the House of Representatives of the General Assembly in 1876  
20 and went on to serve in the 1879, 1880, 1885, and 1891 Sessions of the General  
21 Assembly; and

22       Whereas, Hugh Cale worked hard to improve the life and educational  
23 opportunities for blacks in northeastern North Carolina; and

1           Whereas, on March 3, 1891, the General Assembly of North Carolina ratified  
2 House Bill 383, sponsored by Representative Hugh Cale that read as follows:

3           "Section 1. That it shall be the duty of the state board of education to establish a  
4 normal school at Elizabeth City, in the county of Pasquotank, for the teaching and  
5 training of teachers of the colored race to teach in the common schools of the state.

6           Sec. 2. That the sum of five hundred dollars from the Fayetteville normal  
7 school fund and the further sums of one hundred dollars each from the Salisbury,  
8 Franklinton, Goldsboro and Plymouth normal school funds are hereby appropriated for  
9 the payment of instructors in said normal school at Elizabeth City.

10          Sec. 3. That all laws and clauses of laws in conflict with this act are hereby  
11 repealed.

12          Sec. 4. This act shall go into effect from and after the first day of January,  
13 eighteen hundred and ninety-two."; and

14          Whereas, Hugh Cale died in 1910, knowing that his life had made a  
15 significant impact on those who knew him; and

16          Whereas, Hugh Cale would be proud that Elizabeth City State Normal School  
17 became Elizabeth City State University, a constituent institution of The University of  
18 North Carolina, dedicated to the pursuit of academic excellence; and

19          Whereas, Elizabeth City State University has expanded from a teacher  
20 preparatory institution to a university that offers bachelors degrees in a wide variety of  
21 courses; and

22          Whereas, on the one hundredth year of the University's founding, it is fitting  
23 that the General Assembly honors Hugh Cale and recognizes the progress that Elizabeth  
24 City State University has made;

25 Now, therefore, be it resolved by the House of Representatives, the Senate concurring:

26          Section 1. The General Assembly wishes to honor the life and memory of  
27 Hugh Cale.

28          Sec. 2. The General Assembly commends Elizabeth City State University for  
29 its contributions to the advancement of education. The General Assembly further  
30 extends its congratulations on the centennial celebration of Elizabeth City State  
31 University.

32          Sec. 3. The Speaker of the House of Representatives and the President Pro  
33 Tempore of the Senate may appoint a delegation of the General Assembly to meet in  
34 Elizabeth City on Friday, March 1, 1991, to hold a mock session of the General  
35 Assembly for the purpose of commemorating the centennial of Elizabeth City State  
36 University.

37          Sec. 4. The Secretary of State shall transmit a certified copy of this resolution  
38 to Chancellor Jimmy R. Jenkins of Elizabeth City State University.

39          Sec. 5. This resolution is effective upon ratification.
