- Commission occurs, the appointing authority shall appoint a replacement to serve for 1 2 the unexpired term. 3 The Commission shall meet upon the call of the chair. (c) The Secretary of Administration shall provide staff support for Commission 4 (d)5 activities and travel reimbursement for Commission members. 6 (e) The Commission shall establish a schedule of uniform entrance fees for the 7 North Carolina Aquariums and may revise that schedule from time to time. The 8 Commission shall recommend expenditures from the North Carolina Special Aquariums 9 Fund, hereafter established. 10 (f) The North Carolina Special Aquariums Fund, hereafter 'Fund', is hereby created, and shall be a special and nonreverting fund. The Fund shall be used only for 11 12 repair, maintenance, and educational exhibit construction at existing aquariums. The Fund may also be used to match private funds that are raised for these purposes. 13 14 (g) Beginning June 30, 1992, the Department of Administration shall retain, at 15 the end of each fiscal year, unbudgeted entrance fee receipts from the North Carolina Aquariums and deposit the receipts into the Fund. The Secretary of Administration may 16 17 expend funds only upon the recommendation of the Commission and the approval of the 18 Office of State Budget and Management. The Department of Administration shall provide an annual report showing the use of aquarium entrance fees collected to the 19 20 Office of State Budget and Management and to the Fiscal Research Division of the 21 Legislative Services Office." 22
