1 A BILL TO BE ENTITLED  
2 AN ACT TO EQUALIZE PER DIEM PAYMENTS FOR OCCUPATIONAL  
3 LICENSING BOARD MEMBERS.

4 The General Assembly of North Carolina enacts:

5 Section 1. G.S. 93B-5(a) reads as rewritten:

6 "(a) Board members shall receive as compensation for their services per diem not  
7 to exceed ~~thirty-five dollars (\$35.00)~~ one hundred dollars (\$100.00) for each day during  
8 which they are engaged in the official business of the board."

9 Sec. 2. G.S. 90-133 reads as rewritten:

10 "**§ 90-133. Fees held by Board; salaries; payment of expenses.**

11 All fees shall be paid in advance to the treasurer of the Board, to be by him held as a  
12 fund for the use of the State Board of Osteopathic Examination and Registration. The  
13 compensation and expenses of the members and officers of said Board, and all expenses  
14 proper and necessary, in the opinion of said Board, to discharge its duties under and to  
15 enforce the law, shall be in accordance with G.S. 93B-5, shall be paid out of such fund,  
16 upon the warrant of the president and secretary of said Board, and no expense shall be  
17 created to exceed the income of fees or fines as herein provided. ~~The salaries shall be  
18 fixed by the Board, but shall not exceed ten dollars (\$10.00) per day per member, and railroad  
19 and hotel expenses."~~

20 Sec. 3. G.S. 90-171.21(g) reads as rewritten:

21 "(g) Reimbursement. – Board members are entitled to receive compensation and  
22 reimbursement as authorized by G.S. 93B-5, ~~provided that Board members may receive~~

1 a per diem not to exceed fifty dollars (\$50.00) per day for each day during which they  
2 are engaged in the official business of the Board."

3 Sec. 4. G.S. 90-184 reads as rewritten:

4 **"§ 90-184. Compensation of the Board.**

5 In addition to such reimbursement for travel and other expenses as is normally  
6 allowed to State employees, each member of the Board, for each day or substantial  
7 portion thereof he is engaged in the work of the Board may receive a per diem  
8 allowance, as determined by the Board, ~~not to exceed thirty five dollars (\$35.00) per~~  
9 ~~day~~ Board in accordance with G.S. 93B-5. None of the expenses of the Board or of the  
10 members shall be paid by the State."

11 Sec. 5. G.S. 90A-56 reads as rewritten:

12 **"§ 90A-56. Compensation of Board members; expenses; employees.**

13 Members of the Board shall receive ~~thirty five dollars (\$35.00) per day for each day~~  
14 ~~actually spent in the performance of duties required by this Chapter, plus all necessary~~  
15 ~~travel expenses in an amount not to exceed that authorized under G.S. 138-6(a), (1), (2),~~  
16 ~~and (3) for officers and employees of State departments~~ compensation and be  
17 reimbursed for travel expenses in accordance with G.S. 93B-5. The Board may employ  
18 necessary personnel for the performance of its functions and fix the compensation  
19 therefor, within the limits of funds available to the Board. The total expenses of the  
20 administration of this Article shall not exceed the total income therefrom and none of  
21 the expenses of said Board or the compensation or expenses of any officer thereof or  
22 any employee shall ever be paid or payable out of the treasury of the State of North  
23 Carolina; and neither the Board nor any officer or employee thereof shall have any  
24 power or authority to make or incur any expense, debt, or other financial obligation  
25 binding upon the State of North Carolina."

26 Sec. 6. G.S. 93-12(1) reads as rewritten:

27 "(1) To elect from its members a president, vice-president and secretary-  
28 treasurer. The members of the Board shall ~~be paid, for the time~~  
29 ~~actually expended in pursuance of the duties imposed upon them by~~  
30 ~~this Chapter, an amount not exceeding ten dollars (\$10.00) per day,~~  
31 ~~and they shall be entitled to necessary traveling expenses~~ receive  
32 compensation and reimbursement for travel expenses in accordance  
33 with G.S. 93B-5."

34 Sec. 7. This act becomes effective October 1, 1992.
