A BILL TO BE ENTITLED 1 2 AN ACT TO REQUIRE MANDATORY COMMUNITY SERVICE FOR AN INITIAL CONVICTION OF MAKING FALSE BOMB REPORTS TO A HOSPITAL 3 4 FACILITY OR USING A FALSE BOMB TO CREATE A SCARE IN A 5 HOSPITAL FACILITY AND TO PROVIDE THAT A SECOND OR SUBSEQUENT CONVICTION OF EITHER OFFENSE IS A CLASS I FELONY. 6 The General Assembly of North Carolina enacts: 7 Section 1. G.S. 14-69.1 reads as rewritten: 8 9 "§ 14-69.1. Making a false report concerning destructive device. If any person shall, by any means of communication to any person or group 10 (a) of persons, make a report, knowing or having reason to know the same to be false, that 11 there is located in any building, house or other structure whatsoever or any vehicle, 12 aircraft, vessel or boat any device designed to destroy or damage the building, house or 13 structure or vehicle, aircraft, vessel or boat by explosion, blasting or burning, he shall be 14 guilty of a misdemeanor, and shall, upon conviction, be fined or imprisoned or both in 15 the discretion of the court. 16 If any person shall, by any means of communication to any person or group 17 (b) of persons, make a report, knowing or having reason to know the same to be false, that 18 there is located in any hospital facility as defined in G.S. 131E-6, which includes a 19 health clinic facility, any device designed to destroy or damage the hospital or health 20 clinic facility by explosion, blasting, or burning, he shall, upon a first conviction, be 21 guilty of a misdemeanor, punishable by a minimum of 100 hours of mandatory 22

community service. Upon a second or subsequent conviction under this subsection, he 1 shall be guilty of a Class I felony and shall be fined or imprisoned or both in the 2 3 discretion of the court." Sec. 2. G.S. 14-69.2 reads as rewritten: 4 5 "§ 14-69.2. Perpetrating hoax by use of false bomb or other device. 6 If any person, with intent to perpetrate a hoax, shall secrete, place or display (a) 7 any device, machine, instrument or artifact, so as to cause any person reasonably to 8 believe the same to be a bomb or other device capable of causing injury to persons or 9 property, he shall be guilty of a misdemeanor, and shall, upon conviction, be fined or 10 imprisoned or both in the discretion of the court. A violation of subsection (a) of this section that occurs in a hospital facility as 11 (b) 12 defined in G.S. 131E-6 is, upon a first conviction, a misdemeanor punishable by a minimum of 100 hours of mandatory community service. A second or subsequent 13 14 conviction under subsection (a) of this section is a Class I felony."

15 Sec. 3. This act becomes effective October 1, 1991, and applies to offenses 16 occurring on or after that date.
