Sec. 6. Section 3 of this act becomes effective only if the constitutional amendments set out in Sections 1 and 2 of this act are approved by the voters. If the constitutional amendments are approved by the voters, Section 3 of this act becomes effective upon certification of the constitutional amendments.

Sec. 7. This act is effective upon ratification.
