member; a plate issued to an enlisted member, a senior member, or a 1 2 cadet member shall begin with the number '501'. 3 **(4)** Class D Citizen's Radio Station Operator. - Issuable to a Class D 4 citizen's radio station operator licensed by the Federal 5 Communications Commission. The plate shall bear the operator's 6 official Class D citizen's radio station call letters. 7 Clerk of Superior Court. – Issuable to a clerk of superior court. The (5) 8 plate shall bear the phrase 'Clerk Superior Court' and the letter 'C' 9 followed by a number that indicates the county the clerk serves. 10 (6) Coast Guard Auxiliary Member. – Issuable to an active member of the United States Coast Guard Auxiliary. The plate shall bear the phrase 11 12 'Coast Guard Auxiliary'. 13 (6a) Collegiate Insignia Plate. – Issuable to the registered owner of a motor 14 vehicle in accordance with G.S. 20-81.12. The plate may bear a phrase 15 or an insignia representing a public or private college or university. 16 **(7)** Congressional Medal of Honor Recipient. – Issuable to a recipient of 17 the Congressional Medal of Honor. 18 (8) Disabled Veteran. – Issuable to a veteran of the armed forces of the 19 United States who suffered a 100% service-connected disability. 20 (9) District Attorney. - Issuable to a North Carolina or United States 21 District Attorney. The plate issuable to a North Carolina district attorney shall bear the letters 'DA' followed by a number that 22 represents the prosecutorial district the district attorney serves. The 23 24 plate for a United States attorney shall bear the phrase 'U.S. Attorney' 25 followed by a number that represents the district the attorney serves, with 1 being the Eastern District, 2 being the Middle District, and 3 26 27 being the Western District. 28 (10)Fire Department or Rescue Squad Member. – Issuable to an active 29 regular member or volunteer member of a fire department, rescue 30 squad, or both a fire department and rescue squad. The plate shall bear the words 'Firefighter', 'Rescue Squad', or 'Firefighter-Rescue Squad'. 31 Historic Vehicle Owner. – Issuable for a motor vehicle that is at least 32 (11)35 years old measured from the date of manufacture. The plate for a 33 34 vehicle that is 35 to 50 years old shall bear the phrase 'Antique'. The 35 plate for a vehicle that is at least 50 years old shall bear the phrase 'Horseless Carriage'. 36 37 Historical Attraction Plate. – Issuable to the registered owner of a (11a)38 motor vehicle in accordance with G.S. 20-81.12. The plate may 39 bear a phrase or an insignia representing a publicly owned or nonprofit historical attraction located in North Carolina. 40 (12)Honorary Plate. – Issuable to a member of the Honorary Consulor 41 42 Consular Corps, who has been certified by the U. S. State

Department, the plate shall bear the words 'Honorary Consulor

Consular Corps' and a distinguishing number based on the order of 1 2 issuance. 3 (13)Judge or Justice. – Issuable to a sitting or retired judge or justice in accordance with G.S. 20-79.6. 4 5 Legislator. – Issuable to a member of the North Carolina General (14)Assembly. The plate shall bear the words 'Senate' or 'State House' 6 7 followed by the Senator's or Representative's assigned seat number. 8 (15)Marshal. – Issuable to a United States Marshal. The plate shall bear 9 the phrase 'U.S. Marshal' followed by a number that represents the 10 district the Marshal serves, with 1 being the Eastern District, 2 being the Middle District, and 3 being the Western District. 11 12 (16)Military Reservist. – Issuable to a member of a reserve component of the armed forces of the United States. The plate shall bear the 13 14 name and insignia of the appropriate reserve component. Plates 15 shall be numbered sequentially for members of a component with 16 the numbers 1 through 5000 reserved for officers, without regard to 17 rank. 18 (16a) Military Retiree. – Issuable to an individual who has retired from 19 the armed forces of the United States. The plate shall bear the 20 phrase 'U.S. Armed Forces Retired' and the name of the branch of 21 service from which the individual retired. 22 (17)National Guard Member. - Issuable to an active or a retired 23 member of the North Carolina National Guard. The plate shall bear 24 the phrase 'National Guard'. A plate issued to an active member 25 shall bear a number that reflects the seniority of the member; a plate issued to a commissioned officer shall begin with the number 26 27 '1'; a plate issued to a noncommissioned officer with a rank of E7, 28 E8, or E9 shall begin with the number '1601'; a plate issued to an 29 enlisted member with a rank of E6 or below shall begin with the 30 number '3001'. The plate issued to a retired or separated member shall indicate the member's retired status. 31 32 Partially Disabled Veteran. - Issuable to a veteran of the armed (18)33 forces of the United States who suffered a service connected 34 disability of less than 100%. 35 (19)Pearl Harbor Survivor. – Issuable to a veteran of the armed forces 36 of the United States who was present at and survived the attack on 37 Pearl Harbor on December 7, 1941. The plate will bear the phrase 38 'Pearl Harbor Survivor' and the insignia of the Pearl Harbor 39 Survivors' Association. 40 (20)Personalized. – Issuable to the registered owner of a motor vehicle. 41 The plate will bear the letters or letters and numbers requested by 42 the owner. The Division may refuse to issue a plate with a letter 43 combination that is offensive to good taste and decency. The

Division may not issue a plate that duplicates another plate.

- 1 (21)Prisoner of War. – Issuable to a member or veteran member of the 2 armed forces of the United States who has been captured and held 3 prisoner by forces hostile to the United States while serving in the armed forces. 4 5 (22)Purple Heart Recipient. – Issuable to a recipient of the Purple Heart 6 award. The plate shall bear the phrase 'Purple Heart Veteran, 7 Combat Wounded' and the letters 'PH'. 8 'State of the Arts.' – Issuable to the registered owner of a motor (22a) 9 vehicle in accordance with G.S. 20-81.12. The background of the 10 plate shall be an abstract design of areas in turquoise and green on a field of blue and shall bear the words 'State of the Arts.' 11 12 (23)State Government Official. – Issuable to elected and appointed members of State government in accordance with G.S. 20-79.5. 13 14 (24)Street Rod Owner. - Issuable to the registered owner of a 15 modernized private passenger motor vehicle manufactured prior to 16 the year 1949 or designed to resemble a vehicle manufactured prior 17 to the year 1949. The plate shall bear the phrase 'Street Rod'. 18 (25)Transportation Personnel. – Issuable to various members of the 19 Divisions of the Department of Transportation. The plate shall bear 20 the letters 'DOT' followed by a number from 1 to 85, as designated 21 by the Governor. 22 (26)U.S. Representative. – Issuable to a United States Representative for North Carolina. The plate shall bear the phrase 'U.S. House' and 23 24 shall be issued on the basis of Congressional district numbers. U.S. Senator. - Issuable to a United States Senator for North 25 (27)Carolina. The plates shall bear the phrase 'U.S. Senate' and shall be 26 27 issued on the basis of seniority represented by the numbers 1 and 2." 28
  - Sec. 2. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

"(b) Distribution of Fees. – The Special Registration Plate Account and Account, the Collegiate and Historical Attraction Plate Account, and the State of the Arts

Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Historical Attraction Plate Account (CHAPA), and—the Recreation and Natural Heritage Trust Fund (RNHTF), which is established under G.S. 113-77.7, and the State of the Arts Account (SAA) as follows:

Sec. 4. G.S. 20-81.12 reads as rewritten:

## "§ 20-81.12. Collegiate insignia plates, high school insignia plates, and historical attraction plates, plates, and 'State of the Arts' plates.

- (a) Collegiate Insignia Plates. The Division must receive 300 or more applications for a collegiate insignia license plate for a college or university before a collegiate license plate may be developed. The color, design, and material for the plate must be approved by both the Division and the alumni or alumnae association of the appropriate college or university. The Division must transfer quarterly the money in the Collegiate and Historical Attraction Plate Account derived from the sale of in-State collegiate insignia plates to the Board of Governors of The University of North Carolina for in-State, public colleges and universities and to the respective board of trustees for in-State, private colleges and universities in proportion to the number of collegiate plates sold representing that institution for use for academic enhancement.
- (b) Historical Attraction Plates. The Division must receive 300 or more applications for an historical attraction plate representing a publicly owned or nonprofit historical attraction located in North Carolina and listed below before the plate may be developed. The Division must transfer quarterly the money in the Collegiate and Historical Attraction Plate Account derived from the sale of historical attraction plates to the organizations named below in proportion to the number of historical attraction plates sold representing that organization:
  - (1) Historical Attraction Within Historic District. The revenue derived from the special plate shall be transferred quarterly to the appropriate Historic Preservation Commission, or entity designated as the Historic Preservation Commission, and used to maintain property in the historic district in which the attraction is located. As used in this subdivision, the term "historic district" means a district created under G.S. 160A-400.4.
  - (2) Nonprofit Historical Attraction. The revenue derived from the special plate shall be transferred quarterly to the nonprofit corporation

- that is responsible for maintaining the attraction for which the plate is issued and used to develop and operate the attraction.
  - (3) State Historic Site. The revenue derived from the special plate shall be transferred quarterly to the Department of Cultural Resources and used to develop and operate the site for which the plate is issued. As used in this subdivision, the term 'State historic site' has the same meaning as in G.S. 121-2(11).
  - (b1) 'State of the Arts' Plates. The Division must receive 300 or more applications for a 'State of the Arts' license plate before a 'State of the Arts' license plate may be developed. The Division shall transfer quarterly the money in the State of the Arts Plate Account derived from the sale of 'State of the Arts' plates to the Division of the Arts Council, Department of Cultural Resources, for use in its grants program. An applicant may combine a request for a 'State of the Arts' license plate and a Collegiate Insignia plate by paying the additional fee amount for each of the plates. The distribution of the additional fee shall be as for each type of plate pursuant to G.S. 20-79.2(b).
  - (c) General. An application for a special license plate named in this section may be made at any time during the year. If the application is made to replace an existing current valid plate, the special plate must be issued with the appropriate decals attached. No refund shall be made to the applicant for any unused portion remaining on the original plate. The request for a special license plate named in this section may be combined with a request that the plate be a personalized license plate.
