EDUCATION TO CONVEY PROPERTY TO THEIR COUNTIES IN
CONNECTION WITH IMPROVEMENTS AND REPAIR OF THE PROPERTY.

The General Assembly of North Carolina enacts:

Section 1. Section 2 of Chapter 885 of the 1989 Session Laws, as amended by Chapters 120, 533, 832, 848, 865, and 1001 of the 1991 Session Laws, reads as rewritten:

- "Sec. 2. This act applies only to <u>Macon</u>, Bladen, Cabarrus, Carteret, Columbus, Duplin, Franklin, <u>Haywood</u>, Iredell, Pender, Richmond, Rowan, Sampson, and Stanly Counties."
- Sec. 2. Notwithstanding the provisions of G.S. 115C-518 and G.S. 160A-274, a local board of education may lease or sell any of its property to the board of commissioners of the county in which the property is located for any price negotiated between the two boards.
- Sec. 3. Section 2 of this act applies only to Macon and Haywood Counties and to local boards of education for school administrative units in or for Macon and Haywood Counties. Section 2 of this act applies only to sales and leases of property in connection with additions, improvements, renovations, or repairs to the property or to some part of the property.
 - Sec. 4. This act is effective upon ratification.
