Section 1. G.S. 20-7(n) reads as rewritten:

- "(n) Format. A drivers license issued by the Division must be tamperproof and must contain all of the following information:
 - (1) An identification of this State as the issuer of the license.
 - (2) The license holder's full name.
 - (3) The license holder's residence address.
 - (4) A color photograph of the license holder, taken by the Division.
- 15 (5) A physical description of the license holder, including sex, height, eye color, and hair color.
- 17 (6) The license holder's date of birth.
- 18 (7) The license holder's social security number or another identifying number assigned by the Division.

- Each class of motor vehicle the license holder is authorized to drive and (8) any endorsements or restrictions that apply.

- (9) The license holder's signature.

The date the license was issued and the date the license expires. (10)The Commissioner may waive the requirement of a color photograph on a license if

the license holder proves to the satisfaction of the Commissioner that taking the photograph would violate the license holder's religious convictions. photographs of license holders, the Division must distinguish between license holders who are less than 21 years old and license holders who are at least 21 years old by using different color backgrounds or borders for each group. The Division shall determine the different colors to be used.

At the request of an applicant for a drivers license, a license issued to the applicant must contain the applicant's race."

"§ 20-14. Duplicate licenses.

A person may obtain a duplicate of a license issued by the Division by paying a fee of ten dollars (\$10.00) and giving the Division satisfactory proof that any of the following has occurred:

(1) The person's license has been lost or destroyed.

(2) It is necessary to change the name or address on the license.

21 22 (3) Because of age, the person is entitled to a license with a different color photographic background.-background or a different color border.

The Division revoked the person's license, the revocation period has (4) expired, and the period for which the license was issued has not expired."
