- 4 The General Assembly of North Carolina enacts:
 - Section 1. G.S. 153A-335 reads as rewritten:
- 6 "§ 153A-335. 'Subdivision' defined.

For purposes of this Part, 'subdivision' means all divisions of a tract or parcel of land into two or more lots, building sites, or other divisions for the purpose of sale or building development (whether immediate or future) and includes all division of land involving the dedication of a new street or a change in existing streets; however, the following is not included within this definition and is not subject to any regulations enacted pursuant to this Part:

- 13(1)The combination or recombination of portions of previously14subdivided and recorded lots if the total number of lots is not increased15and the resultant lots are equal to or exceed the standards of the county16as shown in its subdivision regulations;
- 17(2)The division of land into parcels greater than 10 acres if no street right-
of-way dedication is involved; five acres where the grantor or developer
records a right-of-way agreement prior to or simultaneously with the
recording of the deed, which said agreement provides for access to the
parcel by right-of-way at least 50 feet in width and contains an
agreement for construction and maintenance of the road;22232324
- 23 (3) The public acquisition by purchase of strips of land for widening or
