SENATE BILL 293

Short Title: Liquor Importer/Bottler Permit.

(Public)

Sponsors: Senators Rand and Jordan.

A BILL TO BE ENTITLED

AN ACT TO PERMIT THE IMPORTATION AND BOTTLING OF SPIRITUOUS LIQUOR WITHIN FOREIGN TRADE ZONES LOCATED AT THE WILMINGTON AND MOREHEAD CITY PORTS.

The General Assembly of North Carolina enacts:

Section 1. Article 11 of Chapter 18B of the General Statutes is amended by adding a new section to read:

"§ 18B-1105.1. Authorization of liquor importer/bottler permit.

The holder of a liquor importer/bottler permit may:

- (1) Receive spirituous liquor in closed containers into foreign trade zones at the State Port facilities in Morehead City and Wilmington from ships docked at the State Port facilities for the purpose of bottling, packaging, or labeling.
- (2) Bottle, package, or label spirituous liquor imported or received into a foreign trade zone pursuant to this section.
- (3) Receive spirituous liquor in closed containers into the foreign trade zones at the State Port facilities in Morehead City and Wilmington from ships docked at the State Port facilities for storage, sale, shipment, and transshipment to the State or a local ABC board warehouse or, subject

1 to the laws of other jurisdictions, to private or public agencies or
2 establishments of other states or nations.

3 (4) Subject to the record-keeping requirements of G.S. 18B-1115, transport
4 into or out of the foreign trade zones at the State Port facilities in
5 Morehead City and Wilmington, the maximum amount of liquor
6 allowed under federal law, if the transportation is related to the bottling,
7 packaging, labeling, sale, or storage permitted by this section."

8 Sec. 2. G.S. 18B-902(d) reads as rewritten:

- 21 (10) Mixed beverages permit – \$750.00.
- 22 (11) Culinary permit – \$100.00.
- 23 (12) Unfortified winery permit – \$150.00.
- 24 (13) Fortified winery permit – \$150.00.
- 25 (14) Limited winery permit – \$150.00.
- 26 (15) Brewery permit – \$150.00.
- 27 (16) Distillery permit – \$150.00.
- 28 (17) Fuel alcohol permit – \$50.00.
- 29 (18) Wine importer permit – \$150.00.
- 30 (19) Wine wholesaler permit – \$150.00.
- 31 (20) Malt beverage importer permit – \$150.00.
- 32 (21) Malt beverage wholesaler permit – \$150.00.
- 33 (22) Bottler permit – \$150.00.
- 34 (23) Salesman permit – \$25.00.
- 35 (24) Vendor representative permit – \$25.00.
- 36 (25) Nonresident malt beverage vendor permit – \$50.00.
- 37 (26) Nonresident wine vendor permit – \$50.00.
- 38 (27) Any special one-time permit under G.S. 18B-1002 – \$25.00.

- 40 (29) Mixed beverages catering permit – \$100.00.
- 41 (30) Guest room cabinet permit – \$750.00.
- 42 (31) Liquor importer/bottler permit – \$250.00."

43 Sec. 3. G.S. 18B-1100 reads as rewritten:

"§ 18B-1100. Commercial permits.

The Commission may issue the following commercial permits:

- (1) Unfortified winery
- (2) Fortified winery
- (3) Limited winery
- (4) Brewery
- (5) Distillery
- (6) Fuel alcohol
- (7) Wine importer
- (8) Wine wholesaler
- (9) Malt beverages importer
- (10) Malt beverages wholesaler
- (11) Bottler
- (12) Salesman
- (13) Vendor representative
- (14) Nonresident malt beverage vendor
- (15) Nonresident wine vendor
- (16) Winery special show
- (17) Liquor importer/bottler permit."

Sec. 4. G.S. 105-113.74(a) reads as rewritten:

"(a) License and Tax. – A person holding any of the following commercial ABC permits shall obtain a State license for the activity authorized by the permit. The annual tax for each license is as stated.
