PUBLIC LIBRARIES FOR CONSTRUCTION, PLANNING, AND RENOVATION

Whereas, the General Assembly has recognized that the availability of adequate, modern library services and facilities is in the general interest of the people of North Carolina and a proper concern of the State and of local governments; and

Whereas, it is the intent of the General Assembly to provide revenue to fund grants to public libraries for construction, renovation, and planning that will be a responsible and fair use of State funds and will provide partial support to projects that meet criteria that assure adequate planning and local support; Now, therefore,

6 The General Assembly of North Carolina enacts:

7 Section 1. There is appropriated from the General Fund to the Department of

8 Cultural Resources, Division of State Library, the sum of two million one hundred forty-

9 one thousand six hundred nine dollars (\$2,141,609) for the 1995-96 fiscal year to provide

- 10 grants to libraries that (i) applied for grants for construction, renovation, and planning,
- 11 (ii) are members of a library system that qualifies for the Aid to Public Libraries Fund
