1	A BILL TO BE ENTITLED
2	AN ACT TO ALLOW STATE AGENCIES TO RETAIN RECEIPTS FROM THE
3	SALE OF RECYCLABLE MATERIALS, AS RECOMMENDED BY THE
4	ENVIRONMENTAL REVIEW COMMISSION, TO CREATE THE COMMISSION
5	ON SMALL FAMILY FARM PRESERVATION AND TO PROVIDE THAT THE
6	DIRECTOR OF THE BUDGET MAY IDENTIFY FUNDS TO MATCH GRANT
7	FUNDS FOR THE CENTER FOR COMMUNITY SELF-HELP.
8	The General Assembly of North Carolina enacts:
9	Section 1. G.S. 143-64.02 reads as rewritten:
10	"§ 143-64.02. Definitions.
11	As used in Part 1 of this Article, except where the context clearly requires otherwise:
12	(1) 'Agency' means an existing department, institution, commission,
13	committee, board, division, or bureau of the State.
14	(2) 'Nonprofit tax exempt organizations' means those nonprofit tax exempt
15	medical institutions, hospitals, clinics, health centers, school systems,
16	schools, colleges, universities, schools for the mentally retarded, schools

1	for the physically handicapped, radio and television stations licensed by
2	the Federal Communications Commission as educational radio or
3	educational television stations, public libraries, and civil defense
4	organizations, that have been certified by the Internal Revenue Service
5	as tax-exempt nonprofit organizations under section 501(c)(3) of the
6	United States Internal Revenue Code of 1954.
7	(3) <u>'Recyclable material' means a recyclable material, as defined in G.S.</u>
8	130A-290, that the Secretary of Administration determines, consistent
9	with G.S. 130A-309.14, to be a recyclable material."
10	Section 2. G.S. 143-64.05 reads as rewritten:
11	"§ 143-64.05. Warehousing, transfer, etc., chargesService charges for disposal of
12	surplus property and recyclables; use of receipts from sale of surplus
13	property and recyclable material.
14	(a) The State agency for surplus property may assess and collect <u>a</u> service <u>charge</u>
15	charges or fees for the acquisition, receipt, warehousing, distribution distribution, or
16	transfer of any State surplus property. property and for the transfer or sale of recyclable
17	material.
18	(b) All receipts from the transfer or sale of surplus, obsolete, or unused equipment
19	of State departments, institutions, and agencies, agencies that are supported by
20	appropriations from the General Fund, except where the receipts have been anticipated
21	for, for or budgeted against the cost of replacements, shall be credited by the Secretary to
22	the Office of State Treasurer, Nontax Revenues. Treasurer as nontax revenue.
23	(c) A department, institution, or agency may retain receipts derived from the
24	transfer or sale of recyclable material, less any charge collected pursuant to subsection (a)
25	of this section, and may use the receipts to defray the costs of its recycling activities. A
26	contract for the transfer or sale of recyclable material to which a department, institution,
27	or agency is a party shall not become effective until the contract is approved by the
28	Secretary of Administration. The Secretary of Administration shall adopt rules governing
29	the transfer or sale of recyclable material by a department, institution, or agency and
30	specifying the conditions and procedures under which a department, institution, or
31	agency may retain the receipts derived from the transfer or sale, including the appropriate
32	allocation of receipts when more than one department, institution, or agency is involved
33	in a recycling activity."
34	Section 3. The Commission on Small Family Farm Preservation is created in
35	the General Assembly. The Commission shall study:
36	(1) Land-use and population trends in North Carolina.
37	(2) The causes of the declining number of small family farms in the State.
38	(3) The influence of federal and State taxes in the conversion of small
39	family farms to nonagricultural uses.
40	(4) Voluntary incentives and voluntary options to preserve small family
41	farms as well as enhance their economic viability and their use of
42	environmentally sustainable agriculture.

1	(5)	The feasibility and desirability of using various farmland preservation
2		mechanisms, including: purchase or lease of development rights, land-
3		use tax credits, estate and gift tax exemptions, comprehensive land-use
4		plans, redevelopment of urban areas and density development to
5		eliminate duplication of infrastructure, cluster zoning, agricultural
6		protection zoning, limits on annexation, and limits on extending utilities
7		to designated agricultural areas; and the adequacy of Article 61 of
8		Chapter 106 of the General Statutes in preserving farmland in this State.

20	member of the Commission as cochair of the Commission. A majority of the
21	Commission shall constitute a quorum for the transaction of business.
22	Section 5. The Commission may file an interim report to the 1999 Regular
23	Session of the 1999 General Assembly and shall file a final report prior to the convening
24	of the 2000 Regular Session of the 1999 General Assembly. The Commission shall
25	submit interim and final reports by filing the reports with the President Pro Tempore of
26	the Senate and the Speaker of the House of Representatives. The final report shall
27	contain the findings, recommendations, and legislative proposals, if any, of the
28	Commission.
29	Section 6. Members appointed to the Commission shall serve until the
30	Commission makes its final report. Vacancies on the Commission shall be filled by the
31	same appointing officer who made the original appointments. The Commission shall
32	terminate upon the filing of its final report.
33	Section 7. The Commission may contract for consultant services as provided
34	by G.S. 120-32.02. The Commission may obtain assistance from the State's universities.
35	Upon approval of the Legislative Services Commission, the Legislative Services Officer
36	shall assign professional and clerical staff to assist in the work of the Commission.
37	Clerical staff shall be furnished to the Commission through the offices of the House of
38	Representatives' and Senate's Supervisors of Clerks. The Commission may meet in the
39	Legislative Building or the Legislative Office Building upon the approval of the
40	Legislative Services Commission. The Commission, while in the discharge of official
41	duties, may exercise all the powers authorized by G.S. 120-19 through G.S. 120-19.4.
42	Section 8. Members of the Commission shall receive per diem, subsistence,
43	and travel allowances as follows:

1	(1) Commission members who are also General Assembly members, at the
2	rate established in G.S. 120-3.1.
3	(2) Commission members who are officials or employees of the State or
4	local government agencies, at the rate established in G.S. 138-6.
5	(3) All other Commission members, at the rate established in G.S. 138-5.
6	Section 8.1. Notwithstanding any other provision of law, the Director of the
7	Budget may identify resources of up to ten million dollars (\$10,000,000) from the
8	General Fund for the 1998-99 fiscal year for the Center for Community Self-Help to
9	match grant funds on a one-to-one basis. These funds shall be used to create a loan loss
10	reserve that leverages private capital for home ownership.
11	Section 9. Sections 1 and 2 of this act become effective 1 January 1999.
12	Sections 3 through 9 of this act are effective when this act becomes law.
