1 A BILL TO BE ENTITLED  
2 AN ACT TO AMEND THE GENERAL STATUTES PERTAINING TO CHILD  
3 SUPPORT ENFORCEMENT IN ORDER TO ENHANCE CHILD SUPPORT  
4 ENFORCEMENT AND PATERNITY ESTABLISHMENT IN CONFORMANCE  
5 WITH FEDERAL WELFARE REFORM REQUIREMENTS.

6 The General Assembly of North Carolina enacts:

7  
8 **PART 1. STATE DIRECTORY OF NEW HIRES.**

9 Section 1. Effective October 1, 1997, Article 1 of Chapter 110 of the General  
10 Statutes is amended by adding the following new section to read:

11 "**§ 110-129.2. State Directory of New Hires established; employers required to**  
12 **report; civil penalties for noncompliance; definitions.**

13 (a) Directory Established. – There is established the State Directory of New Hires.  
14 The Directory shall be developed and maintained by the Department. The Directory shall  
15 be a central repository for employment information to assist in the location of persons  
16 owing child support, and in the establishment and enforcement of child support orders.

17 (b) Employer Reporting. – Every employer in this State shall report to the  
18 Directory the hiring of every employee for whom a federal W-4 form is required to be  
19 completed by the employee at the time of hiring. The employer shall report the

1 information required under this section not later than 20 days from the date of hire, or, in  
2 the case of an employer who transmits new hire reports magnetically or electronically by  
3 two monthly transmissions, not less than 12 nor more than 16 days apart.

4 (c) Report Contents. – Each report required by this section shall contain the name,  
5 address, and social security number of the employee, and the name and address of the  
6 employer and the employer's identifying number assigned under section 6109 of the  
7 Internal Revenue Code of 1986 and the employer's State employer identification number.  
8 Reports shall be made on the W-4 form or, at the option of the employer, an equivalent  
9 form, and may be transmitted magnetically, electronically, or by first-class mail.

10 (d) Penalties for Failure to Report. – Upon a finding that an employer has failed to  
11 comply with the reporting requirements of this section, the district court shall impose a  
12 civil penalty in an amount not to exceed twenty-five dollars (\$25.00). If the court finds  
13 that an employer's failure to comply with the reporting requirements is the result of a  
14 conspiracy between the employer and the employee to not supply the required report or to  
15 supply a false or incomplete report, then the court shall impose upon the employer a civil  
16 penalty in an amount not to exceed five hundred dollars (\$500.00). Penalties collected  
17 under this subsection shall be deposited to the General Fund.

18 (e) Entry of Report Data Into Directory. – Within five business days of receipt of  
19 the report from the employer, the Department shall enter the information from the report  
20 into the Directory.

21 (f) Notice to Employer to Withhold. – Within two business days of the date the  
22 information was entered into the Directory, the Department or its designated  
23 representative as defined under G.S. 110-129(5) shall transmit notice to the employer of  
24 the newly hired employee directing the employer to withhold from the income of the  
25 employee an amount equal to the monthly or other periodic child support obligation,  
26 including any past-due support obligation of the employee and subject to the limitations  
27 of G.S. 110-136.6, unless the employee's income is not subject to withholding.

28 (g) Other Uses of Directory Information. – The Employment Security  
29 Commission may access information entered into the Directory from employer reports  
30 for the purpose of administering employment security programs. The North Carolina  
31 Industrial Commission may access information entered into the Directory from employer  
32 reports for the purpose of administering workers' compensation programs.

33 (h) Department May Contract for Services. – The Department may contract with  
34 other State or private entities to perform the services necessary to implement this section.

35 (i) Except as otherwise provided in this section, information contained in the  
36 Directory is confidential and may be used only by the State Child Support Enforcement  
37 Program.

38 (j) Definitions. – As used in this section, unless the context clearly requires  
39 otherwise, the term:

40 (1) 'Business day' means a day on which State offices are open for  
41 business.

42 (2) 'Department' means the Department of Human Resources.

- 1           (3) 'Employee' means an individual who is an employee within the meaning  
2 of Chapter 24 of the Internal Revenue Code of 1986. The term  
3 'employee' does not include an employee of a federal or State agency  
4 performing intelligence or counterintelligence functions, if the head of  
5 the agency has determined that reporting information as required under  
6 this section could endanger the safety of the employee or compromise  
7 an ongoing investigation or intelligence mission.
- 8           (4) 'Employer' has the meaning given the term in section 3401(d) of the  
9 Internal Revenue Code of 1986 and includes persons who are  
10 governmental entities and labor organizations. The term 'labor  
11 organization' shall have the meaning given that term in section 2(5) of  
12 the National Labor Relations Act, and includes any entity which is used  
13 by the organization and an employer to carry out requirements described  
14 in section 8(f)(3) of the National Labor Relations Act of an agreement  
15 between the organization and the employer."

16  
17 **PART 2. EXPANDED AUTHORITY OF THE DEPARTMENT TO ENFORCE**  
18 **CHILD SUPPORT ORDERS AND TO ESTABLISH PATERNITY.**

19           Section 2. Chapter 110 of the General Statutes is amended by adding the  
20 following new section to read:

21 **"§ 110-129.1. Additional powers and duties of the Department.**

22           (a) In addition to other powers and duties conferred upon the Department of  
23 Human Resources, Child Support Enforcement Program, by this Chapter or other State  
24 law, the Department shall have the following powers and duties:

- 25           (1) Upon authorization of the Secretary, to issue a subpoena for the  
26 production of books, papers, correspondence, memoranda, agreements,  
27 or other information, documents, or records relevant to a child support  
28 establishment or enforcement proceeding or paternity establishment  
29 proceeding. The subpoena shall be signed by the Secretary and shall  
30 state the name of the person or entity required to produce the  
31 information authorized under this section, and a description of the  
32 information compelled to be produced. The subpoena may be served in  
33 the manner provided for service of subpoenas under the North Carolina  
34 Rules of Civil Procedure. The form of subpoena shall generally follow  
35 the practice in the General Court of Justice in North Carolina. Return of  
36 the subpoena shall be to the person who issued the subpoena. Upon the  
37 refusal of any person to comply with the subpoena, it shall be the duty  
38 of any judge of the district court, upon application by the person who  
39 issued the subpoena, to order the person subpoenaed to show cause why  
40 he should not comply with the requirements, if in the discretion of the  
41 judge the requirements are reasonable and proper. Refusal to comply  
42 with the subpoena or with the order shall be dealt with as for contempt  
43 of court and as otherwise provided by law. Information obtained as a

1 result of a subpoena issued pursuant to this subdivision is confidential  
2 and may be used only by the Child Support Enforcement Program in  
3 conjunction with a child support establishment or enforcement  
4 proceeding or paternity establishment proceeding.

5 (2) For the purposes of locating persons, establishing paternity, or enforcing  
6 child support orders, the Program shall have direct access to any  
7 information or data storage and retrieval system maintained and used by  
8 the Department of Transportation for drivers license issuance or motor  
9 vehicle registration, or by a law enforcement agency of this State for  
10 law enforcement purposes.

11 (3) Establish and implement procedures under which in IV-D cases either  
12 parent or, in the case of an assignment of support, the State may request  
13 that a child support order enforced under this Chapter be reviewed and,  
14 if appropriate, adjusted in accordance with the most recently adopted  
15 uniform statewide child support guidelines prescribed by the  
16 Conference of Chief District Court Judges.

17 (4) Develop procedures for entering into agreements with financial  
18 institutions to develop and operate a data match system as provided  
19 under G.S. 110-139.2.

20 (5) Develop procedures for ensuring that when a noncustodial parent  
21 providing health care coverage pursuant to a court order changes  
22 employers and is eligible for health care coverage from the new  
23 employer, the new employer, upon receipt of notice of the order from  
24 the Department, enrolls the child in the employer's health care plan.

25 (6) Develop and implement an administrative process for paternity  
26 establishment in accordance with G.S. 110-132.2.

27 (7) Establish and implement administrative procedures to change the child  
28 support payee to ensure that child support payments are made to the  
29 appropriate caretaker when custody of the child has changed, in  
30 accordance with G.S. 50-13.4(d).

31 (8) Establish and implement expedited procedures to take the following  
32 actions relating to the establishment of paternity or to establishment of  
33 support orders, without obtaining an order from a judicial tribunal:

34 a. Subpoena the parties to undergo genetic testing as provided  
35 under G.S. 110-132.2;

36 b. Implement income withholding in accordance with this Chapter;

37 c. For the purpose of securing overdue support, increase the amount  
38 of monthly support payments by implementation of income  
39 withholding procedures established under G.S. 110-136.4, or by  
40 notice and opportunity to contest to an obligor who is not subject  
41 to income withholding. Increases under this subdivision are  
42 subject to the limitations of G.S. 110-136.6;

1           d.     For purposes of exerting and retaining jurisdiction in IV-D cases,  
2                 transfer cases between jurisdictions in this State without the  
3                 necessity for additional filing by the petitioner or service of  
4                 process upon the respondent.

5           (b)    As used in this section, the term 'Secretary' means the Secretary of Human  
6                 Resources, the Secretary's designee, or a designated representative as defined under G.S.  
7                 110-129(5)."

8                 Section 2.1. (a) G.S. 50-13.4(d) reads as rewritten:

9                 "(d)   Payments~~In non-IV-D cases, payments~~ for the support of a minor child shall  
10                be ordered to be paid to the person having custody of the child or any other proper  
11                person, agency, organization or institution, or to the court, for the benefit of ~~such~~~~the~~  
12                child. In IV-D cases, payments for the support of a minor child shall be ordered to be  
13                paid to the court or other proper State agency for the benefit of the child."

14                (b) This section applies to orders entered or modified on and after October 1,  
15                1997.

16                Section 2.2. G.S. 50-13.4 is amended by adding the following new subsection  
17                to read:

18                "(e1) In IV-D cases, the order for child support shall provide that the clerk shall  
19                transfer the case to another jurisdiction in this State if the IV-D agency requests the  
20                transfer on the basis that the obligor, the custodian of the child, and the child do not  
21                reside in the jurisdiction in which the order was issued. The IV-D agency shall provide  
22                notice of the transfer to the obligor. The clerk shall transfer the case to the jurisdiction  
23                requested by the IV-D agency, which shall be a jurisdiction in which the obligor, the  
24                custodian of the child, or the child resides. Nothing in this subsection shall be construed  
25                to prevent a party from contesting the transfer."

## 26                **PART 2A. NOTICE/DUE PROCESS REQUIREMENTS.**

27                Section 2.3. Chapter 110 of the General Statutes is amended by adding the  
28                following new section to read:

### 29                "§ 110-131.1. Notice; due process requirements met.

30                In any child support enforcement proceeding the trial court may deem State due  
31                process requirements for notice and service of process to be met with respect to the  
32                nonmoving party, upon delivery of written notice in accordance with the notice  
33                requirements of Chapter 1A-1, Rule 5(b) of the Rules of Civil Procedure with respect to  
34                all pleadings subsequent to the original complaint."  
35

## 36                **PART 3. AUTHORIZE JUDGES TO IMPOSE WORK REQUIREMENTS ON** 37                **OBLIGORS WHO ARE IN ARREARS IN CHILD SUPPORT, AND TO** 38                **REQUIRE PARENTS TO PROVIDE MEDICAL SUPPORT.**

39                Section 3. G.S. 110-136.3 is amended by adding the following new subsection  
40                to read:

41                "(a1) Payment Plan/Work Requirement for Past-Due Support. In any IV-D case in  
42                which an obligor owes past-due support and income withholding has been ordered but  
43

1 cannot be implemented against the obligor, the court may order the obligor to pay the  
2 support in accordance with a payment plan approved by the court and, if the obligor is  
3 subject to the payment plan and is not incapacitated, the court may order the obligor to  
4 participate in such work activities, as defined under Section 407(d) of P.L. 104-193, as  
5 the court deems appropriate."

6 Section 3.1. G.S. 50-13.11 reads as rewritten:

7 "**§ 50-13.11. Orders and agreements regarding medical support and health**  
8 **insurance coverage for minor children.**

9 (a) The court may order a parent of a minor child or other responsible party to  
10 provide medical support for the child, or the parties may enter into a written agreement  
11 regarding medical support for the child. ~~An order or agreement for medical support may~~  
12 ~~require one or both parties to maintain health insurance, dental insurance, or both, or to~~  
13 ~~pay the medical, hospital, or dental expenses.~~ An order or agreement for medical support  
14 for the child may require one or both parties to pay the medical, hospital, dental, or other  
15 health care related expenses.

16 (a1) The court shall order the parent of a minor child or other responsible party to  
17 maintain health insurance for the benefit of the child when health insurance is available at  
18 a reasonable cost. As used in this subsection, health insurance is considered reasonable  
19 in cost if it is employment related or other group health insurance, regardless of service  
20 delivery mechanism. The court may require one or both parties to maintain dental  
21 insurance.

22 (b) The party ordered or under agreement to provide ~~medical-health~~ insurance  
23 shall provide written notice of any change in the applicable insurance coverage to the  
24 other party.

25 (c) The employer or insurer of the party required to provide ~~medical, health,~~  
26 hospital, and dental insurance shall release to the other party, upon written request, any  
27 information on a minor child's insurance coverage that the employer or insurer may  
28 release to the party required to provide ~~medical, health, hospital, and dental~~ insurance.

29 (d) When a court order or agreement for ~~medical-health~~ insurance is in effect, the  
30 signature of either party shall be valid authorization to the insurer to process an insurance  
31 claim on behalf of a minor child.

32 (e) If the party who is required to provide ~~medical-health~~ insurance fails to  
33 maintain the insurance coverage for the minor child, the party shall be liable for any  
34 ~~medical, health, hospital, or dental~~ expenses incurred from the date of the court order or  
35 agreement that would have been covered by insurance if it had been in force.

36 (f) When a noncustodial parent ordered to provide health insurance changes  
37 employment and health insurance coverage is available through the new employer, the  
38 obligee shall notify the new employer of the noncustodial parent's obligation to provide  
39 health insurance for the child. Upon receipt of notice from the obligee, the new employer  
40 shall enroll the child in the employer's health insurance plan."

41 Section 3.2. G.S. 108A-69(b) reads as rewritten:

1       "(b) If a parent is required by a court or administrative order to provide health  
2 benefit plan coverage for a child, and the parent is eligible for family health benefit plan  
3 coverage through an employer doing business in this State, the employer:

- 4           (1) Must allow the parent to enroll, under family coverage, the child if the  
5 child would be otherwise eligible for coverage without regard to any  
6 enrollment season restrictions.
- 7           (2) Must enroll the child under family coverage upon application of the  
8 child's other parent or upon receipt of notice from the Department of  
9 Human Resources in connection with its administration of the Medical  
10 Assistance or Child Support Enforcement Program if the parent is  
11 enrolled but fails to make application to obtain coverage for the child.
- 12          (3) May not disenroll or eliminate coverage of the child unless:
- 13           a. The employer is provided satisfactory written evidence that:
- 14               1. The court or administrative order is no longer in effect; or  
15               2. The child is or will be enrolled in comparable health  
16 benefit plan coverage that will take effect not later than  
17 the effective date of disenrollment; or
- 18           b. The employer has eliminated family health benefit plan coverage  
19 for all of its employees.
- 20          (4) Must withhold from the employee's compensation the employee's share,  
21 if any, of premiums for health benefit plan coverage, not to exceed the  
22 maximum amount permitted to be withheld under section 303(b) of the  
23 federal Consumer Credit Protection Act, as amended; and must pay this  
24 amount to the health insurer; subject to regulations, if any, adopted by  
25 the Secretary of the U.S. Department of Health and Human Services."
- 26

### 27 **PART 3A. CONFORM STATE TAX INTERCEPT LAW TO FEDERAL** 28 **REQUIREMENTS.**

29       Section 3.3. G.S. 105A-2(1)d. reads as rewritten:

30       "d. The North Carolina Department of Human Resources when in  
31 the performance of its duties, under the Child Support  
32 Enforcement Program as enabled by Chapter 110, Article 9 and  
33 Title IV, Part D of the Social Security Act to obtain  
34 indemnification for past paid public assistance or to collect child  
35 support ~~arrears~~—owed to an individual receiving program  
36 services and any county operating the program at the local level,  
37 when and only to the extent that the county is engaged in the  
38 performance of those same duties;"

39

### 40 **PART 4. REQUIREMENT TO PROVIDE SOCIAL SECURITY NUMBERS ON** 41 **CERTAIN DOCUMENTS.**

42       Section 4. G.S. 20-7(b1) reads as rewritten:

1       "(b1) Application. – To obtain a drivers license from the Division, a person must  
2 complete an application form provided by the Division, present at least two forms of  
3 identification approved by the Commissioner, be a resident of this State, and demonstrate  
4 his or her physical and mental ability to drive safely a motor vehicle included in the class  
5 of license for which the person has applied. The Division may copy the identification  
6 presented or hold it for a brief period of time to verify its authenticity. To obtain an  
7 endorsement, a person must demonstrate his or her physical and mental ability to drive  
8 safely the type of motor vehicle for which the endorsement is required.

9       The application form must request all of the following information:

- 10       (1)     The applicant's full name.
- 11       (2)     The applicant's mailing address and residence address.
- 12       (3)     A physical description of the applicant, including the applicant's sex,  
13             height, eye color, and hair color.
- 14       (4)     The applicant's date of birth.
- 15       (5)     The applicant's social security number. The Division shall not issue a  
16             license to an applicant who fails to provide the applicant's social  
17             security number. The applicant's social security number shall not be  
18             printed on the license and may be released only to the Department of  
19             Human Resources, Child Support Enforcement Program, upon its  
20             request and for the purpose of establishing paternity or child support, or  
21             enforcing a child support order.
- 22       (6)     The applicant's signature.

23       The application form must also contain the disclosures concerning the request for an  
24 applicant's social security number required by section 7 of the federal Privacy Act of  
25 1974, Pub. L. No. 93-579. In accordance with 42 U.S.C. 405(c)(2)(C)(v), the Division  
26 may disclose a social security number obtained under this subsection only for the purpose  
27 of administering the drivers license laws and may not disclose the social security number  
28 for any other purpose. The social security number of an applicant for a license or of a  
29 licensed driver is therefore not a public record. A violation of the disclosure restrictions is  
30 punishable as provided in 42 U.S.C. 405(c)(2)(C)(vii)."

31       Section 4.1. G.S. 49-7 reads as rewritten:

32       "**§ 49-7. Issues and orders.**

33       The court before which the matter may be brought shall determine whether or not the  
34 defendant is a parent of the child on whose behalf the proceeding is instituted. After this  
35 matter has been determined in the affirmative, the court shall proceed to determine the  
36 issue as to whether or not the defendant has neglected or refused to provide adequate  
37 support and maintain the child who is the subject of the proceeding. After this matter  
38 shall have been determined in the affirmative, the court shall fix by order, subject to  
39 modification or increase from time to time, a specific sum of money necessary for the  
40 support and maintenance of the child, subject to the limitations of G.S. 50-13.10. The  
41 amount of child support shall be determined as provided in G.S. 50-13.4(c). The order  
42 fixing the sum shall require the defendant to pay it either as a lump sum or in periodic  
43 payments as the circumstances of the case may appear to the court to require. The social



1 security number, if known, of the minor child's parents shall be placed in the record of  
2 the proceeding. Compliance by the defendant with any or all of the further provisions of  
3 this Article or the order or orders of the court requiring additional acts to be performed by  
4 the defendant shall not be construed to relieve the defendant of his or her responsibility to  
5 pay the sum fixed or any modification or increase thereof.

6 The court before whom the matter may be brought, on motion of the State or the  
7 defendant, shall order that the alleged-parent defendant, the known natural parent, and the  
8 child submit to any blood tests and comparisons which have been developed and adapted  
9 for purposes of establishing or disproving parentage and which are reasonably accessible  
10 to the alleged-parent defendant, the known natural parent, and the child. The results of  
11 those blood tests and comparisons, including the statistical likelihood of the alleged  
12 parent's parentage, if available, shall be admitted in evidence when offered by a duly  
13 qualified, licensed practicing physician, duly qualified immunologist, duly qualified  
14 geneticist or other duly qualified person. The evidentiary effect of those blood tests and  
15 comparisons and the manner in which the expenses therefor are to be taxed as costs shall  
16 be as prescribed in G.S. 8-50.1. In addition, if a jury tries the issue of parentage, they  
17 shall be instructed as set out in G.S. 8-50.1. From a finding on the issue of parentage  
18 against the alleged-parent defendant, the alleged-parent defendant has the same right of  
19 appeal as though he or she had been found guilty of the crime of willful failure to support  
20 an illegitimate child."

21 Section 4.2. G.S. 49-14(a) reads as rewritten:

22 "(a) The paternity of a child born out of wedlock may be established by civil action  
23 at any time prior to such child's eighteenth birthday. A certified copy of a certificate of  
24 birth of the child shall be attached to the complaint. ~~Such~~ The establishment of paternity  
25 shall not have the effect of legitimation. The social security numbers, if known, of the  
26 minor child's parents shall be placed in the record of the proceeding."

27 Section 4.3. G.S. 50-8 reads as rewritten:

28 "**§ 50-8. Contents of complaint; verification; venue and service in action by**  
29 **nonresident; certain divorces validated.**

30 In all actions for divorce the complaint shall be verified in accordance with the  
31 provisions of Rule 11 of the Rules of Civil Procedure and G.S. 1-148. The plaintiff shall  
32 set forth in his or her complaint that the complainant or defendant has been a resident of  
33 the State of North Carolina for at least six months next preceding the filing of the  
34 complaint, and that the facts set forth therein as grounds for divorce, except in actions for  
35 divorce from bed and board, have existed to his or her knowledge for at least six months  
36 prior to the filing of the complaint: Provided, however, that if the cause for divorce is  
37 one-year separation, then it shall not be necessary to allege in the complaint that the  
38 grounds for divorce have existed for at least six months prior to the filing of the  
39 complaint; it being the purpose of this proviso to permit a divorce after such separation of  
40 one year without awaiting an additional six months for filing the complaint: Provided,  
41 further, that if the complainant is a nonresident of the State action shall be brought in the  
42 county of the defendant's residence, and summons served upon the defendant personally  
43 or service of summons accepted by the defendant personally in the manner provided in

1 G.S. 1A-1, Rule 4(j)(1). Notwithstanding any other provision of this section, any suit or  
2 action for divorce heretofore instituted by a nonresident of this State in which the  
3 defendant was personally served with summons or in which the defendant personally  
4 accepted service of the summons and the case was tried and final judgment entered in a  
5 court of this State in a county other than the county of the defendant's residence, is hereby  
6 validated and declared to be legal and proper, the same as if the suit or action for divorce  
7 had been brought in the county of the defendant's residence.

8 In all divorce actions the complaint shall set forth the name and age of any minor  
9 child or children of the marriage, and in the event there are no ~~such~~ minor children of the  
10 marriage, the complaint shall so state. In addition, the complaint shall state the social  
11 security number of the plaintiff and, if known, the social security number of the  
12 defendant.

13 In all prior suits and actions for divorce heretofore instituted and tried in the courts of  
14 this State where the averments of fact required to be contained in the affidavit heretofore  
15 required by this section are or have been alleged and set forth in the complaint in said  
16 suits or actions and said complaints have been duly verified as required by Rule 11 of the  
17 Rules of Civil Procedure, said allegations so contained in said complaints shall be  
18 deemed to be, and are hereby made, a substantial compliance as to the allegations  
19 heretofore required by this section to be set forth in any affidavit; and all such suits or  
20 actions for divorce, as well as the judgments or decrees issued and entered as a result  
21 thereof, are hereby validated and declared to be legal and proper judgments and decrees  
22 of divorce.

23 In all suits and actions for divorce heretofore instituted and tried in this State on and  
24 subsequent to the 5th day of April, 1951, wherein the statements, averments, or  
25 allegations in the verification to the complaint in said suits or actions are not in  
26 accordance with the provisions of Rule 11 of the Rules of Civil Procedure and G.S. 1-  
27 148 or the requirements of this section as to verification of complaint or the allegations,  
28 statements or averments in the verification contain the language that the facts set forth in  
29 the complaint are true 'to the best of affiant's knowledge and belief' instead of the  
30 language 'that the same is true to his (or her) own knowledge' or similar variation in  
31 language, said allegations, statements and averments in said verifications as contained in  
32 or attached to said complaint shall be deemed to be, and are hereby made, a substantial  
33 compliance as to the allegations, averments or statements required by this section to be  
34 set forth in any such verifications; and all such suits or actions for divorce, as well as the

4 shall contain the name of each of the parties, the date of birth of each party, the social

41 (2) The date of entry of an order establishing paternity or an order for the  
42 payment of child support.

1 and filed with and approved by a judge of the district court in the county where the  
2 mother of the child resides or is found, or in the county where the putative father resides  
3 or is found, or in the county where the child resides or is found shall have the same force  
4 and effect as a judgment of that court; and a

5 In order to rescind, a challenger must request the district court to order the rescission  
6 and to include in the order specific findings of fact that the request for rescission was filed  
7 with the clerk of court within 60 days of the signing of the document. The court must  
8 also find that all parties, including the child support enforcement agency, if appropriate,  
9 have been served in accordance with Rule 4 of the North Carolina Rules of Civil  
10 Procedure. In the event the court orders rescission and the putative father is thereafter  
11 found not to be the father of the child, then the clerk of court shall send a copy of the  
12 order of rescission to the State Registrar of Vital Statistics. Upon receipt of an order of  
13 rescission, the State Registrar shall remove the putative father's name from the birth  
14 certificate. In the event that the putative father defaults or fails to present or prosecute

30 affirmation, and the written acknowledgment shall contain the social security number of  
31 the person executing the acknowledgment. Voluntary agreements to support shall  
32 contain the social security number of each of the parties to the agreement. The written  
33 affirmations, acknowledgments and agreements to support shall be sworn to before a  
34 certifying officer or notary public or the equivalent or corresponding person of the state,  
35 territory, or foreign country where the affirmation, acknowledgment, or agreement is  
36 made, and shall be binding on the person executing the same whether ~~he~~ the person is an  
37 adult or a minor. The child support enforcement agency shall ensure that the mother and  
38 putative father are given oral and written notice of the legal consequences and  
39 responsibilities arising from the signing of an acknowledgement of paternity, and of any  
40 alternatives to the execution of an acknowledgment or affirmation of paternity. ~~Such~~ The  
41 mother shall not be excused from making ~~such~~ the affirmation on the grounds that it may  
42 tend to disgrace or incriminate her; nor shall she thereafter be prosecuted for any criminal  
43 act involved in the conception of the child as to whose paternity she makes affirmation."

1 Section 4.8. G.S. 110-133 reads as rewritten:

2 **"§ 110-133. Agreements of support.**

3 In lieu of or in conclusion of any legal proceeding instituted to obtain support from a  
4 responsible parent for a dependent child born of the marriage, a written agreement to  
5 support the child by periodic payments executed by the responsible parent when  
6 acknowledged before a certifying officer or notary public or the equivalent or  
7 corresponding person of the state, territory, or foreign country where the  
8 acknowledgment is made and filed with and approved by a judge of the district court in  
9 the county where the custodial parent of the child resides or is found, or in the county  
10 where the noncustodial parent resides or is found, or in the county where the child resides  
11 or is found shall have the same force and effect, retroactively and prospectively, in  
12 accordance with the terms of the agreement, as an order of support entered by the court,  
13 and shall be enforceable and subject to modification in the same manner as is provided by  
14 law for orders of the court in such cases. A responsible parent executing a written  
15 agreement under this section shall provide on the agreement the responsible parent's  
16 social security number."

17 Section 4.9. G.S. 49-12.1(c) reads as rewritten:

18 "(c) The parties may ~~waive a jury trial and~~ enter a consent order with the approval  
19 of the clerk of superior court. The order entered by the clerk shall find the facts and  
20 declare the proper person the father of the child and may change the surname of the  
21 child."

22 Section 4.10. G.S. 49-14 is amended by adding the following new subsections  
23 to read:

24 "(f) Parties to an action to establish paternity are not entitled to a trial by jury on  
25 the issue of paternity.

26 (g) When a determination of paternity is pending in a IV-D case, the court shall  
27 enter a temporary order for child support upon motion and showing of clear, cogent, and  
28 convincing evidence of paternity. For purposes of this subsection, the results of blood or  
29 genetic tests shall constitute clear, cogent, and convincing evidence of paternity if the

32 reimbursed the full amount of temporary support paid under the order.

33 (h) Invoices for services rendered for pregnancy, childbirth, and blood or genetic  
34 testing are admissible as evidence without requiring third party foundation testimony and  
35 shall constitute prima facie evidence of the amounts incurred for the services or for  
36 testing on behalf of the child."

37 Section 4.11. Chapter 110 of the General Statutes is amended by adding the

39 **"§ 110-132.2. Expedited procedures to establish paternity in IV-D cases.**

40 (a) In a IV-D case, a local child support enforcement office may, without  
41 obtaining a court order, subpoena a minor child, the minor child's mother, and the  
42 putative father of the minor child (including the mother's husband, if different from the  
43 putative father) to appear for the purpose of undergoing blood or genetic testing to

1 establish paternity. A subpoena issued pursuant to this section must be served in  
2 accordance with Rule 4 of the North Carolina Rules of Civil Procedure. Refusal to  
3 comply with a subpoena may be dealt with as for contempt of court, and as otherwise  
4 provided under law. A party may contest the results of the genetic or blood test. If the

7 (b) A person subpoenaed to submit to testing pursuant to subsection (a) of this

21 mother and father complete an affidavit acknowledging paternity which contains the

- 23 (1) A sworn statement by the mother consenting to the assertion of paternity  
24 by the father and declaring that the father is the child's natural father;
- 25 (2) A sworn statement by the father declaring that he believes he is the

4 inheritance unless the affidavit is also filed with the clerk of court in accordance with

28 issue a limited driving privilege, with those terms and conditions applying as the court  
29 shall prescribe. An ~~obligor~~ individual whose license has been revoked for reasons not  
30 related to this section and whose license remains revoked at the time of the hearing shall  
31 not be eligible and may not be issued a limited driving privilege. The court may modify  
32 or revoke the limited driving privilege pursuant to G.S. 20-179.3(i).

33 (d) An ~~obligor~~ individual may file a request with the child support enforcement  
34 agency for certification that the ~~obligor~~ individual is no longer delinquent in child support  
35 payments upon submission of proof satisfactory to the child support enforcement agency  
36 that the ~~obligor~~ individual has paid the delinquent amount in full. An individual subject  
37 to a subpoena issued pursuant to a child support or paternity establishment proceeding  
38 may file a request with the child support enforcement agency for certification that the  
39 individual has complied with or is no longer subject to the subpoena. The child support  
40 enforcement agency shall provide a form to be used by the ~~obligor~~ individual for a  
41 request for certification. If the child support enforcement agency finds that the ~~obligor~~  
42 individual has met the requirements for reinstatement under this subsection, then the  
43 child support enforcement agency shall certify that the ~~obligor~~ individual is no longer

1 delinquent or that the individual has complied with or is no longer subject to a subpoena  
2 issued pursuant to child support or paternity establishment proceedings and shall provide  
3 a copy of the certification to the ~~obligor~~-individual.

4 (e) If licensing privileges are revoked under this section, the ~~obligor~~-individual  
5 may petition the district court for a reinstatement of such privileges. The court may order  
6 the privileges reinstated conditioned upon full payment of the delinquency over ~~time~~  
7 time, or, as applicable, may order the reinstatement if the court finds that the individual  
8 has complied with or is no longer subject to the subpoena issued pursuant to paternity  
9 establishment proceedings. Any order allowing license reinstatement shall additionally  
10 require the obligor's maintenance of current child support. Upon reinstatement under this  
11 subsection, the child support enforcement agency shall certify that the ~~obligor~~-individual  
12 is no longer ~~delinquent~~-delinquent, or, as applicable, that the individual has complied  
13 with or is no longer subject to the subpoena issued pursuant to child support or paternity  
14 establishment proceedings and shall provide a copy of the certification to the ~~obligor~~-  
15 individual, as applicable.

16 (f) Upon receipt of certification under subsection (d) or (e) of this section, the  
17 Division of Motor Vehicles shall reinstate the license to operate a motor vehicle in  
18 accordance with G.S. 20-24.1, and remove any restriction of the ~~obligor's~~-individual's  
19 motor vehicle registration.

20 (g) Upon receipt of certification under subsection (d) or (e) of this section, the  
21 licensing board having jurisdiction over the ~~obligor's~~-individual's hunting, fishing, or  
22 trapping license shall reinstate the license.

23 (h) If the court imposes sanctions under subdivision (3) of subsection (a) of this  
24 section and the sanctions are stayed upon conditions as provided in subsection (b) of this  
25 section, the child support enforcement agency may, without any further application to the  
26 court, notify the Division of Motor Vehicles if the ~~obligor~~-individual violates the terms  
27 and conditions of the stay. The Division shall then take such action as provided in  
28 subdivision (3) of subsection (a) of this section. The Division shall not remove any  
29 restriction of the ~~obligor's~~-individual's motor vehicle registration, until receipt of  
30 certification pursuant to subsection (d) or (e) of this section.

31 (i) The Department of Human Resources, the Administrative Office of the Courts,  
32 the Division of Motor Vehicles, and the Department of Environment, Health, and Natural  
33 Resources shall work together to develop the forms and procedures necessary for the  
34 implementation of this process."

35 Section 5.3. G.S. 50-13.12 reads as rewritten:

36 "**§ 50-13.12. Forfeiture of Licensing Privileges for Failure to Pay Child Support.**  
37 **Support or for Failure to Comply with Subpoena Issued Pursuant to Child**  
38 **Support or Paternity Establishment Proceedings.**

39 (a) As used in this section, the term:

40 (1) 'Licensing board' means a department, division, agency, officer, board,  
41 or other unit of state government that issues hunting, fishing, trapping,  
42 drivers, or occupational licenses or licensing privileges.

1 (2) 'Licensing privilege' means the privilege of an individual to be  
2 authorized to engage in an activity as evidenced by hunting, fishing, or  
3 trapping licenses, regular and commercial drivers licenses, and  
4 occupational, professional, and business licenses.

5 (3) 'Obligee' means the individual or agency to whom a duty of support is  
6 owed or the individual's legal representative.

7 (4) 'Obligor' means the individual who owes a duty to make child support  
8 payments under a court order.

9 (5) 'Occupational license' means a license, certificate, permit, registration,  
10 or any other authorization issued by a licensing board that allows an  
11 obligor to engage in an occupation or profession.

12 (b) Upon a finding by the district court judge that the obligor is willfully  
13 delinquent in child support payments equal to at least one month's child support, or upon  
14 a finding that a person has willfully failed to comply with a subpoena issued pursuant to a  
15 child support or paternity establishment proceeding, and upon findings as to any specific  
16 licensing privileges held by the ~~obligor~~, obligor or held by the person subject to the  
17 subpoena, the court may revoke some or all of such privileges until the obligor shall have  
18 paid the delinquent amount in full. ~~full~~, or, as applicable, until the person subject to the  
19 subpoena has complied with the subpoena. The court may stay any such revocation  
20 pertaining to the obligor upon conditions requiring the obligor to make full payment of  
21 the delinquency over time. Any such stay shall further be conditioned upon the obligor's  
22 maintenance of current child support. The court may stay the revocation pertaining to the  
23 person subject to the subpoena upon a finding that the person has complied with or is no  
24 longer subject to the subpoena. Upon an order revoking such privileges of an obligor that  
25 does not stay the revocation, the clerk of superior court shall notify the appropriate  
26 licensing board that the obligor is delinquent in child support payments and that the  
27 obligor's licensing privileges are revoked until such time as the licensing board receives  
28 proof of certification by the clerk that the obligor is no longer delinquent in child support  
29 payments. Upon an order revoking such privileges of a person subject to the subpoena  
30 that does not stay the revocation, the clerk of superior court shall notify the appropriate  
31 licensing board that the person has failed to comply with the subpoena issued pursuant to  
32 a child support or paternity establishment proceeding and that the person's licensing  
33 privileges are revoked until such time as the licensing board receives proof of  
34 certification by the clerk that the person is in compliance with or no longer subject to the  
35 subpoena.

36 (c) An obligor may file a request with the clerk of superior court for certification  
37 that the obligor is no longer delinquent in child support payments upon submission of  
38 proof satisfactory to the clerk that the obligor has paid the delinquent amount in full. A  
39 person whose licensing privileges have been revoked under subsection (b) of this section  
40 because of a willful failure to comply with a subpoena may file a request with the clerk of  
41 superior court for certification that the person has met the requirements of or is no longer  
42 subject to the subpoena. The clerk shall provide a form to be used by the ~~obligor~~ for a  
43 request for certification. If the clerk finds that the obligor has met the requirements for

1 reinstatement under this subsection, then the clerk shall certify that the obligor is no  
2 longer delinquent and shall provide a copy of the certification to the obligor. Upon  
3 request of the obligor, the clerk shall mail a copy of the certification to the appropriate  
4 licensing board. If the clerk finds that the person whose licensing privileges have been  
5 revoked under subsection (b) of this section for failure to comply with a subpoena has  
6 complied with or is no longer subject to the subpoena, then the clerk shall certify that the  
7 person has met the requirements of or is no longer subject to the subpoena and shall  
8 provide a copy of the certification to the person. Upon request of the person, the clerk  
9 shall mail a copy of the certification to the appropriate licensing board.

10 (d) If licensing privileges are revoked under this section, the obligor may petition  
11 the district court for a reinstatement of such privileges. The court may order the  
12 privileges reinstated conditioned upon full payment of the delinquency over time. Any  
13 order allowing license reinstatement shall additionally require the obligor's maintenance  
14 of current child support. If the licensing privileges of a person other than the obligor are  
15 revoked under this section for failure to comply with a subpoena, the person may petition  
16 the district court for reinstatement of the privileges. The court may order the privileges  
17 reinstated if the person has complied with or is no longer subject to the subpoena that was  
18 the basis for revocation. Upon reinstatement under this subsection, the clerk of superior  
19 court shall certify that the obligor is no longer delinquent and provide a copy of the  
20 certification to the obligor. Upon request of the obligor, the clerk shall mail a copy of the  
21 certification to the appropriate licensing board. Upon reinstatement of the person whose  
22 licensing privileges were revoked based on failure to comply with a subpoena, the clerk  
23 of superior court shall certify that the person has complied with or is no longer subject to  
24 the subpoena. Upon request of the person whose licensing privileges are reinstated, the  
25 clerk shall mail a copy of the certification to the appropriate licensing board.

26 (e) ~~The obligor~~ An obligor or other person whose licensing privileges are  
27 reinstated under this section may provide a copy of the certification set forth in either  
28 subsection (c) or (d) to each licensing agency to which the obligor or other person applies  
29 for reinstatement of licensing privileges. Upon request of the obligor, obligor or other  
30 person, the clerk shall mail a copy of the certification to the appropriate licensing board.  
31 Upon receipt of a copy of the certification, the licensing board shall reinstate the license.

32 (f) Upon receipt of notification by the clerk that ~~the obligor's~~ an obligor's or other  
33 person's licensing privileges are revoked, revoked pursuant to this section, the board shall  
34 note the revocation on its records and take all necessary steps to implement and enforce  
35 the revocation. These steps shall not include the board's independent revocation process  
36 pursuant to Chapter 150B of the General Statutes, the Administrative Procedure Act,  
37 which process is replaced by the court process prescribed by this section. The revocation  
38 pertaining to an obligor shall remain in full force and effect until the board receives  
39 certification under this section that the obligor is no longer delinquent in child support  
40 payments. The revocation pertaining to the person whose licensing privileges were  
41 revoked on the basis of failure to comply with a subpoena shall remain in full force and  
42 effect until the board receives certification of reinstatement under subsection (d) of this  
43 section."

1 Section 5.4. G.S. 93B-13 reads as rewritten:

2 "**§ 93B-13. Revocation when licensing privilege forfeited for nonpayment of child**  
3 **support.** ~~support~~ or for failure to comply with subpoena.

4 (a) Upon receipt of a court order, pursuant to G.S. 50-13.12, revoking the  
5 occupational license of a licensee under its jurisdiction, an occupational licensing board  
6 shall note the revocation in its records and follow the normal postrevocation rules and  
7 procedures of the board as if the revocation had been ordered by the board. The  
8 revocation shall remain in effect until the board receives certification by the clerk of  
9 superior court that the licensee is no longer delinquent in child support ~~payments.~~  
10 payments, or, as applicable, that the licensee is in compliance with or is no longer subject  
11 to the subpoena that was the basis for the revocation.

12 (b) Upon receipt of notification from the Department of Human Resources that a  
13 licensee under an occupational licensing board's jurisdiction has forfeited the licensee's

16 as provided by G.S. 110-142.1(d). If the license is revoked as provided by the provisions

18 certification by the designated representative or the child support enforcement agency  
19 that the licensee is no longer delinquent in child support ~~payments.~~ payments, or, as  
20 applicable, that the licensee is in compliance with or no longer subject to a subpoena that  
21 was the basis for the revocation.

22 (c) If at the time the court revokes a license pursuant to subsection (a) of this  
23 section, or if at the time the occupational licensing board revokes a license pursuant to  
24 subsection (b) of this section, the occupational licensing board has revoked the same  
25 license under the licensing board's disciplinary authority over licensees under its  
26 jurisdiction, and that revocation period is greater than the revocation period resulting  
27 from forfeiture pursuant to G.S. 50-13.12 or G.S. 110-142.1 then the revocation period  
28 imposed by the occupational licensing board applies.

29 (d) Immediately upon certification by the clerk of superior court or the child  
30 support enforcement agency that the licensee whose license was revoked pursuant to  
31 subsection (a) or (b) of this section is no longer delinquent in child support payments, the  
32 occupational licensing board shall reinstate the license. Immediately upon certification by  
33 the clerk of superior court or the child support enforcement agency that the licensee  
34 whose license was revoked because of failure to comply with a subpoena is in  
35 compliance with or no longer subject to the subpoena, the occupational licensing board  
36 shall reinstate the license. Reinstatement of a license pursuant to this section shall be  
37 made at no additional cost to the licensee."

## 39 PART 6. INCOME WITHHOLDING.

40 Section 6. G.S. 110-136.8(b) reads as rewritten:

41 "(b) Payor's responsibilities. A payor who has been properly served with a notice to  
42 withhold is required to:

- 1 (1) Withhold from the obligor's disposable income and, within ~~10~~7  
2 business days of the date the obligor is paid, send to the clerk of  
3 superior court or State collection and disbursement unit, as specified in  
4 the notice, the amount specified in the notice and the date the amount  
5 was withheld, but in no event more than the amount allowed by G.S.  
6 110-136.6; however, if a lesser amount of disposable income is  
7 available for any pay period, the payor shall either: (a) compute and  
8 send the appropriate amount to the clerk of court, using the percentages  
9 as provided in G.S. 110-136.6, or (b) request the initiating party to  
10 inform the payor of the proper amount to be withheld for that period;
- 11 (2) Continue withholding until further notice from the IV-D ~~agency or~~  
12 agency, the clerk of superior court, court, or the State collection and  
13 disbursement unit;
- 14 (3) Withhold for child support before withholding pursuant to any other  
15 legal process under State law against the same disposable income;
- 16 (4) Begin withholding from the first payment due the obligor in the first pay  
17 period that occurs 14 days following the date the notice of the obligation  
18 to withhold was served on the payor;
- 19 (5) Promptly notify the obligee in a IV-D case, or the clerk of superior court  
20 or the State collection and disbursement unit in a non-IV-D case, in  
21 writing:
- 22 a. If there is more than one child support withholding for the  
23 obligor;
- 24 b. When the obligor terminates employment or otherwise ceases to  
25 be entitled to disposable income from the payor, and provide the  
26 obligor's last known address, and the name and address of his  
27 new employer, if known;
- 28 c. Of the payor's inability to comply with the withholding for any  
29 reason; and
- 30 (6) Cooperate fully with the initiating party in the verification of the amount  
31 of the obligor's disposable income."

### 33 PART 6A. EXPEDITED PROCEDURES FOR INCOME WITHHOLDING.

34 Section 6.1. G.S. 110-136.3(b) reads as rewritten:

35 "(b) When obligor subject to withholding.

- 36 (1) In IV-D cases in which a new or modified child support order is entered  
37 on or after October 1, 1989, an obligor is subject to income withholding  
38 immediately upon entry of the order. In IV-D cases in which the child  
39 support order was entered prior to October 1, 1989, an obligor shall  
40 become subject to income withholding on the ~~earliest of~~:
- 41 a. The date on which the obligor fails to make legally obligated  
42 child support payments in an amount equal to the support  
43 payable for one month; or



- 1           b. ~~The date on which the obligor or obligee requests withholding.~~  
2           (2) In non-IV-D cases in which the child support order was entered prior to  
3           January 1, 1994, an obligor shall be subject to income withholding on  
4           the earliest of:  
5           a. The date on which the obligor fails to make legally obligated  
6           child support payments in an amount equal to the support  
7           payable for one month; or  
8           b. The date on which the obligor requests withholding; or  
9           c. The date on which the court determines, pursuant to a motion or  
10           independent action filed by the obligee under G.S. 110-136.5(a),  
11           that the obligor is or has been delinquent in making child support  
12           payments or has been erratic in making child support payments.  
13           (3) In IV-D child support cases in which an order was issued or modified in  
14           this State prior to October 1, 1996, and in which the obligor is not  
15           otherwise subject to withholding, the obligor shall become subject to  
16           withholding if arrearages occur."

17 Section 6.2. G.S. 110-136.4(a)(2) reads as rewritten:

- 18 "(2) Contents of advance notice. The advance notice to the obligor shall  
19           contain, at a minimum, the following information:  
20           a. Whether the proposed withholding is based on the obligor's  
21           failure to make legally obligated payments in an amount equal to  
22           the support payable for one month or on the obligor's request for  
23           withholding or on the obligee's request for ~~withholding~~;  
24           withholding, or on the obligor's eligibility for withholding under  
25           G.S. 110-136.3(b)(3);  
26           b. The amount of overdue support, the total amount to be withheld,  
27           and when the withholding will occur;  
28           c. The name of each child for whose benefit the child support is  
29           due, and information sufficient to identify the court order under  
30           which the obligor has a duty to support the child;  
31           d. The amount and sources of disposable income;  
32           e. That the withholding will apply to the obligor's wages or other  
33           sources of disposable income from current payors and all  
34           subsequent payors once the procedures under this section are  
35           invoked;  
36           f. An explanation of the obligor's rights and responsibilities  
37           pursuant to this section;  
38           g. That withholding will be continued until terminated pursuant to  
39           G.S. 110-136.10."

41 **PART 7. ESTABLISHMENT OF A LIEN ON REAL AND PERSONAL**  
42 **PROPERTY OF PERSON OWING PAST-DUE CHILD SUPPORT.**

1 Section 7. Chapter 44 of the General Statutes is amended by adding the  
2 following new Article to read:

3 **“ARTICLE 15.**

4 **“LIENS FOR OVERDUE CHILD SUPPORT.**

5 **“§ 44-86. Lien on real and personal property of person owing past-due child**  
6 **support; definitions; filing required; discharge.**

7 (a) Definitions. As used in this Article, the terms ‘designated representative’,  
8 ‘obligee’, and ‘obligor’ have the meanings given them in G.S. 110-129.

9 (b) Lien Created. There is created a general lien upon the real and personal  
10 property of any person who is delinquent in the payment of court-ordered child support.  
11 For purposes of this section, an obligor is delinquent when arrears under a court-ordered  
12 child support obligation equals three months of payments or three thousand dollars  
13 (\$3,000), whichever occurs first. The amount of the lien shall be determined by a  
14 verified statement of child support delinquency prepared in accordance with subsection  
15 (c) of this section.

16 (c) Contents of Statement; Verification. A verified statement of child support  
17 delinquency shall contain the following information:

- 18 (1) The caption and file docket number of the case in which child support  
19 was ordered;  
20 (2) The date of the order of support;  
21 (3) The amount of the child support obligation established by the order; and  
22 (4) The amount of the arrearage as of the date of the statement.

23 The statement shall be verified by the designated representative in a IV-D case and by the  
24 obligee in a non-IV-D case.

25 (d) Filing and Perfection of Lien. The verified statement shall be filed in the  
26 office of the clerk of superior court in the county in which the child support was ordered.  
27 At the time of filing the verified statement, the designated representative in a IV-D case  
28 and the obligee in a non-IV-D case shall serve notice on the obligor that the statement has  
29 been filed. The notice shall be served and the return of service filed with the clerk of  
30 court in accordance with Rule 4 of the North Carolina Rules of Civil Procedure. The  
31 notice shall specify the manners in which the lien may be discharged. Upon perfection of  
32 the lien, as set forth herein, the clerk shall docket and index the statement on the  
33 judgment docket. The clerk shall issue a transcript of the docketed statement to the clerk  
34 of any other county as requested by the designated representative in a IV-D case or the  
35 obligee in a non-IV-D case. The clerk receiving the transcript shall docket and index the  
36 transcript. A lien on personal property attaches when the property is seized by the  
37 sheriff. A lien on real property attaches when the perfected lien is docketed and indexed  
38 on the judgment docket.

- 39 (1) IV-D Cases. In IV-D cases, the filing of a verified statement with the  
40 clerk of court by the designated representative shall perfect the lien.  
41 The obligor may contest the lien by motion in the cause.

- 42 (2) Non-IV-D Cases. In a non-IV-D case, the notice to the obligor of the  
43 filing of the verified statement shall state that the obligor has 30 days

1           from the date of service to request a hearing before a district court judge  
2           to contest the validity of the lien. If the obligor fails to contest the lien  
3           after 30 days from the time of service, the obligee may make application  
4           to the clerk, and the clerk shall record and index the lien on the  
5           judgment docket. If the obligee files a petition contesting the validity of  
6           the lien, a hearing shall be held before a district court judge to determine  
7           whether the lien is valid and proper. In contested cases, the clerk of  
8           court shall record and index the lien on the judgment docket only by  
9           order of the judge. The docketing of a verified statement in a non-IV-D  
10           case shall perfect the lien when duly recorded and indexed.

11           (e) Lien Superior to Subsequent Liens. Except as otherwise provided by law, a  
12           lien established in accordance with this section shall take priority over all other liens  
13           subsequently acquired and shall continue from the date of filing until discharged in  
14           accordance with G.S. 44-87.

15           (f) Execution on the Lien. A designated representative in a IV-D case, after 30  
16           days from the docketing of the perfected lien, or an obligee in a non-IV-D case, after  
17           docketing the perfected lien, may enforce the lien in the same manner as for a civil  
18           judgment.

19           (g) Liens Arising Out-of-State. This State shall accord full faith and credit to child  
20           support liens arising in another state when the child support enforcement agency, party,  
21           or other entity seeking to enforce the lien complies with the requirements relating to  
22           recording and serving child support liens as set forth in this Article and with the  
23           requirements relating to the enforcement of foreign judgments as set forth in Chapter 1C  
24           of the General Statutes.

25           **"§ 44-87. Discharge of lien; penalty for failure to discharge.**

26           (a) Liens created by this Article may be discharged as follows:

27           (1) By the designated representative in IV-D cases, or by the obligee in  
28           non-IV-D cases, filing with the clerk of superior court an  
29           acknowledgment that the obligor has satisfied the full amount of the  
30           lien;

31           (2) By depositing with the clerk of superior court money equal to the  
32           amount of the claim and filing a petition in the cause requesting a  
33           district court judge to determine the validity of the lien. The money  
34           shall not be disbursed except by order of a district court judge following  
35           the hearing on the merits; or

36           (3) By an entry in the judgment docket book that the action on the part of  
37           the lien claimant to enforce the lien has been dismissed, or a judgment  
38           has been rendered against the claimant in such action.

39           (b) An obligee in a non-IV-D case who has received payment in full for a  
40           delinquent child support obligation which is the basis for the lien shall, within 30 days of  
41           receipt of payment, file with the clerk of court an acknowledgment that the obligor has  
42           satisfied the full amount of the lien and that the lien is discharged. If the lienholder fails  
43           to timely file the acknowledgment, the obligor may, after serving notice on the obligee,

1 file an action in district court to discharge the lien. If in an action filed by the obligor to  
2 discharge the lien, the court discharges the lien and finds that the obligee failed to timely  
3 file an acknowledgment discharging the lien, then the court may allow the prevailing  
4 party to recover reasonable attorneys' fees to be taxed as court costs against the obligee."

5 Section 7.1. G.S. 50-13.4(f)(8) reads as rewritten:

6 "(8) Except as provided in Article 15 of Chapter 44 of the General Statutes, a  
7 A-judgment for child support shall not be a lien against real property  
8 unless the judgment expressly so provides, sets out the amount of the  
9 lien in a sum certain, and adequately describes the real property  
10 affected; but past due periodic payments may by motion in the cause or  
11 by a separate action be reduced to judgment which shall be a lien as  
12 other judgments."

14 **PART 8. DEPARTMENT OF HUMAN RESOURCES TO DEVELOP**  
15 **AUTOMATED DATA PROCESSING AND INFORMATION SYSTEM, AND**  
16 **CENTRALIZED COLLECTION AND DISBURSEMENT SYSTEM FOR THE**  
17 **ENHANCEMENT OF CHILD SUPPORT COLLECTION AND**  
18 **DISBURSEMENT.**

19 Section 8. (a) Automated System. The Department of Human Resources shall  
20 develop a single statewide automated data processing and information retrieval system to  
21 enhance enforcement of child support obligations. The system shall have the capability  
22 to perform the following tasks:

- 23 (1) Program management, including the controlling and accounting for use  
24 of federal, State, and local funds in carrying out the State child support

- 27 (2) Maintenance of requisite data on State performance with respect to  
28 paternity establishment and child support enforcement, including  
29 systems controls to ensure completeness and reliability of and ready  
30 access to this data;
- 31 (3) Establishment of safeguards on the integrity, accuracy, and  
32 completeness of, access to, and use of data in the system. Safeguards  
33 shall include policies restricting, controlling, and monitoring access to  
34 the system and database;
- 35 (4) Maintenance of the State's automated case tracking system (ACTS) in  
36 accordance with federal requirements;
- 37 (5) Information retrieval, comparisons, and disclosure, including the  
38 sharing and comparison of information from other databases and  
39 information comparison services. Comparison services shall include  
40 information retrieval and sharing with such databases as the Federal  
41 Case Registry of Child Support Orders, the Federal Parent Locator  
42 Service, temporary family assistance and Medicaid agencies, and other

1 agencies of this State and agencies of other states and interstate  
2 information networks;

3 (6) Collection and distribution of support payments through the State  
4 Collection Disbursement Unit as required by federal law; and

5 (7) Implement expedited administrative procedures for the establishment of  
6 paternity and the enforcement of child support orders.

7 In addition, the system shall include procedures to ensure that all personnel who have  
8 access to confidential program data are trained in and informed of applicable  
9 requirements and penalties. The Department shall impose administrative penalties  
10 authorized by State law for unauthorized access to or disclosure or use of confidential  
11 data in the system.

12 (b) Progress Reports on Development. The Department shall provide periodic  
13 written progress reports to the Cochairs of the House and Senate Appropriations  
14 subcommittees on Human Resources, and to the Fiscal Research Division, not later than  
15 October 1, 1997, March 1, 1998, and October 1, 1998. Information contained in the  
16 report shall include, but not be limited to:

17 (1) Federal requirements for the automated system and collection and  
18 disbursements units;

19 (2) Status of development of the automated system and collection and  
20 disbursement unit as of the date of the progress report, and whether the  
21 development plan is on schedule, behind schedule, or ahead of schedule,  
22 and the reasons therefor;

23 (3) Projected costs to develop and operate the automated system; and  
24 projected savings, if any, from full implementation of the system;

25 (4) Projected costs to develop and operate the collection and disbursement  
26 unit, including recommendations on whether the Department should  
27 operate the unit or whether it should be operated by an outside  
28 contractor;

29 (5) The amount of State funds that must be appropriated for the 1998-99  
30 fiscal year to develop and implement the collection and disbursement  
31 unit; and

32 (6) Other information requested by the Cochairs or that the Department  
33 considers relevant and useful.

34 Section 8.1. Effective October 1, 1999, G.S. 110-139 is amended by adding  
35 the following new subsection to read:

36 "(f) There is established the State Child Support Collection and Disbursement Unit.  
37 The duties of the Unit shall be the collection and disbursement of payments under support  
38 orders for:

39 child support agency under this section, and for any other action taken by the financial  
40 institution in good faith to comply with this section or with G.S. 110-139.

41            (c) As used in this subdivision, a financial institution includes federal, State,  
42 commercial, or savings banks, savings and loan associations and cooperative banks,  
43 federal or State chartered credit unions, benefit associations, insurance companies, safe

1 deposit companies, money market mutual funds, and investment companies doing  
2 business in this State or incorporated under the laws of this State."

3 Section 9.1. G.S. 110-139(d) reads as rewritten:

4 "(d) Notwithstanding any other provision of law making this information  
5 confidential, including Chapter 53B of the General Statutes, any utility ~~company~~  
6 company, cable television company, or financial institution, including federal, State,  
7 commercial, or savings banks, savings and loan associations and cooperative banks,  
8 federal or State chartered credit unions, benefit associations, insurance companies, safe  
9 deposit companies, money market mutual funds, and investment companies doing

42 any source and any other property subject to withholding for support  
43 under the law of this State.

- 1 (6) 'Income-withholding order' means an order or other legal process  
2 directed to a payer of income to withhold support from the income of  
3 the obligor.
- 4 (7) 'Initiating state' means a state ~~in~~ from which a proceeding is forwarded  
5 or in which a proceeding is filed for forwarding to a responding state  
6 under this Act or a law or procedure substantially similar to this Act, the  
7 Uniform Reciprocal Enforcement of Support Act, or the Revised  
8 Uniform Reciprocal Enforcement of Support Act ~~is filed for forwarding~~  
9 ~~to a responding state.~~ Act.
- 10 (8) 'Initiating tribunal' means the authorized tribunal in an initiating state.
- 11 (9) 'Issuing state' means the state in which a tribunal issues a support order  
12 or renders a judgment determining parentage.
- 13 (10) 'Issuing tribunal' means the tribunal that issues a support order or  
14 renders a judgment determining parentage.
- 15 (11) 'Law' includes decisional and statutory law and rules and regulations  
16 having the force of law.
- 17 (12) 'Obligee' means:  
18 a. An individual to whom a duty of support is or is alleged to be  
19 owed or in whose favor a support order has been issued or a  
20 judgment determining parentage has been rendered;  
21 b. A state or political subdivision to which the rights under a duty  
22 of support or support order have been assigned or which has  
23 independent claims based on financial assistance provided to an  
24 individual obligee; or  
25 c. An individual seeking a judgment determining parentage of the  
26 individual's child.
- 27 (13) 'Obligor' means an individual, or the estate of a decedent:  
28 a. Who owes or is alleged to owe a duty of support;  
29 b. Who is alleged but has not been adjudicated to be a parent of a  
30 child; or  
31 c. Who is liable under a support order.
- 32 (14) 'Register' means to file a support order or judgment determining  
33 paternity in the appropriate location for the recording or filing of foreign  
34 judgments generally or foreign support orders specifically.
- 35 (15) 'Registering tribunal' means a tribunal in which a support order is  
36 registered.
- 37 (16) 'Responding state' means a state ~~to~~ in which a proceeding is filed or to  
38 which a proceeding is forwarded for filing from an initiating state under  
39 this Act or a law or procedure substantially similar to this Act, the  
40 Uniform Reciprocal Enforcement of Support Act, or the Revised  
41 Uniform Reciprocal Enforcement of Support Act.
- 42 (17) 'Responding tribunal' means the authorized tribunal in a responding  
43 state.



- 1 (18) 'Spousal-support order' means a support order for a spouse or former  
2 spouse of the obligor.
- 3 (19) 'State' means a state of the United States, the District of Columbia, ~~the~~

5 territory or insular possession subject to the jurisdiction of the United  
6 States. The term 'state' includes:

10 are substantially similar to the procedures under this Chapter.  
11 Act, the Uniform Reciprocal Enforcement of Support Act, or the

- 13 (20) 'Support enforcement agency' means a public official or agency  
14 authorized to seek:
- 15 a. Enforcement of support orders or duties of support-support;
- 16 b. ~~to seek establishment~~ Establishment or modification of child  
17 support, support;
- 18 c. ~~to seek determination~~ Determination of paternity, parentage; or
- 19 d. ~~to~~ To locate obligors or their assets.
- 20 (21) 'Support order' means a judgment, decree, or order, whether temporary,  
21 final, or subject to modification, for the benefit of a child, a spouse, or a  
22 former spouse, which provides for monetary support, health care,  
23 arrears, or reimbursement, and may include related costs and fees,  
24 interest, income withholding, attorneys' fees, and other relief.
- 25 (22) 'Tribunal' means a court, administrative agency, or quasi-judicial entity  
26 authorized to establish, enforce, or modify support orders or to  
27 determine paternity, except that, for matters heard in this State, tribunal  
28 means the General Court of Justice, District Court Division."

29 Section 10.1. G.S. 52C-2-203 reads as rewritten:

30 "**§ 52C-2-203. Initiating and responding tribunal of ~~this State.~~ state.**

31 Under this Chapter, a tribunal of this State may serve as an initiating tribunal to  
32 forward proceedings to another state and as a responding tribunal for proceedings

22 existence of the support obligation. A tribunal of this State may not modify a spousal  
23 support order issued by a tribunal of another state having continuing, exclusive  
24 jurisdiction over that order under the law of that state."

10 child support order, the order of that tribunal controls and must be so recognized.

11 (b) If a proceeding is brought under this Chapter, and two or more child support  
12 orders have been issued by tribunals of this State or another state with regard to the same  
13 obligor and child, a tribunal of this State shall apply the following rules in determining  
14 which order to recognize for purposes of continuing, exclusive jurisdiction:

15 (1) If only one of the tribunals would have continuing, exclusive  
16 jurisdiction under this Chapter, the order of that tribunal controls and  
17 must be so recognized.

18 (2) If more than one of the tribunals would have continuing, exclusive  
19 jurisdiction under this Chapter, an order issued by a tribunal in the

31 copy of every support order in effect. The requesting party shall give notice of the  
32 request to each party whose rights may be affected by a certified copy of every support  
33 order in the effect. The requesting party shall give notice of the request to each party  
34 whose rights may be affected by the determination.

40 controlling order under subdivision (b)(3) of this section shall state in that order the basis  
41 upon which the tribunal made its determination.

42 (f) Within 30 days after issuance of an order determining the identity of the  
43 controlling order, the party obtaining the order shall file a certified copy of it with each

1 tribunal that issued or registered an earlier order of child support. A party who obtains  
2 the order and fails to file a certified copy is subject to appropriate sanctions by a tribunal  
3 in which the issue of failure to file arises. The failure to file does not affect the validity  
4 or enforceability of the controlling order."

7 (e) If a responding tribunal of this State issues an order under this Chapter, the  
8 tribunal shall send a copy of the order ~~by first-class mail~~ to the petitioner and the  
9 respondent and to the initiating tribunal, if any."

10 Section 10.6. G.S. 52C-3-306 reads as rewritten:

22 (a) ~~A party seeking to enforce a support order or an income withholding order, or~~  
23 ~~both, issued by a tribunal of another state may send the documents required for~~  
24 ~~registering the order to a support enforcement agency of this State.~~

25 (b) ~~Upon receipt of the documents, the support enforcement agency, without~~  
26 ~~initially seeking to register the order, shall consider and, if appropriate, use any~~  
27 ~~administrative procedure authorized by the law of this State to enforce a support order or~~  
28 ~~an income withholding order, or both. If the obligor does not contest administrative~~  
29 ~~enforcement, the order need not be registered. If the obligor contests the validity or~~

32 **Employer's compliance with income-withholding order of another state.**

33 (a) Upon receipt of an income-withholding order, the obligor's employer shall  
34 immediately provide a copy of the order to the obligor.

35 (b) The employer shall treat an income-withholding order issued in another state  
36 which appears regular on its face as if it had been issued by a tribunal of this State.

37 (c) Except as otherwise provided in subsection (d) of this section and G.S. 52C-5-  
38 503, the employer shall withhold and distribute the funds as directed in the income-  
39 withholding order by complying with terms of the order which specify:

40 (1) The duration and amount of periodic payments of current child support,  
41 stated as a sum certain;

42 (2) The person or agency designated to receive payments and the address to  
43 which the payments are to be forwarded;

- 1           (3) Medical support, whether in the form of periodic cash payment, stated  
2 as a sum certain, or ordering the obligor to provide health insurance  
3 coverage for the child under a policy available through the obligor's  
4 employment;
- 5           (4) The amount of periodic payments of fees and costs for a support  
6 enforcement agency, the issuing tribunal, and the obligee's attorney,  
7 stated as sums certain; and
- 8           (5) The amount of periodic payments of arrearages and interest on  
9 arrearages, stated as sums certain.
- 10       (d) An employer shall comply with the law of the state of the obligor's principal  
11 place of employment for withholding from income with respect to:
- 12           (1) The employer's fee for processing an income-withholding order;  
13           (2) The maximum amount permitted to be withheld from the obligor's  
14 income; and
- 15           (3) The times within which the employer must implement the income-  
16 withholding order and forward the child support payment.

17 **"§ 52C-5-503. Compliance with multiple income-withholding orders.**

18 If an obligor's employer receives multiple income-withholding orders with respect to  
19 the earnings of the same obligor, the employer satisfies the terms of the multiple orders if  
20 the employer complies with the law of the state of the obligor's principal place of  
21 employment to establish the priorities for withholding and allocating income withheld for  
22 multiple child support obligees.

23 **"§ 52C-5-504. Immunity from civil liability.**

24 An employer who complies with an income-withholding order issued in another state  
25 in accordance with this Article is not subject to civil liability to an individual or agency  
26 with regard to the employer's withholding of child support from the obligor's income.

27 **"§ 52C-5-505. Penalties for noncompliance.**

28 An employer who willfully fails to comply with an income-withholding order issued  
29 by another state and received for enforcement is subject to the same penalties that may be  
30 imposed for noncompliance with an order issued by a tribunal of this State.

31 **"§ 52C-5-506. Contest by obligor.**

32       (a) An obligor may contest the validity or enforcement of an income-withholding  
33 order issued in another state and received directly by an employer in this State in the  
34 same manner as if the order had been issued by a tribunal of this State. G.S. 52C-6-604  
35 applies to the contest.

36       (b) The obligor shall give notice of the contest to:

- 37           (1) A support enforcement agency providing services to the obligee;  
38           (2) Each employer that has directly received an income-withholding order;  
39 and  
40           (3) The person or agency designated to receive payments in the income-  
41 withholding order if no person or agency is designated, to the obligee.

42 **"§ 52C-5-507. Administrative enforcement of orders.**

1 (a) A party seeking to enforce a support order or an income-withholding order, or  
2 both, issued by a tribunal of another state may send the documents required for  
3 registering the order to a support enforcement agency of this State.

4 (b) Upon receipt of the documents, the support enforcement agency, without  
5 initially seeking to register the order, shall consider and, if appropriate, use any  
6 administrative procedure authorized by the law of this State to enforce a support order or  
7 an income-withholding order, or both. If the obligor does not contest administrative  
8 enforcement, the order need not be registered. If the obligor contests the validity or  
9 administrative enforcement of the order, the support enforcement agency shall register  
10 the order pursuant to this Chapter."

11 Section 10.9. G.S. 52C-6-601 reads as rewritten:

12 **"§ 52C-6-601. Registration ~~or [of]~~ of order for enforcement.**

13 A support order or an income-withholding order issued by a tribunal of another state  
14 may be registered in this State for enforcement."

15 Section 10.10. G.S. 52C-6-605 reads as rewritten:

16 **"§ 52C-6-605. Notice of registration of order.**

17 (a) When a support order or income-withholding order issued in another state is  
18 registered, the registering tribunal shall notify the nonregistering party. ~~Notice must be~~  
19 ~~given by first class, certified, or registered mail or by any means of personal service~~  
20 ~~authorized by the law of this State.~~ The notice must be accompanied by a copy of the  
21 registered order and the documents and relevant information accompanying the order.

22 (b) The notice must inform the nonregistering party:

23 (1) That a registered order is enforceable as of the date of registration in the  
24 same manner as an order issued by a tribunal of this State;

25 (2) That a hearing to contest the validity or enforcement of the registered  
26 order must be requested within 20 days after ~~the date of mailing or~~  
27 ~~personal service of the notice;~~

28 (3) That failure to contest the validity or enforcement of the registered order  
29 in a timely manner will result in confirmation of the order and  
30 enforcement of the order and the alleged arrears and precludes further  
31 contest of that order with respect to any matter that could have been  
32 asserted; and

33 (4) Of the amount of any alleged arrears.

34 (c) Upon registration of an income-withholding order for enforcement, the  
35 registering tribunal shall notify the obligor's employer pursuant to the income-  
36 withholding provisions of Chapter 50 or Chapter 110 of the General Statutes, as  
37 applicable."

38 Section 10.11. G.S. 52C-6-606 reads as rewritten:

39 **"§ 52C-6-606. Procedure to contest validity or enforcement of registered order.**

40 (a) A nonregistering party seeking to contest the validity or enforcement of a  
41 registered order in this State shall request a hearing within 20 days after ~~the date of~~  
42 ~~mailing or personal service of notice~~ of the registration. The nonregistering party may  
43 seek to vacate the registration, to assert any defense to an allegation of noncompliance



1 with the registered order, or to contest the remedies being sought or the amount of any  
2 alleged arrears pursuant to G.S. 52C-6-607.

3 (b) If the nonregistering party fails to contest the validity or enforcement of the  
4 registered order in a timely manner, the order is confirmed by operation of law.

5 (c) If a nonregistering party requests a hearing to contest the validity or

7 hearing and give notice to the parties ~~by first-class mail~~ of the date, time, and place of the

9 Section 10.12. G.S. 52C-6-611 reads as rewritten:

11 (a) After a child support order issued in another state has been registered in this  
12 State, the responding tribunal of this State may modify that order only ~~if~~, if G.S. 52C-6-  
13 613 does not apply and after notice and ~~hearing~~, hearing it finds that:

14 (1) The following requirements are met:

- 15 a. The child, the individual obligee, and the obligor do not reside in  
16 the issuing state;  
17 b. A petitioner who is a nonresident of this State seeks  
18 modification; and  
19 c. The respondent is subject to the personal jurisdiction of the  
20 tribunal of this State; or

21 (2) ~~An individual party or the child~~ The child, or a party who is an  
22 individual, is subject to the personal jurisdiction of the tribunal of this  
23 State and all of the ~~individual~~ parties who are individuals have filed a

38 must be so recognized under G.S. 52C-2-207 establishes the aspects of the support order  
39 which are nonmodifiable.

40 (d) On issuance of an order modifying a child support order issued in another state,  
41 a tribunal of this State becomes the tribunal of continuing, exclusive jurisdiction.

42 (e) ~~Within 30 days after issuance of a modified child support order, the party~~

1 ~~which had continuing, exclusive jurisdiction over the earlier order, and in each tribunal in~~

3 Section 10.13. Article 6 of Chapter 52C of the General Statutes is amended by  
4 adding the following new sections to read:

5 **"§ 52C-6-613. Jurisdiction to modify child support order of another state when**  
6 **individual parties reside in this State.**

7 (a) If all of the parties who are individuals reside in this State and the child does  
8 not reside in the issuing state, a tribunal of this State has jurisdiction to enforce and to  
9 modify the issuing state's child support order in a proceeding to register that order.

10 (b) A tribunal of this State exercising jurisdiction under this section shall apply the  
11 provisions of Articles 1 and 2 of this Chapter, this Article, and the procedural and  
12 substantive law of this State to the proceeding for enforcement or modification. Articles  
13 3, 4, 5, 7, and 8 of this Chapter do not apply.

14 **"§ 52C-6-614. Notice to issuing tribunal of modification.**

15 Within 30 days after issuance of a modified child support order, the party obtaining  
16 the modification shall file a certified copy of the order with the issuing tribunal that had  
17 continuing, exclusive jurisdiction over the earlier order, and in each tribunal in which the  
18 party knows the earlier order has been registered. A party who obtains the order and fails  
19 to file a certified copy is subject to appropriate sanctions by a tribunal in which the issue  
20 of failure to file arises. The failure to file does not affect the validity or enforceability of  
21 the modified order of the new tribunal having continuing, exclusive jurisdiction."

22 Section 10.14. The Reviser of Statutes shall cause to be printed separate from  
23 this Part all relevant portions of the official comments to the Uniform Interstate Family  
24 Support Act, as amended, as the Reviser deems appropriate.

26 **PART 10A. FRAUDULENT CONVEYANCES TO AVOID CHILD SUPPORT.**

27 Section 10.15. Article 3 of Chapter 39 of the General Statutes is amended by  
28 adding the following new section to read:

29 **"§ 39-15.1. Fraudulent conveyances to avoid child support.**

30 (a) As used in this section, the terms 'obligor' and 'obligee' shall have the  
31 meanings given those terms in G.S. 110-129.

32 (b) In all child support cases, the conveyance of property by an obligor who is  
33 delinquent in the payment of child support may be voided by an obligee upon a showing  
34 of fraudulent intent. The factors which may be considered to show fraudulent intent are  
35 as follows:

36 (1) The conveyance or obligation was to an insider.

37 (2) The obligor retained possession or control of the property after the  
38 conveyance.

39 (3) The conveyance was concealed or not disclosed.

40 (4) Before the conveyance was made or the obligation was incurred, the  
41 obligor had been sued or threatened with suit.

42 (5) The conveyance was of substantially all the obligor's assets.

43 (6) The obligor removed or concealed assets.

1           (7) The value of the consideration received by the obligor was not  
2           reasonably equivalent to the value of the asset conveyed or the amount  
3           of the obligation incurred.

4           (8) The obligor was insolvent or became insolvent shortly after the  
5           conveyance was made or the obligation incurred.

6           (9) The conveyance occurred shortly before or shortly after a substantial  
7           debt was incurred.

8           (10) The obligor conveyed the essential assets of a business to a lienor who  
9           conveyed the assets to an insider of the obligor.

10          Proof of two or more of the factors listed in this subsection creates a rebuttable  
11          presumption of fraud. Unless otherwise provided under this Article, if the court finds by  
12          clear and convincing evidence that the conveyance was fraudulent, then the conveyance  
13          is void."

#### 14          **PART 11. MISCELLANEOUS AND EFFECTIVE DATE**

15                 Section 11. The headings to the Parts of this act are a convenience to the reader  
16                 and are for reference only. The headings do not expand, limit, or define the text of this  
17                 act.

19                 Section 11.1. If the 1997 General Assembly enacts House Bill 407, the  
20                 Uniform Fraudulent Transfer Act, then Section 10.15 of this act is repealed effective on  
21                 the date that the Uniform Fraudulent Transfer Act becomes law.

22                 Section 11.2. Except as otherwise provided in this act, this act becomes  
23                 effective October 1, 1997.
