4	Section 1. G.S. 115C-290.5(a) reads as rewritten:			
5	"(a) Th	e Standards Board shall administer this Article. In fulfilling this duty, the		
6	Standards Board shall:			
7	(1)	In accordance with subsection (c) of this section, develop and		
8		implement a North Carolina Public School Administrator Exam, based		
9		on the professional standards established by the Standards Board.		
10	(2)	Establish and collect an application fee not to exceed fifty dollars		
11		(\$50.00). (\$50.00), and an exam fee not to exceed one hundred fifty dollars		
12		(\$150.00). Fees collected under this Article shall be credited to the		
13		General Fund as nontax revenue.		
14	(3)	Review the educational achievements of an applicant to take the exam		
15		to determine whether the achievements meet the requirements set by		
16		G.S. 115C-290.7.
