1	A BILL TO BE ENTITLED
2	AN ACT TO REQUIRE THE DISCLOSURE OF PROPERTY INTERESTS AND
3	ASSETS BY GREENSBORO CITY COUNCIL MEMBERS.
4	The General Assembly of North Carolina enacts:
5	Section 1. Every member of the city council shall within 30 days after the
6	effective date of this act or within 30 days after assuming office, whichever comes later,
7	disclose any legal, equitable, or beneficial interest the member or the member's spouse
8	may have in any real property which is in the zoning jurisdiction of the city.
9	This disclosure shall be filed in writing with the clerk of superior court of the
10	county where the majority of the population of the city is located and shall include all real
11	property which any council member holds title to, individually or jointly, any real
12	property held in trust as well as any pecuniary interest he may have in any business, firm,
13	or corporation, of whatever nature, which holds title to or has any ownership interest in
14	any real property within the zoning jurisdiction of the city.
15	Section 2. Every member of the city council shall disclose any legal, equitable,
16	or beneficial ownership interest he may have in any business, firm, or corporation, of
17	whatever nature, which is doing business with the city pursuant to contracts which have
18	been awarded by the city.

1 Section 3. Every member of the city council shall disclose any legal, equitable, 2 or beneficial ownership interest he may have in any business, firm, or corporation, of 3 whatever nature, which is attempting to secure the award of a bid from the city, prior to 4 the award of any contract.

5 Section 4. The acquisition by any member subject to this act of any legal, 6 equitable, or beneficial interest in real property within the zoning jurisdiction of the city 7 shall be disclosed within 30 days after the acquisition of that property. Any legal, 8 equitable, or beneficial ownership interest which any member has in any business, firm, 9 or corporation, of whatever nature, with whom the city is now doing business, shall be 10 disclosed within 30 days after the effective date of this act or within 30 days after 11 acquisition of the ownership interest, whichever is later.

12 Section 5. Every city council member who has an ownership interest required 13 to be disclosed by this act shall disqualify himself from voting on any matter involving 14 any such ownership interest which comes for official action before the city council.

15 Section 6. Any member who violates any provision of this act shall be guilty of 16 a Class 1 misdemeanor.

Section 7. This act applies to the City of Greensboro only.

18 Section 8. This act becomes effective January 1, 1998.
