2	AN ACT TO ANNEX CERTAIN DESCRIBED TERRITORY TO THE TOWN OF
3	LAKE WACCAMAW.
4	The General Assembly of North Carolina enacts:
5	Section 1. The corporate limits of the Town of Lake Waccamaw are extended
6	to include the following described territory:
7	Waccamaw Shores Drive
8	BEGINNING at an existing concrete monument, in the northeast right-of-way
9	of Waccamaw Shores Drive, also known as S.R. 1967, said existing concrete monument
10	marking the most southern corner of the Lake Waccamaw Camp Ground lands now or
11	formerly belonging to Gene Grainger as recorded in Deed Book 385 Page 531 Columbus
12	County Registry, said existing concrete monument also marking the most western corner
13	of lands of James and Paul Council as recorded in Deed Book 261 Page 189 of the
14	Columbus County Registry. Said existing concrete monument also marking the most
15	southern limits of the Town of Lake Waccamaw. Running thence along the eastern edge
16	of Waccamaw Shores Drive in a northwesterly direction to a point located approximately
17	North 63 degrees 33 minutes 00 seconds East 60.00 feet from the southeast corner of Lot
18	306, Waccamaw Shores Subdivision as shown and delineated in Plat Book 11, Page 65,

Thence crossing Waccamaw Shores Drive South 63 1 2 degrees 33 minutes 00 seconds West 60.00 feet to the southeast corner of Lot 306, 3 Waccamaw Shores Subdivision as shown and delineated in Plat Book 11, Page 65, of the Columbus County Registry. Thence continuing along the line between Lot 306 and Lot 4 5 305 South 63 degrees 33 minutes 00 seconds West 119.88 feet to the southwest corner of 6 Lot 306 and the northwest corner of Lot 305. Thence continuing South 63 degrees 33 7 minutes 00 seconds West to a point located North 37 degrees 25 minutes 00 seconds West from the northwest corner of Lot 304. Thence South 37 degrees 25 minutes 00 8 9 seconds East to the northwest corner of Lot 304, located in the center of a canal. Thence 10 along the west and southwest lines of Lots 304 thru 1 of Block D, Waccamaw Shores Subdivision as shown and delineated in Plat Book 11, Page 65, Plat Book 8, Page 33, Plat 11 12 Book 8, Page 31, Plat Book 8, Page 29, Plat Book 8, Page 27, and Plat Book 8, Page 25, all of the Columbus County Registry, to the southwest corner of Lot 1, Block D, 13 Waccamaw Shores Subdivision as shown and delineated in Plat Book 8, Page 25, of the 14 15 Columbus Country Registry. Thence continuing southwestwardly along the southwest lines of Lots 1 thru 272 of Block B of the Waccamaw Shores Subdivision as shown and 16 17 delineated in Plat Book 8, Page 6, Plat Book 8, Page 7, Plat Book 8, Page 8, Plat Book 8, 18 Page 9, Plat Book 8, Page 10, Plat Book 8, Page 11, and Plat Book 8, Page 12, all of the Columbus County Registry, to the southwest corner of Lot 272 of Block B of the 19 20 Waccamaw Shores Subdivision as shown and delineated in Plat Book 8, Page 12, of the 21 Columbus Country Registry, in the center of a canal. Thence along the south line of Lot 272 North 82 degrees 34 minutes 00 seconds East 145.00 feet to a point in the western 22 23 right-of-way of Waccamaw Shores Drive, marking the southeast corner of Lot 272. 24 Thence crossing Waccamaw Shores Drive approximately North 75 degrees 21 minutes 25 00 seconds East 60.50 feet to an existing concrete monument marking the southwest corner of Lot 273 of Block A of the Waccamaw Shores Subdivision as shown and 26 27 delineated on a plat recorded in Plat Book 8 Page 12 of the Columbus County Registry. Running thence in a northwesterly direction with the eastern edge of Waccamaw Shores 28 29 Drive to the point and place of beginning.

32 For a tie line, begin at an old concrete control monument located at the 33 northwestern corner of Lot 1 in that plat for Bella Coola Corp. recorded in Plat Book 8, 34 Page 24, of the Columbus County Registry. Thence North 86 degrees 11 minutes East 35 34.01 feet to a point in the center of S.R. 1947, locally known as Creek Ridge Road, this 36 being THE POINT AND PLACE OF BEGINNING. Thence North 86 degrees 11 minutes East 34.01 feet to a point, this being the northwestern corner of Lot 1A of that 37 38 plat for Bella Coola Corp. recorded in Plat Book 10, Page 95, of the Columbus County 39 Registry. Thence North 65 degrees 08 minutes East 192.51 feet to a point. Thence South 81 degrees 10 minutes East 34.54 feet to a point. Thence South 35 degrees 44 minutes 40 East 54.00 feet to a point. Thence South 23 degrees 54 minutes East 101.01 feet to a 41 42 point. Thence South 35 degrees 55 minutes East 100.24 feet to a point. Thence South 37 degrees 04 minutes East 100.46 feet to a point. Thence South 28 degrees 41 minutes East 43

72.21 feet to a point. Thence South 30 degrees 03 minutes East 101.33 feet to a point. 1 2 Thence South 35 degrees 25 minutes East 100.29 feet to a point. Thence South 34 3 degrees 39 minutes East 100.37 feet to a point. Thence South 37 degrees 29 minutes East 4 100.08 feet to a point. Thence South 43 degrees 52 minutes East 100.37 feet to a point. 5 Thence South 40 degrees 23 minutes East 117.93 feet to a point. Thence South 41 6 degrees 30 minutes East 55.58 feet to a point. Thence South 31 degrees 09 minutes East 7 67.90 feet to a point. Thence South 18 degrees 00 minutes East 118.26 feet to a point. 8 Thence South 14 degrees 49 minutes East 100.78 feet to a point. Thence South 17 9 degrees 30 minutes East 100.30 feet to a point. Thence South 68 degrees 11 minutes 10 West 202.97 feet to a point in the centerline of S.R. 1947, said point being located South 68 degrees 11 minutes West 30.00 feet from the southwest corner of Lot 15A as shown 11 12 and delineated in that plat for Bella Coola Corp. recorded in Plat Book 10, Page 95, of the 13 Columbus County Registry. Thence following the centerline of S.R. 1947 in a 14 northwesterly direction back to the point and place of beginning.

15 TRACT 2

16 BEGINNING at PKS #172, located in the centerline of S.R. 1947, locally known as Creek Ridge Road, said point being shown and delineated in that map entitled 17 18 "The Big Creek Tract at Lake Waccamaw – The Southern Part" for IP Timberlands 19 Operating Co., Ltd. and International Paper Company recorded in Plat Book 60, Page 61, 20 of the Columbus County Registry. Thence North 28 degrees 42 minutes 02 seconds East 21 202.38 feet to a post. Thence North 29 degrees 22 minutes 26 seconds East 28.43 feet to an existing iron pipe. Thence South 55 degrees 49 minutes 35 seconds East 3612.22 feet 22 23 to an existing iron pipe located on the west bank of Big Creek. Thence South 35 degrees 24 55 minutes 49 seconds West approximately 376.68 feet to a point located in the centerline of S.R. 1947. Thence following the centerline of S.R. 1947 in a northwesterly 25 direction to the point and place of beginning. 26

27 Section 2. This act becomes effective only upon adoption of an ordinance by 28 the Town of Lake Waccamaw.
