A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE OMEGA PSI PHI FRATERNITY SPECIAL LICENSE PLATES.

The General Assembly of North Carolina enacts:

Section 1. G.S. 20-81.12 is amended by adding a new subsection to read:

"(b12) Omega Psi Phi Fraternity Plates. – The Division may not issue an Omega Psi Phi Fraternity special plate unless it receives 300 or more applications for the plate and Omega Psi Phi Fraternity, Incorporated licenses, without charge, the State to develop a plate bearing the fraternity's symbol and name."

Section 2. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

17 Section 3. G.S. 20-79.7(b) reads as rewritten:

18 "(b) Distribution of Fees. – The Special Registration Plate Account and the
 19 Collegiate and Cultural Attraction Plate Account are established within the Highway
 20 Fund. The Division must credit the additional fee imposed for the special registration
 21 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the
 22 Collegiate and Cultural Attraction Plate Account (CCAPA), and the Natural Heritage
 23 Trust Fund (NHTF), which is established under G.S. 113-77.7, as follows:
