A BILL TO BE ENTITLED
AN ACT TO INCREASE THE FEES FOR REGISTRATION OF BOATS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 75A-4 reads as rewritten:

"§ 75A-4. Identification numbers required.

Every vessel on the waters of this State shall be ~~numbered~~-numbered, except those vessels exempted from numbering under G.S. 75A-7. No person shall operate or give permission for the operation of any vessel on such waters unless the vessel is numbered in accordance with this Chapter, or in accordance with applicable federal law, or in accordance with a federally approved numbering system of another state, and unless

(1) The certificate of number awarded to such vessel is in full force and effect, and

(2) The identifying number set forth in the certificate of number is displayed on each side of the bow of such vessel."

Section 2. G.S. 75A-5(a) reads as rewritten:

"(a) The owner of each vessel requiring numbering by this State shall file an application for number with the Wildlife Resources Commission on forms approved by it. The application shall be signed by the owner of the vessel, or his agent, and shall be accompanied by a fee of ~~eight dollars (\$8.00)~~ ten dollars (\$10.00) for a one-year period or

1 by a fee of ~~twenty dollars (\$20.00)~~ twenty-five dollars (\$25.00) for a three-year period;
2 provided, however, there shall be no fee charged for vessels owned and operated by
3 nonprofit rescue squads if they are operated exclusively for rescue purposes, including
4 rescue training. The applicant shall have the option of selecting a one-year numbering
5 period or a three-year numbering period. Upon receipt of the application in approved
6 form, the Commission shall have the same entered upon the records of its office and issue
7 to the applicant a certificate of number stating the number awarded to the vessel and the
8 name and address of the owner, and a validation decal indicating the expiration date of
9 the certificate of number. The owner shall paint on or attach to each side of the bow of
10 the vessel the identification number in such manner as may be prescribed by rules of the
11 Commission in order that it may be clearly visible. The number shall be maintained in
12 legible condition. The validation decal shall be displayed on the starboard bow of the
13 vessel immediately following the number. The certificate of number shall be pocket size
14 and shall be available at all times for inspection on the vessel for which issued, whenever
15 such vessel is in operation. Provided, however, any person charged with failing to so
16 carry such certificate of number shall not be convicted if he produces in court a certificate
17 of number theretofore issued to him and valid at the time of his arrest."

18 Section 3. G.S. 75A-5(c) reads as rewritten:

19 "(c) Should the ownership of a vessel change, a new application form with a fee of
20 ~~eight dollars (\$8.00)~~ ten dollars (\$10.00) for a one-year period or by a fee of ~~twenty dollars~~
21 ~~(\$20.00)~~ twenty-five dollars (\$25.00) for a three-year period shall be filed with the
22 Wildlife Resources Commission and a new certificate bearing the same number shall be
23 awarded the new owner in the manner as provided for in an original award of number. In
24 case a certificate should become lost, a new certificate bearing the same number shall be
25 issued upon payment of a fee of two dollars (\$2.00). Possession of the certificate shall in
26 cases involving prosecution for violation of any provision of this Chapter be prima facie
27 evidence that the person whose name appears therein is the owner of the boat referred to
28 therein."

29 Section 4. G.S. 75A-5(h) reads as rewritten:

30 "(h) **(Effective July 1, 1999)** Each certificate of number awarded pursuant to this
31 Chapter must be renewed on or before the first day of the month next succeeding that
32 during which the same expires; otherwise, such certificate shall lapse and be void until
33 such time as it may thereafter be renewed. Application for renewal shall be submitted on
34 a form approved by the Wildlife Resources Commission and shall be accompanied by a
35 fee of ~~eight dollars (\$8.00)~~ ten dollars (\$10.00) for a one-year period or by a fee of ~~twenty~~
36 ~~dollars (\$20.00)~~ twenty-five dollars (\$25.00) for a three-year period; provided, there shall
37 be no fee required for renewal of certificates of number which have been previously
38 issued to commercial fishing vessels as defined in G.S. 75A-5.1, upon compliance with
39 all of the requirements of that section."

40 Section 5. G.S. 75A-3(c) reads as rewritten:

41 "(c) The Boating Account is established within the Wildlife Resources Fund
42 created under G.S. 143-250. All moneys collected pursuant to the numbering and titling
43 provisions of this Chapter shall be credited to this Account. Gasoline excise tax revenue

1 is credited to the Account under G.S. 105-449.126. Revenue in the Account shall be used
2 by the Wildlife Resources Commission, subject to the Executive Budget Act and the
3 Personnel Act, for the administration and enforcement of this Chapter; for activities
4 relating to boating and water safety including education and waterway marking and
5 improvement; and for boating access area acquisition, development, and maintenance. At
6 least three dollars (\$3.00) from each boat registration fee collected under the numbering
7 provisions of G.S. 75A-5 shall be used for boating access area acquisition, development,
8 and maintenance."

9 Section 6. Section 5 of this act becomes effective January 1, 2000, and applies
10 to fees collected from each boat registration in effect on or after that date. The remainder
11 of this act becomes effective January 1, 2000.
