A BILL TO BE ENTITLED

AN ACT TO ESTABLISH THE COMMISSION ON IMPROVING THE ACADEMIC
 ACHIEVEMENT OF MINORITY AND AT-RISK STUDENTS.

Whereas, minority and at-risk students disproportionately represent a significant portion of the public school population who are not achieving academically; and

Whereas, the lack of educational achievement is demonstrated by the poor performance of minority and at-risk students as a whole on State-administered end-of-grade, end-of-course, and competency tests; and

Whereas, there is a significant gap in academic achievement between minority and at-risk students and majority students; and

Whereas, the achievement gap between student groups has not been significantly closed or narrowed in the past decade despite an overall increase in student achievement in North Carolina; and

Whereas, the reported discipline rate for minority and at-risk students is high, when compared to other students; and

Whereas, the dropout rate for minority and at-risk students is high; and

Whereas, the State Board of Education and the Department of Public Instruction recognize that there is a significant problem with schools meeting the education needs of minority and at-risk students; and

Whereas, it is acknowledged that the failure of minority and at-risk students to achieve educationally is a significant factor when addressing the economic and social burden that is experienced by the correctional and social service agencies in North Carolina; and

Whereas, the General Assembly recognizes that in order to be competitive as a State in the 21st century, all students must achieve educational proficiency in a rapidly changing technological, educational environment; and

Whereas, it is in the best interest of the North Carolina citizenry that a coordinated strategy be developed for implementing measures designed to yield substantial improvements in the educational achievement of minority and at-risk students; and

Whereas, a commission is required to effectively research, review, and make recommendations to improve achievement of minority and at-risk students; Now, therefore,

- 1 The General Assembly of North Carolina enacts:
- 2 Section 1.(a) The Commission on Improving the Academic Achievement of
 3 Minority And At-Risk Students is created. The Commission shall consist of 16 members,
 4 as follows:

- (1) Five senators and three public members appointed by the President Pro Tempore of the Senate;
- (2) Five representatives and three public members appointed by the Speaker of the House of Representatives; and
- 9 (3) Six public members appointed by the Governor, who represent groups 10 or individuals with knowledge and experience in advocating, educating, 11 or assisting minority and at-risk students to achieve, at least one of 12 whom is a representative of a statewide nonprofit education advocacy 13 organization that advocates on behalf of minority and at-risk students 14 and at least one of whom is a representative of a statewide organization 15 that represents the interests of African-Americans.
- 16 In making appointments to the Commission, the appointing officers shall ensure that 17 African-American members have significant representation on the Commission.

18 Section 1.(b) Initial appointments to the Commission shall be made before 19 September 15, 1999. The first meeting of the Commission shall be held no later than 20 October 15, 1999.

21 Section 2. The President Pro Tempore of the Senate shall designate one 22 senator as cochair and the Speaker of the House of Representatives shall designate one 23 representative as cochair.

- Section 3. The Commission shall be authorized to:
- (1) Gather accurate and reliable data and research information pertaining to
 the status of minority and at-risk students in the North Carolina public
 education system;

1 Section 7. Members of the Commission shall receive subsistence and travel 2 expenses at the rates set forth in G.S. 120-3.1.

Section 8. The Commission may contract for professional, clerical, or consultant services as provided by G.S. 120-32.02. The Legislative Administrative Officer shall assign professional staff to assist in the work of the Commission. The House of Representatives' and the Senate's Supervisors of Clerks shall assign clerical staff to the Commission, upon the direction of the Legislative Services Commission. The expenses relating to the employees shall be borne by the Commission.

9 Section 9. When a vacancy occurs in the membership of the Commission, the 10 vacancy shall be filled by the same appointing officer who made the initial appointment.

11 Section 10. All State departments and agencies and local governments and 12 their subdivisions shall furnish the Commission with information in their possession or 13 available to them.

14 Section 11. There is appropriated from the General Fund to the General 15 Assembly the sum of one hundred thousand dollars (\$100,000) for the 1999-2000 fiscal 16 year and the sum of one hundred thousand dollars (\$100,000) for the 2000-2001 fiscal 17 year for the expenses of the Commission.

18 Section 12. This act becomes effective July 1, 1999.
