1	A BILL TO BE ENTITLED
2	AN ACT TO ENSURE THAT EMPLOYEES WHO RECEIVE VACCINATION
3	AGAINST SMALLPOX INCIDENT TO THE ADMINISTRATION OF
4	SMALLPOX COUNTERMEASURES BY HEALTH PROFESSIONALS UNDER
5	SECTION 304 OF THE FEDERAL HOMELAND SECURITY ACT OF 2002 AND
6	ANY HOUSEHOLD MEMBERS LIVING IN THE HOMES OF THESE
7	VACCINATED EMPLOYEES WILL BE COVERED FOR ADVERSE MEDICAL
8	REACTIONS DUE TO THE VACCINATION.
9	The General Assembly of North Carolina enacts:
10	SECTION 1. G.S. 135-40.6(8) reads as rewritten:
11	"(8) Other Covered Charges. –
12	
13	<u>u.</u> <u>Treatment of adverse reactions to vaccinations undertaken as</u>
14	smallpox countermeasures: Necessary medical services
15	provided to a covered individual for infection with smallpox,
16	infection with vaccinia, or any adverse medical reaction due to
17	the vaccination."
18	SECTION 2. G.S. 97-53 reads as rewritten:
19	"§ 97-53. Occupational diseases enumerated; when due to exposure to chemicals.
20	The following diseases and conditions only shall be deemed to be occupational
21	diseases within the meaning of this Article:

23	(29) Infection with smallpox, infection with vaccinia, or any adverse
24	medical reaction when the infection or adverse reaction is due to the
25	employee receiving in employment vaccination against smallpox
26	incident to the Administration of Smallpox Countermeasures by
27	Health Professionals, section 304 of the Homeland Security Act, Pub.
28	L. No. 107-296 (Nov. 25, 2002)(to be codified at 42 U.S.C. § 233(p)),

1 2 3	or when the infection or adverse medical reaction is due to the employee being exposed to another employee vaccinated as described in this subdivision.

5	SECTION 3. Article 31 of Chapter 143 of the General Statutes is amended
6	by adding a new section to read:
7	"§ 143-300.1A. Claims arising from certain smallpox vaccinations of State
8	employees.
9	The North Carolina Industrial Commission shall have jurisdiction to hear and
10	determine claims in accordance with the procedures set forth in this Article made
11	against the State by a person who is permanently or temporarily living in the home of a
12	State employee who receives in employment vaccination against smallpox incident to
13	the Administration of Smallpox Countermeasures by Health Professionals, section 304
14	of the Homeland Security Act, Pub. L. No. 107-296 (Nov. 25, 2002)(to be codified at
15	42 U.S.C. § 233(p)) when the person contracts an infection with smallpox or an
16	infection with vaccinia or has any adverse medical reaction due to the vaccination
17	received by the employee. A person covered by this section shall be entitled to recover
18	from the State damages incurred by the person that are directly attributable to the
19	vaccination of the employee under this section. No showing of negligence is required
20	under this section. The provisions of G.S. 143-299.1 shall not apply to claims made
21	under this section, and contributory negligence is not a defense for claims under this
22	section. Damages awarded under this section shall be paid in accordance with G.S.
23	143-291(a1) and shall be subject to the same limits as those which apply to tort claims
24	under this Article."
25	SECTION 4. Article 3 of Chapter 126 of the General Statutes is amended by
26	adding a new section to read:
27	"§ 126-8.4. No sick leave taken for absences by State employees resulting from
28	adverse reactions to vaccination.
29	(a) Absence from work by an employee shall not count against the employee's
30	sick leave, and the employee's salary shall continue during the absence when the
31	employee receives in employment vaccination against smallpox incident to the
32	Administration of Smallpox Countermeasures by Health Professionals, section 304 of
33	the Homeland Security Act, Pub. L. No. 107-296 (Nov. 25, 2002)(to be codified at
34	42 U.S.C. § 233(p)) and the absence is due to the employee having an adverse medical
35	reaction resulting from the vaccination. The provisions of this subsection shall apply for
36	a maximum of 480 employment hours. The employing department, agency, institution,
37	or entity may require the employee to obtain certification from a health care provider
38	justifying the need for leave after the first 24 hours of leave taken pursuant to this
39	subsection.
40	(b) Absence from work by an employee shall not count against the employee's
41	sick leave, and the employee's salary shall continue during the absence when the
42	employee is permanently or temporarily living in the home of a person who receives in
43	employment vaccination against smallpox incident to the Administration of Smallpox
44	Countermeasures by Health Professionals, section 304 of the Homeland Security Act,

14 15	responders shall, not later than 90 days after this section becomes law, enact a policy

17 18	due to an adverse medical reaction resulting from the employee receiving in employment vaccination against smallpox incident to the Administration of Smallpox
18 19	<u>Countermeasures by Health Professionals, section 304 of the Homeland Security Act,</u>

20 21	SECTION 6. Part 4 of Article 5 of Chapter 153A of the General Statutes is

23 24	All counties that employ firefighters, law enforcement officers, paramedics, other
24 25	first responders, or health department employees shall, not later than 90 days after this
23 26	section becomes law, enact a policy regarding sick leave and salary continuation for
20 27	those employees for absence from work due to an adverse medical reaction resulting
28	from the employee receiving in employment vaccination against smallpox incident to
20 29	the Administration of Smallpox Countermeasures by Health Professionals, section 304
30	of the Homeland Security Act, Pub. L. No. 107-296 (Nov. 25, 2002)(to be codified at
31	42 U.S.C. § 233(p))."
32	SECTION 7. In the event that federal regulatory or statutory provisions
33	providing compensation and benefits to persons for infection with smallpox, infection
34	with vaccinia, or any adverse medical reaction incident to the Administration of
35	Smallpox Countermeasures by Health Professionals, section 304 of the Homeland
36	Security Act, Pub. L. No. 107-296 (Nov. 25, 2002)(to be codified at 42 U.S.C. § 233(p))
37	are adopted, a condition precedent to recovery under this act shall be that the person
38	claiming compensation and benefits under this act shall first seek compensation and
39	benefits under the federal provisions, with those provisions constituting primary
40	coverage and the person then being entitled to compensation and benefits under this act
41	not exceeding a total recovery under the federal provisions and this act equal to the

1 **SECTION 8.** The provisions of this act are severable. If any provision of 2 this act is held invalid by a court of competent jurisdiction, the invalidity does not affect 3 other provisions of the act that can be given effect without the invalid provision.

4 **SECTION 9.** This act is effective when it becomes law and applies to claims 5 arising from infection or adverse medical reactions related to smallpox vaccinations 6 incident to the Administration of Smallpox Countermeasures by Health Professionals, 7 section 304 of the Homeland Security Act, Pub. L. No.107-296 (Nov. 25, 2002)(to be 8 codified at 42 U.S.C. § 233(p)) whether the infection or adverse medical reactions 9 occurred before, on, or after the effective date of this act.
