Powers and duties generally. 8 In addition to the powers and duties designated in G.S. 115C-36, local boards of 9 10 education shall have the power or duty: 11 12 (44)To Ensure That All Students in Kindergarten through Eighth Grade Participate in Physical Education. – It is the duty of each local board of 13 14 education to ensure that all students in kindergarten through eighth 15 grade participate in at least 30 minutes of physical activity in a physical education program each school day. Physical activity shall 16 17 consist of physical exertion of at least moderate intensity level and for 18 a duration sufficient to provide a significant health benefit to students. It shall take place in an environment in which students learn, practice, 19 20 and are assessed on developmentally appropriate motor skills, social 21 skills, and knowledge. Local boards of education shall establish specific learning goals 22 23 and objectives for the program based on the North Carolina Healthful 24 Living Curriculum. The physical education program shall: Emphasize knowledge and skills for a lifetime of regular 25 a. physical activity; 26 27 Be consistent with the North Carolina Healthful Living b. Standard Course of Study; 28 Provide many different physical activity choices; 29 <u>c.</u> Feature cooperative as well as competitive games; 30 d. Meet the needs of all students, especially those who are not 31 e. 32 athletically gifted; 33 Take into account gender and cultural differences in students' <u>f.</u> 34 interests: 35 Teach self-management skills as well as movement skills; g. Actively teach cooperation, fair play, and responsible 36 h. participation in physical activity incorporating character 37 education concepts; 38 Be an enjoyable experience for students; 39 <u>1.</u> Be a safe environment in which children learn and participate; 40 <u>i.</u> 41 and 42 Integrate health-related fitness testing into the curriculum as an k.
