A BILL TO BE ENTITLED

1 AN ACT TO AMEND AND MODERNIZE THE CHARTER OF THE CITY OF  
2 EDEN.  
3

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** Section 3.3(d) of the Charter of the City of Eden, being  
6 Chapter 967 of the Session Laws of 1967, as amended, reads as rewritten:

7 "(d) The mayor shall exercise such powers and perform such duties as are or may  
8 be conferred upon him by the General Laws of North Carolina, by his Charter, and by  
9 the ordinances of the ~~town.~~ city."

10 **SECTION 2.** Section 3.5(a) of the Charter of the City of Eden, being  
11 Chapter 967 of the Session Laws of 1967, as amended, reads as rewritten:

12 "(a) ~~The organizational meeting of the council shall be the first regular meeting~~  
13 ~~after the regular city election. The council may fix the date and time of its~~  
14 ~~organizational meeting, provided it shall not be later than the date and time of the first~~  
15 ~~regular meeting of the council in December after the results of the municipal election~~  
16 ~~have been certified. The organization of the council shall take place notwithstanding the~~  
17 ~~absence, death, refusal to serve, failure to qualify, or nonelection of one or more~~  
18 ~~members, but at least a quorum of members must be present."~~

19 **SECTION 3.** Section 3.6.1 of the Charter of the City of Eden, being Chapter  
20 967 of the Session Laws of 1967, as amended, reads as rewritten:

21 "Section 3.6.1 Notice of Meetings.

22 (a) Regular meetings. A schedule of the regular meetings shall be filed in the  
23 office of the city clerk and shall be posted ~~on the principal bulletin board~~ at city hall.

24 (b) Special meetings. Notice of special meetings shall be delivered to the mayor  
25 and each councilman or left at his usual dwelling place at least forty-eight hours before  
26 the special meeting. In addition, notice of a special meeting shall:

27 (1) Be posted ~~on the principal bulletin board~~ at city hall; and

1           (2)    Be mailed or delivered to each news medium which has requested such  
2                   special meeting notice. News media asking for special meeting notice  
3                   shall annually request such notice in writing, filing such request with  
4                   the city clerk and paying therewith an annual fee ~~of ten dollars~~ as  
5                   established by the council to cover the costs of providing such notice.

6           (c)    Emergency meetings. Notice of emergency meetings shall be delivered to the  
7                   mayor and each councilman or left at his usual dwelling place at least six hours before  
8                   the emergency meeting. In addition, notice of an emergency meeting shall be given to  
9                   each local news medium which has filed a written request for notice with the city clerk.  
10                  Notice shall be given to each such local news medium by telephone or by delivering  
11                  such notice to the principal local office of such news medium at least six hours before  
12                  an emergency meeting.

13           (d)    The city manager shall cause all notices to be posted, mailed, delivered or  
14                  telephoned as required by this section."

15                  **SECTION 4.** Section 4.3 of the Charter of the City of Eden, being Chapter  
16                  967 of the Session Laws of 1967, is repealed.

17                  **SECTION 5.** Section 5.2 of the Charter of the City of Eden, being Chapter  
18                  967 of the Session Laws of 1967, reads as rewritten:

19                  "Sec. 5.2. Duties of City Attorney. It shall be the duty of the City Attorney to  
20                  prosecute and defend suits for and against the City; to advise the Mayor, the City  
21                  Council, and other City officials with respect to the affairs of the City; to draw all legal  
22                  documents relating to the affairs of the City; to draw proposed ordinances when  
23                  requested to do so; to inspect and pass upon all agreements, contracts, franchises and  
24                  other instruments with which the City may be concerned; to attend ~~all~~ meetings of the  
25                  Council; and to perform such other duties as may be required of him by virtue of his  
26                  position as City Attorney."

27                  **SECTION 6.** Article VII of the Charter of the City of Eden, being Chapter  
28                  967 of the Session Laws of 1967, is repealed.

29                  **SECTION 7.** This act is effective when it becomes law.
