A BILL TO BE ENTITLED
AN ACT AUTHORIZING THE NORTH CAROLINA BOARD OF COSMETIC ART
EXAMINERS TO ESTABLISH NEW FEES AND TO INCREASE CERTAIN
CURRENT FEES UNDER THE COSMETIC ART ACT.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 88B-20 reads as rewritten:

"§ 88B-20. Fees required.

(a) The Board may charge the applicant the actual cost of preparation, administration, and grading of examinations for cosmetologists, apprentices, manicurists, estheticians, or teachers, in addition to its other fees.

(b) The Board may charge application fees as follows:

- 5 (2) Cosmetic art schools and shops late renewal ~~\$ 10.00~~ \$ 35.00
- 6 (3) Reinstatement – cosmetic art schools and shops..... ~~\$ 25.00~~ \$ 75.00.

7 (d1) The Board may require payment of miscellaneous fees as follows:

- 8 (1) Document request..... \$ 10.00
- 9 (2) Mailing list \$ 20.00
- 10 (3) License listing..... \$ 15.00 per list.

11 (e) The Board may prorate fees as appropriate."
