SENATE BILL 915

Short Title: Raise Cigarette Tax for Medicaid.

1 A BILL TO BE ENTITLED
2 AN ACT TO RAISE THE EXCISE TAX ON CIGARETTES AND TO PHASE OUT
3 THE COUNTY SHARE OF MEDICAID COSTS.

4 The General Assembly of North Carolina enacts:

5 SECTION 1. G.S. 105-113.5 reads as rewritten:

6 "§ 105-113.5. Tax on cigarettes.

7 A tax is levied on the sale or possession for sale in this State, by a distributor, of all
8 cigarettes at the rate of ~~two and one-half mills~~ three cents (3¢) per individual cigarette.

9 This tax does not apply to any of the following:

- 10 (1) Sample cigarettes distributed without charge in packages containing
11 five or fewer cigarettes.
- 12 (2) Cigarettes in a package of cigarettes given without charge by the
13 manufacturer of the cigarettes to an employee of the manufacturer who
14 works in a factory where cigarettes are made, if the cigarettes are not
15 taxed by the federal government."

16 SECTION 2. Notwithstanding any other provision of law to the contrary,
17 effective July 1, 2003, the State shall pay one hundred percent (100%) of the nonfederal
18 share of nonadministrative costs under the Medical Assistance Program for all counties
19 that were designated as enterprise tier one or two for 2003. Effective July 1, 2004, the
20 State shall pay one hundred percent (100%) of the nonfederal share of
21 nonadministrative costs under the Medical Assistance Program for all counties that were
22 designated as enterprise tier one, two, or three for 2003. Effective July 1, 2005, the State
23 shall pay one hundred percent (100%) of the nonfederal share of nonadministrative
24 costs under the Medical Assistance Program for all counties. For the purposes of this
25 section, "enterprise tier" has the same meaning as under G.S. 105-129.2.

26 SECTION 3. Effective July 1, 2005, G.S. 108A-54 reads as rewritten:

27 "§ 108A-54. Authorization of Medical Assistance Program.

28 The Department is authorized and empowered to establish a Medical Assistance
29 Program from ~~federal, State and county~~ federal and State appropriations and to adopt

1 rules and regulations under which payments are to be made in accordance with the
2 provisions of this Part. ~~The nonfederal share may be divided between the State and the~~
3 ~~counties, in a manner consistent with the provisions of the federal Social Security Act,~~
4 ~~except that the share required from the counties may not exceed the share required from~~
5 ~~the state. If a portion of the nonfederal share is required from the counties, the boards of~~
6 ~~county commissioners of the several counties shall levy, impose and collect the taxes~~
7 ~~required for the special purpose of medical assistance as provided in this Part, in an~~
8 ~~amount sufficient to cover each county's share of such assistance."~~

9 **SECTION 4.** Except as otherwise provided, this act becomes effective
10 July 1, 2003.
