A BILL TO BE ENTITLED

2 AN ACT TO CREATE HOUSE DISTRICTS IN ANSON, MONTGOMERY, RICHMOND, STANLY, AND UNION COUNTIES.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 120-2(a) is rewritten to read:

"(a) For the purpose of nominating and electing members of the House of Representatives in 2004 and every two years thereafter, representative districts are established and seats in the House of Representatives are apportioned among those districts so that each district elects one representative.

THIS IS A PARTIAL DISTRICTING PLAN COVERING ONLY DISTRICTS 68, 69, 70, AND 73.
