1 A BILL TO BE ENTITLED
2 AN ACT TO AMEND THE LAW REGARDING THE USE OF MEDICARE
3 RECEIPTS BY BRODY SCHOOL OF MEDICINE AT EAST CAROLINA
4 UNIVERSITY.

5 The General Assembly of North Carolina enacts:

6 SECTION 1. G.S. 116-36.6 reads as rewritten:

7 "**§ 116-36.6. Brody School of Medicine at East Carolina University School of**
8 **Medicine; University; Medicare receipts.**

9 The Brody School of Medicine at East Carolina University School of Medicine shall
10 request, on a regular basis consistent with the State's cash management plan, funds
11 earned by the School from Medicare reimbursements for education costs. Upon receipt,
12 these funds shall be allocated as follows:

13 (1) The portion of the Medicare reimbursement generated through the
14 effort and expense of the Brody School of Medicine's Medical Faculty
15 Practice Plan shall be transferred to the appropriate Medical Faculty
16 Practice Plan account within the School of Medicine. The Medical
17 Faculty Practice Plan shall assume responsibility for any of these funds
18 that subsequently must be refunded due to final audit settlements.

19 (2) ~~The funds from this source budgeted by the General Assembly as part~~
20 ~~of the School of Medicine's General Fund budget code shall be~~
21 ~~credited to that code as a receipt.~~

22 (3) ~~The remainder of the funds shall be transferred to a special fund~~
23 ~~account on deposit with the State Treasurer. This special fund account~~
24 ~~shall be used for any necessary repayment of Medicare funds due to~~
25 ~~final audit settlements for funds allocated under subdivision (2) of this~~
26 ~~subsection. When the amount of these reimbursement funds has been~~
27 ~~finalized by audit for each year, those funds remaining in the special~~
28 ~~fund shall be available for specific capital improvement projects for~~
29 ~~the East Carolina University School of Medicine. Requests by East~~

1 ~~Carolina University for use of these funds shall be made to the Board~~
2 ~~of Governors of The University of North Carolina. Approval of~~
3 ~~projects by the Board of Governors shall be reported to the Joint~~
4 ~~Legislative Commission on Governmental Operations, and the reports~~
5 ~~shall include projected costs and sources of funds for operation of the~~
6 ~~approved projects.~~

7 (2a) Funds that were received pursuant to this section prior to July 1, 2005,
8 and that were transferred to a special fund account on deposit with the
9 State Treasurer are appropriated to the Brody School of Medicine at
10 East Carolina University and may be expended by the Brody School of
11 Medicine for the Family Medicine Center and for purposes consistent
12 with its stated mission."

13 **SECTION 2.** Subsections (b) and (c) of Section 87 of Chapter 321 of the
14 1993 Session Laws are repealed.

15 **SECTION 3.** This act becomes effective July 1, 2005.
