Restriction of certain forestry activities prohibited. 5 6 A municipality shall not adopt or continue in effect any ordinance, rule, 7 regulation, or resolution regulating forestry activities on forestland. This section applies 8 to requiring notices, permits, or imposing a fee on forestry activities. 9 (b) Nothing in this section prohibits a municipality from exercising its planning and zoning authority under Article 19 of Chapter 160A of the General Statutes. 10 Nothing in this section prohibits a municipality from exercising its authority to adopt 11 12 tree ordinances if it previously received that authority by an act of the General 13 Assembly. 14 (c) This section does not apply to development activities. The definitions in G.S. 153A-451 apply to this section." 15 (d) **SECTION 3.** This act is effective when it becomes law. 16
