A BILL TO BE ENTITLED

1 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE  
2 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF  
3 REPRESENTATIVES AND TO AMEND THE APPOINTMENT OF THE  
4 MEMBERSHIP OF THE EDENTON HISTORICAL COMMISSION.  
5

6 Whereas, G.S. 120-121 authorizes the General Assembly to make certain  
7 appointments to public offices upon the recommendation of the Speaker of the House of  
8 Representatives; and

9 Whereas, the Speaker of the House of Representatives has made  
10 recommendations; Now, therefore,

11 The General Assembly of North Carolina enacts:

12 **SECTION 1.1.** Tracy Sturdivant of Wake County and Nan Cameron of New

44           **SECTION 2.** G.S. 143B-98 reads as rewritten:

1 **"§ 143B-98. Edenton Historical Commission – members; selection; compensation;**  
2 **quorum.**

3 The Edenton Historical Commission shall consist of 33 members, ~~18-22~~ appointed  
4 by the Governor to serve at his pleasure, ~~12~~ elected by the Commission from time to  
5 time according to the procedure it adopts, ~~members appointed by the Governor~~ four  
6 appointed by the President Pro Tempore of the Senate, four appointed by the Speaker of  
7 the House of Representatives, and, ex officio, the Mayor of the Town of Edenton, the  
8 Chairman of the Board of Commissioners of Chowan County, and the Secretary of  
9 Cultural Resources or his designee.

10 All the present members of the Commission may continue to serve, at the pleasure  
11 of the Governor, until the end of his present term of office. The Commission shall elect  
12 its own officers, and the members of the Commission shall serve without pay and  
13 without expense allowance from State funds. The Commission shall determine its  
14 requirements for a quorum."

15 **SECTION 3.** Members of the Edenton Historical Commission appointed by  
16 the Governor as of July 1, 2005, shall continue to serve at the pleasure of the Governor.  
17 Members of the Edenton Historical Commission elected by the Commission as of July  
18 1, 2005, shall no longer serve unless subsequently appointed.

19 **SECTION 4.** This act is effective when it becomes law.
