A BILL TO BE ENTITLED

2 AN ACT TO ESTABLISH LICENSURE REQUIREMENTS FOR GLASS TECHNICIANS.

The General Assembly of North Carolina enacts:

SECTION 1. Chapter 20 of the General Statutes is amended by adding the following new Article to read:

"Article 18.

"Glass Technicians.

9 "<u>§ 20-400. Short title.</u>

This Article shall be known as the North Carolina Glass Technicians Licensure Act.

"<u>§ 20-401. Purpose.</u>

The General Assembly declares that in order to protect the safety and welfare of the people of North Carolina against unqualified or improper glass installation, maintenance, or repair and irreputable glass or glass-related businesses, it is necessary to provide for the licensing and regulation of automotive glass technicians, automotive glass repair technicians, flat glass technicians, and other glass-related companies.

"§ 20-402. License required.

- (a) After July 1, 2006, no person shall engage in the practice of automotive glass work, automotive glass repair work, or flat glass work unless the person has been properly licensed under the provisions of this Article.
- (b) No person shall use the title 'Licensed Automotive Glass Technician', 'Licensed Automotive Glass Repair Technician', 'Licensed Flat Glass Technician', or any other similar title or description or represent himself or herself as a licensed automotive glass technician, licensed automotive glass repair technician, or licensed flat glass technician unless licensed under this Article.
 - (c) Any person violating the provisions of this Article shall be guilty of a Class 3 misdemeanor.

"§ 20-403. Exemptions. 1 2 Nothing in this Article shall be construed to prohibit or affect: 3 Practice by persons employed by any federal, State, or municipal (1) 4 5 Practice by a person who is a student in an educational or certification (2) 6 program approved by the Board. 7 A person performing automotive glass work, automotive glass repair (3) 8 work, or flat glass work in this State so long as the services are not 9 performed more than four times per year. 10 (4) Employees of industrial firms whose main duties concern the maintenance of automotive work or flat glass work on its own or 11 12 leased premises for its own use. The fabrication of glass products. 13 (5) 14 (6) Persons engaged in the installation, maintenance, repair, or service of 15 glass for single-family residences owned and occupied or to be occupied by those persons, subject to inspection and approval by the 16 17 building official and in conformance with State building codes. 18 A person who installs, maintains, or repairs glass in a motor vehicle <u>(7)</u> owned or leased by that person. 19 Persons or entities holding themselves out to be retail sellers of glass 20 (8) 21 products, but not those persons or entities that also engage in automotive glass work or flat glass work. 22 Persons who install preglazed or preassembled windows or doors in 23 <u>(9)</u> 24 residential or commercial buildings. Persons who install safety-backed mirror products or repair or replace 25 (10)flat glass in sizes not greater than 30 square feet in residential 26 27 buildings. "<u>§ 20-404</u>. Definitions. 28 29 The following definitions apply in this Article: 30 Accredited businesses. – Glass shops that have met all the (1) 31

- requirements of the National Glass Association Business Accreditation Council and received the accredited business designation.
- Automotive glass work. The act of installing, maintaining, or (2) repairing fixed glass in motor vehicles.
- Board. The North Carolina Glass Technicians Board of Examiners. (3)
- Flat glass work. The act of installing, maintaining, or repairing glass (4) in residential or commercial structures.
- Licensed automotive glass repair technician. A person licensed under <u>(5)</u> this Article to provide repairs to damaged fixed glass in motor vehicles.
- Licensed automotive glass technician. A person licensed under this (6) Article to provide automotive glass work.
- Licensed flat glass technician. A person licensed under this Article to (7) provide flat glass work.

"§ 20-405. North Carolina Glass Technicians Board of Examiners.

- Composition and Terms. The North Carolina Glass Technicians Board of (a) Examiners is created. The Board shall consist of seven members who shall serve staggered terms. The initial Board members shall be appointed on or before January 1, 2006, as follows:
 - (1) The General Assembly, upon the recommendation of the President Pro Tempore of the Senate, shall appoint three members. One of these members shall be a certified automotive glass technician who shall serve a three-year term, one shall be a certified automotive repair technician who shall serve a two-year term, and one shall be a certified flat glass technician who shall serve a one-year term.
 - The General Assembly, upon the recommendation of the Speaker of (2) the House of Representatives, shall appoint three members. One of these members shall be a certified automotive glass technician who shall serve a three-year term, one shall be a certified automotive repair technician who shall serve a two-year term, and one shall be a certified flat glass technician who shall serve a one-year term.
 - (3) The Governor shall appoint one public member who is a consumer of glass work or has an interest in the rights of consumers who shall serve a three-year term.

Initial Board members appointed on or before January 1, 2006, do not have to be licensed upon appointment. However, once licensure requirements are established, those initial Board members shall satisfy the applicable requirements for licensure pursuant to this Article.

Upon the expiration of the terms of the initial Board members, each member shall be appointed for a term of three years and shall serve until a successor is appointed and qualified. No member may serve more than two consecutive terms.

- Qualifications. All members of the Board shall reside in this State and shall represent the various geographical areas or congressional districts of the State.
- Vacancies. A vacancy shall be filled in the same manner as the original appointment, except that all unexpired terms in seats appointed by the General Assembly shall be filled in accordance with G.S. 120-122. Appointees to fill vacancies shall serve the remainder of the unexpired term and until their successors have been duly appointed and qualified.
- Removal. The Board may remove any of its members for neglect of duty, incompetence, or unprofessional conduct. A member subject to disciplinary proceedings as a licensee shall be disqualified from participating in the official business of the Board until the charges have been resolved.
- Compensation. Each member of the Board shall receive per diem and reimbursement for travel and subsistence as provided in G.S. 93B-5.
- Officers. The officers of the Board shall be a chair, a vice-chair, and other officers deemed necessary by the Board to carry out the purposes of this Article. All officers shall be elected annually during the first meeting of the calendar year by the Board for one-year terms and shall serve until their successors are elected and qualified.

Maintain a list of the names and addresses of all persons licensed by 25 (11)26 the Board. 27 Employ and fix the compensation of personnel that the Board (12)determines is necessary to carry out the provisions of this Article and 28 29 incur other expenses necessary to perform the duties of the Board. 30 Adopt a seal containing the name of the Board for use on all licenses (13)and official reports issued by the Board. 31 32 Prescribe standards of ethical conduct for automotive glass work, (14)33 automotive glass repair work, and flat glass work. "§ 20-407. Oualifications for licensure: examination. 34 35 An applicant shall be licensed as an automotive glass technician if the 36 applicant meets all of the following qualifications: Has obtained a high school diploma or equivalent. 37 (1) 38 (2) Is at least 18 years of age. 39 Is of good moral and ethical character. (3) Has successfully completed the application process. 40 (4) Possesses current credentials as a 'Certified Automotive Glass 41 (5) 42 Technician' issued by the National Glass Association (NGA) or is certified as an automotive glass technician by a nationally recognized 43 certification committee recognized by the Board.

H1274 [Filed] Page 5 Upon filing an application and payment of the required fee, the Board may issue a license without examination to an applicant who is licensed as an automotive glass technician, automotive glass repair technician, or flat glass technician in another state or territory if the requirements for licensure in that state or territory are substantially equal to the requirements for licensure in this State as determined by the Board.

"§ 20-409. Fees.

The Board shall establish fees not to exceed the following amounts:

<u>(1)</u>	<u>Issuance of a license</u>	\$200.00
<u>(2)</u>	Renewal of a license	\$200.00
<u>(3)</u>	<u>Examination</u>	\$250.00
<u>(4)</u>	<u>Reinstatement</u>	\$150.00
(5)	Late fees	\$150.00

"§ 20-410. License renewal; display of license; license nontransferable.

- (a) All licenses shall expire one year after the date they were issued unless renewed. At least 30 days before the expiration date of a license, the Board shall send the licensee an application and notice of renewal of license. All applications for renewal shall be filed with the Board and shall be accompanied by the renewal fee as required by G.S. 20-409. A license that has expired for failure to renew may be reinstated after the applicant pays the late and reinstatement fees as required by G.S. 20-409. The Board may establish any other license renewal requirements as necessary pursuant to rules adopted by the Board.
- (b) The Board shall replace any license that is lost, destroyed, or mutilated, subject to rules established by the Board.
- (c) Every automotive glass technician, automotive glass repair technician, and flat glass technician issued a license under this Article shall display the license prominently in his or her place of business and the technician's license number shall appear on all proposals, contracts, or requests for permits issued by municipalities.
 - (d) A license may not be transferred or assigned.

"§ 20-411. Grounds for disciplinary action.

The Board may deny, revoke, suspend, refuse to renew, censure, or reprimand a licensee or an applicant or place a licensee on probation for any of the following:

- (1) Practicing automotive glass work, automotive glass repair work, or flat glass work in violation of the provisions of this Article or any rules adopted by the Board.
- (2) Obtaining or attempting to obtain a license by fraud or misrepresentation.
- (3) Having been convicted of a felony in the courts of this State or any other state.
- (4) Gross negligence in automotive glass work, automotive glass repair work, or flat glass work that results in injury to another.
- (5) Engaging in dishonorable, unethical, or unprofessional conduct of a character likely to deceive, defraud, or harm the public.
- (6) <u>Habitual intoxication or addition to the use of drugs.</u>

- 1 (7) <u>Directly or indirectly giving or receiving a fee, commission, rebate, or other form of compensation for a service not actually rendered.</u>
 - (8) Failure to respond to a written request for information by the Board within 60 days.
 - (9) Having had a license or certification revoked or suspended or other disciplinary action taken by authorities of another state or territory.
 - (10) Aiding or abetting a person not licensed in this State who directly or indirectly performs automotive glass work, automotive glass repair work, or flat glass work requiring a license.
 - (11) Has made material misstatements in the application for licensure or renewal.
 - (12) Has demonstrated gross negligence, incompetency, or misconduct in the performance of automotive glass work, automotive glass repair work, or flat glass work.

"§ 20-412. Injunctive relief.

The Board may apply to the superior court for an order enjoining violations of this Article. Upon a showing by the Board that any person has violated this Article, the court may grant injunctive relief."

SECTION 2. Any person who submits proof to the Board that the person has practiced automotive glass work, automotive glass repair work, or flat glass work full time for at least five consecutive years prior to the effective date of this act, has completed a nationally recognized certification program in automotive glass work, automotive glass repair work, or flat glass work approved by the Board, or is certified as an automotive glass technician, automotive glass repair technician, or flat glass technician by the National Glass Association or an equivalent, nationally recognized successor organization recognized by the Board may be granted the appropriate license upon completion of an investigation of the applicant's work history by the Board and payment of the required fee under G.S. 20-409, enacted in Section 1 of this act, without having to satisfy the requirements of G.S. 20-407, enacted in Section 1 of this act. All persons who do not make application to the Board within one year of the effective date of this act shall be required to complete all requirements prescribed by the Board and to otherwise comply with the provisions of Article 18 of Chapter 20 of the General Statutes, enacted by Section 1 of this act.

SECTION 3. This act is effective when it becomes law.
