A BILL TO BE ENTITLED  
AN ACT TO APPROPRIATE FUNDS FOR TWO ADDITIONAL ASSISTANT  
DISTRICT ATTORNEYS FOR PROSECUTORIAL DISTRICT 28.

The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 7A-60(a1) reads as rewritten:

"(a1) The counties of the State are organized into prosecutorial districts, and each district has the counties and the number of full-time assistant district attorneys set forth in the following table:

36           **SECTION 2.** There is appropriated from the General Fund to the Judicial  
37 Department the sum of one hundred sixty-four thousand eight hundred forty-two dollars  
38 (\$164,842) for the 2006-2007 fiscal year to establish the two new assistant district  
39 attorneys authorized by this act.

40           **SECTION 3.** This act becomes effective July 1, 2006.
