**SECTION 2.** There is appropriated from the General Fund to the Judicial Department the sum of eighty-four thousand six hundred ninety dollars (\$84,690) for the 2006-2007 fiscal year to establish the additional assistant district attorney position authorized by this act.

**SECTION 3.** There is appropriated from the General Fund to the Judicial Department the sum of forty-eight thousand three hundred fifty-four dollars (\$48,354) for the 2006-2007 fiscal year to establish an additional victim witness assistant position for Prosecutorial District 3B.
