SECTION 1. There is appropriated from the General Fund to Person County the sum of fourteen thousand dollars (\$14,000) for the 2006-2007 fiscal year to be used to purchase equipment for the County's seven volunteer fire departments. These funds shall be allocated equally among the following:

- (1) Ceffo Volunteer Fire & Rescue Department.
- (2) Moriah Volunteer Fire & Rescue Department.
- (3) Hurdle Mills Volunteer Fire Department.
- (4) Timberlake Volunteer Fire & Rescue.
 - (5) Triple Springs Volunteer Fire Department.
 - (6) Allensville Volunteer Fire Department.
 - (7) Woodsdale Volunteer Fire Department.

SECTION 2. There is appropriated from the General Fund to Durham County the sum of four thousand dollars (\$4,000) for the 2006-2007 fiscal year to be used to purchase equipment for the two volunteer fire departments that serve areas of Northern Durham County. These funds shall be allocated equally among the following:

- (1) Lebanon Volunteer Fire Department.
- (2) Bahama Volunteer Fire and Rescue.

SECTION 3. There is appropriated from the General Fund to Caswell County the sum of twenty thousand dollars (\$20,000) for the 2006-2007 fiscal year to be used to purchase equipment for the County's 10 volunteer fire departments. These funds shall be allocated equally among the following:

(1) Yanceyville Volunteer Fire and Rescue.
