A BILL TO BE ENTITLED

1 AN ACT AFFECTING THE REGULATION OF ABANDONED OR JUNKED
2 MOTOR VEHICLES IN THE CITY OF HENDERSON AND THE TOWN OF
3 LOUISBURG.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 160A-303(b2) reads as rewritten:

7 "(b2) A junked motor vehicle is an abandoned motor vehicle that also:

8 (1) Is partially dismantled or wrecked; or

9 (2) Cannot be self-propelled or moved in the manner in which it was
10 originally intended to move; or

11 (3) Is more than five years old and worth less than ~~one hundred dollars~~
12 ~~(\$100.00);~~ five hundred dollars (\$500.00); or

13 (4) Does not display a current license plate."

14 **SECTION 2.** G.S. 160A-303.2(a) reads as rewritten:

15 "(a) A municipality may by ordinance regulate, restrain or prohibit the
16 abandonment of junked motor vehicles on public grounds and on private property
17 within the municipality's ordinance-making jurisdiction upon a finding that such
18 regulation, restraint or prohibition is necessary and desirable to promote or enhance
19 community, neighborhood or area appearance, and may enforce any such ordinance by
20 removing or disposing of junked motor vehicles subject to the ordinance according to
21 the procedures prescribed in this section. The authority granted by this section shall be
22 supplemental to any other authority conferred upon municipalities. Nothing in this
23 section shall be construed to authorize a municipality to require the removal or disposal
24 of a motor vehicle kept or stored at a bona fide "automobile graveyard" or "junkyard" as
25 defined in G.S. 136-143.

26 For purposes of this section, the term "junked motor vehicle" means a vehicle that
27 does not display a current license plate and that:

28 (1) Is partially dismantled or wrecked; or

1 (2) Cannot be self-propelled or moved in the manner in which it originally
2 was intended to move; or

3 (3) Is more than five years old and appears to be worth less than ~~one~~
4 ~~hundred dollars (\$100.00);~~ five hundred dollars (\$500.00)."

5 **SECTION 3.** Section 1 of this act applies only to the City of Henderson and
6 the Town of Louisburg. Section 2 of this act applies only to the Town of Louisburg.

7 **SECTION 4.** This act is effective when it becomes law.
