SECTION 2. There is appropriated from the General Fund to the Judicial Department the sum of one hundred sixty-nine thousand three hundred eighty dollars ( $\$ 169,380$ ) for the 2006-2007 fiscal year to establish the additional assistant district attorneys authorized by this act.

SECTION 3. There is appropriated from the General Fund to the Judicial Department the sum of ninety-six thousand seven hundred eight dollars $(\$ 96,708)$ for
the 2006-2007 fiscal year to establish two additional victim witness assistant positions for Prosecutorial District 24.

SECTION 4. This act becomes effective July 1, 2006.
