3	BUDGET CUTS TO THAT PROGRAM.		
4	The General Assembly of North Carolina enacts:		
5	<b>SECTION 1.</b> Section 18.2 of S.L. 2004-124 is repealed, and any statutes		
6	repealed by that section are reenacted.		
7	<b>SECTION 2.</b> G.S. 143-652, as reenacted by Section 1 of this act, reads as		
8	rewritten:		
9	"§ 143-652. State Boxing Commission.		
10	(a) Creation. – The North Carolina State Boxing Commission is created within		
11	the Department of Crime Control and Public Safety to regulate in North Carolina live		
12	boxing and kickboxing matches, whether professional, amateur, sanctioned amateur, or		
13	toughman events, in which admission is charged for viewing, or the contestants compete		
14	for a purse or prize of value greater than twenty-five dollars (\$25.00). The Commission		
15	shall consist of six voting members and two nonvoting advisory members. All the		
16	members shall be residents of North Carolina and shall meet requirements for		
17	membership under the Professional Boxing Safety Act of 1996. The members shall be		
18	appointed as follows:		
19	(1) One voting member shall be appointed by the Governor for an initial		
20	term of two years.		
21	(2) One voting member shall be appointed by the General Assembly upon		
22	the recommendation of the President Pro Tempore of the Senate for an		
23	initial term of one year, in accordance with G.S. 120-121.		
24	(3) One voting member shall be appointed by the General Assembly upon		
25	the recommendation of the Speaker of the House of Representatives		
26	for an initial term of one year.

1	(4)	Two voting members shall be appointed by the Secretary of Crime		
2		Control and Public Safety. One shall serve for an initial term of three		
3		years, and the other shall serve for an initial term of two years.		
4	(4a)	One member shall be appointed by the Tribal Council of the Eastern		
5		Band of the Cherokee for an initial term of three years.		
6	(5)	One nonvoting advisory member shall be appointed by the General		
7		Assembly upon the recommendation of the Speaker of the House of		
8		Representatives for an initial term of one year, in accordance with		
9		G.S. 120-121, from nominations made by the North Carolina Medical		
10		Society, which shall nominate two licensed physicians for the position.		
11	(6)	One nonvoting advisory member shall be appointed by the General		
12		Assembly upon the recommendation of the President Pro Tempore of		
13		the Senate for an initial term of one year, in accordance with		
14		G.S. 120-121, from nominations made by the North Carolina Medical		
15		Society, which shall nominate two licensed physicians for the position.		
16	The member	appointed pursuant to subdivision (5) of subsection (a) of this section		
17	may serve on the Commission only if an agreement exists and remains in effect between			
18	the Tribal Council of the Eastern Band of the Cherokee and the Commission authorizing			
19	the Commission to regulate professional boxing matches within the Cherokee Indian			
20	Reservation as provided by the Professional Boxing Safety Act of 1996.			
21	The two nonvoting advisory members appointed pursuant to subdivisions (6) and (7)			
22	of subsection (a) of this section shall advise the Commission on matters concerning the

23 24	health and physical condition of boxers and health issues relating to the conduct of exhibitions and hoving metabos. They may prepare and submit to the Commission for

Action may be taken and motions and resolutions adopted by the Commission at any 1 2 meeting by the affirmative vote of a majority of the members of the Commission 3 present at a meeting at which a quorum exists. Any or all members may participate in a regular or special meeting by, or conduct the meeting through the use of, any means of 4 5 communication by which all members participating may simultaneously hear each other 6 during the meeting. A member participating in the meeting by this means is deemed to 7 be present in person at the meeting. 8 Rule-Making Authority of the Commission. – The Commission shall have the (d)9 exclusive authority to approve and issue rules for the regulation of the conduct, 10 promotion, and performances of live boxing, kickboxing, sanctioned amateur, amateur, and toughman matches and exhibitions in this State. The rules shall be issued pursuant 11 12 to the provisions of Chapter 150B of the General Statutes and may include, without 13 limitation, the following subjects: 14 (1)Requirements for issuance of licenses and permits required by this 15 Article. 16 (2)Regulation of ticket sales. 17 (3)Physical requirements for contestants, including classification by 18 weight and skill. 19 (4)Supervision of matches and exhibitions by licensed physicians and 20 referees. 21 (5) Insurance and bonding requirements. Compensation of participants and licensees. 22 (6)Contracts and financial arrangements. 23 (7)(8) Prohibition of dishonest, unethical, and injurious practices. 24 25 (9) Facilities. 26 (10)Approval of sanctioning amateur sports organizations. 27 Procedures and requirements for compliance with the Professional (11)Boxing Safety Act of 1996. 28 29 Compensation. - None of the members of the Commission shall receive (e) 30 compensation for serving on the Commission. However, members of the Commission may be reimbursed for their expenses in accordance with the provisions of Chapter 138 31 32 of the General Statutes. 33 (f) Staff Assistance. - The Secretary of Crime Control and Public Safety shall 34 hire a person to serve as Executive Director of the Commission and shall provide staff 35 assistance to the Executive Director. The Executive Director shall enforce this Article through the Division of Alcohol Law Enforcement. If necessary, the Executive Director 36 may train and contract with independent contractors for the purpose of regulating and 37 38 monitoring events, issuing licenses, collecting fees, and enforcing rules of the 39 Commission. The Executive Director may initiate criminal background checks on persons requesting to work as independent contractors for the Commission or persons 40 applying to be licensed by the Commission. 41 42 Initial appointments to the Commission under this reenacted section shall be (g)

43 <u>for terms commencing July 1, 2006. The Commission may reestablish any rules in</u> 44 effect on the date of the prior abolition of the Commission without following any

1	requirements of Chapter 150B of the General Statutes other than publishing the rules.
2	Any rules of the Alcohol Law Enforcement Division relating to the subject shall remain
3	in effect until new or amended rules are adopted by the Commission."
4	SECTION 3. There is appropriated from the General Fund to the
5	Department of Crime Control and Public Safety for the 2006-2007 fiscal year the sum
6	of one hundred thirty-one thousand four hundred forty-nine dollars (\$131,449) to restore
7	budget cuts for the North Carolina State Boxing Commission.
8	<b>SECTION 4.</b> This act becomes effective July 1, 2006.
