AN ACT TO APPROPRIATE FUNDS FOR THREE ADDITIONAL ASSISTANT
DISTRICT ATTORNEYS FOR PROSECUTORIAL DISTRICT 20B AND TWO
VICTIM WITNESS ASSISTANT POSITIONS FOR PROSECUTORIAL
DISTRICT 20B.

The General Assembly of North Carolina enacts:

SECTION 1. Effective January 1, 2007, G.S. 7A-60(a1) reads as rewritten:

"(a1) The counties of the State are organized into prosecutorial districts, and each district has the counties and the number of full-time assistant district attorneys set forth in the following table:

SEC	TION 2. There is appropriated from the General	Fund to the Judicia

SECTION 2. There is appropriated from the General Fund to the Judicial Department the sum of one hundred thirty-four thousand four hundred twelve dollars (\$134,412) for the 2006-2007 fiscal year to establish the three additional assistant district attorney positions authorized by this act.

SECTION 3. There is appropriated from the General Fund to the Judicial Department the sum of forty-eight thousand three hundred fifty-four dollars (\$48,354)
