2	AN ACT TO ESTABLISH THE NORTH CAROLINA HEALTH CARE FOR ALL				
3	PLANNING COMMISSION.				
4	The General Assembly of North Carolina enacts:				
5	<b>SECTION 1.(a)</b> Commission Established. – There is established the North				
6	Carolina Health Care for All Planning Commission ("Commission"). The purpose of				
7	the Commission is to conduct a comprehensive review of the current health care system				
8	in North Carolina and make recommendations to the General Assembly on moving from				
9	a fragmented system to an integrated system of public and private health care services				
10	such that all North Carolinians have access to appropriate health care on a regular basis.				
11	SECTION 1.(b) Membership. – The Commission shall consist of 17				
12	members, appointed as follows:				
13	(1) Two members of the House of Representatives appointed by the				
14	Speaker of the House of Representatives.				
15	(2) Two members of the Senate appointed by the President Pro Tempore				
16	of the Senate.				
17	(3) The Governor shall appoint nine members. The Governor shall select				
18	appointees after public solicitation and receipt of applications from				
19	interested parties. In making the appointments, the Governor shall				
20	consider the gender, ethnic, and racial distribution of the population of				
21	North Carolina:				
22	a. One member representing the health insurance industry in the				
23	State.				
24	b. One member representing hospitals licensed in this State.				
25	c. Two members representing employers, one of whom represents				
26	employers with fewer than 25 employees and one of whom				
27	represents employers with 25 or more employees.

16	<b>SECTION 1.(c)</b> Vacancies in Membership. – Vacancies on the Commission		
17	shall be filled by the original appointing authority as provided in this section.		
18	SECTION 1.(d) Cochair appointment. – The Speaker of the House of		
19	Representatives, the President Pro Tempore of the Senate, and the Governor, shall each		
20	name one cochair of the Commission.		
21	SECTION 1.(e) Public Input and Reports. – The agenda of each full		
22	Commission meeting shall provide for a public comment period. All reports produced		
23 24	at the request of the Commission shall be made reasonably available to the public.		
24 25	<b>SECTION 1.(f)</b> Commission Funds. – Funds appropriated to the General Assembly for the 2007-2008 fiscal year and the 2008-2009 fiscal year shall be allocated		
25 26	by the Legislative Services Commission for the expenses of the North Carolina Health		
20	Care for All Planning Commission, including per diem, subsistence, and travel		
28	allowances as authorized under G.S. 120-3.1, 138-5, or 138-6, as applicable.		
29	<b>SECTION 1.(g)</b> Commission Staff. – The Legislative Services Commission,		
30	through the Legislative Services Officer, shall assign professional staff to assist the		
31	Commission in its work. The Supervisors of Clerks of the House of Representatives		
32	and the Senate shall assign clerical staff to the Commission. Expenses related to the		
33	clerical employees shall be borne by the Commission from funds allocated to it.		
34	<b>SECTION 1.(h)</b> Professional Services. – In accordance with G.S. 120-32.02,		
35	the Commission shall engage the services of State and national consultants who are		
36	experts in the analysis of the organization, quality, and cost of health care delivery		
37 38	models to assist with the study. Before contracting with a consultant, the Commission shall report to the Joint Logislative Commission on Covernmental Operations on the		
38 39	shall report to the Joint Legislative Commission on Governmental Operations on the consultant selected, the work products to be provided by the consultant, and the cost of		
40	the contract, including an itemization of the cost components. Reports of the		
41	consultants shall be made available to the public.		
42	<b>SECTION 2.(a)</b> Health Care for All Plan. – The Commission shall develop		
43	and recommend to the General Assembly a Health Care for All Plan ("Plan") for		
44	phased-in transitioning from the current fragmented system of health care delivery to a

15	SECT	<b>FION 2.(b)</b> Plan Development. – The Plan shall address the following:
16	(1)	All people living in North Carolina shall, by the year 2012, have
17		access to regular and comprehensive health care, of high quality,
18		whether public or private, that is affordable for individuals, taxpayers,
19		employers, and other payers.
20	(2)`	Development of the Plan shall take into account the costs of
21		implementation, impact on the State's economy, economic impact of
22		the improved health of North Carolinians, and savings inherent in a
23		comprehensive system of health care services that improves access to
24		preventive and primary care and reduces unnecessary acute care,
25		emergency services, and administrative costs.
26	(3)	Initiatives to measure and improve the quality of health care in this
27		State, including consumer and provider satisfaction and health
28		outcomes.
29 30	(4)	Funding of the Plan shall be from all participants in the health care system, including:
31		a. State, local, and federal funding for the Medicaid program;

34		c. Health insurance industry assessments;

39	(5)	The Plan shall provide for continuous monitoring and evaluation of the
40	X- /	integrated system to identify successes and address areas that need
41		strengthening. The Plan shall also provide for regular reporting to the
42		General Assembly and the Governor on the implementation of the
43		integrated system of care.

## **General Assembly of North Carolina**

1 SECTION 2.(c) The Commission shall present annual interim reports, 2 including recommended legislation, to the Speaker of the House of Representatives, the 3 President Pro Tempore of the Senate, and the Governor beginning May 1, 2008. The 4 Commission shall present its final report to the 2011 General Assembly upon its 5 convening, and to the Governor upon the convening of the 2011 General Assembly. 6 Upon issuing its final report, the Commission shall terminate.

**SECTION 3.** There is appropriated from the General Fund to the General Assembly, Legislative Services Office, the sum of one hundred thousand dollars (\$100,000) for the 2007-2008 fiscal year and the sum of one hundred thousand dollars (\$100,000) for the 2008-2009 fiscal year. These funds shall be used for consultant and other professional services to aid the North Carolina Health Care for All Planning Commission in fulfilling its purpose.

13 SECTION 4. Section 3 of this act becomes effective July 1, 2007. The
14 remainder of this act is effective when it becomes law.
