5	The General Assembly of North Carolina enacts:
6	SECTION 1. G.S. 160A-58.1(b)(5) reads as rewritten:
7	"(b) A noncontiguous area proposed for annexation must meet all of the following
8	standards:
9	
10	(5) The area within the proposed satellite corporate limits, when added to
11	the area within all other satellite corporate limits, may not exceed ten
12	percent (10%) of the area within the primary corporate limits of the
13	annexing city.
14	This subdivision does not apply to the Cities of Claremont,
15	Concord, Conover, Durham, Elizabeth City, Gastonia, Greenville,
16	Hickory, Kannapolis, Locust, Marion, Mount Airy, Mount Holly, New
17	Bern, Newton, Oxford, Randleman, Roanoke Rapids, Rockingham,
18	Sanford, Salisbury, Southport, Statesville, and Washington and the
19	Towns of Ahoskie, Angier, Ayden, Benson, Bladenboro, Burgaw,
20	Calabash, Catawba, Clayton, Columbia, Columbus, Cramerton,

3	SECTION 2. For the Town of Richlands, G.S. 160-58.1(b)(5) shall not
4	apply in the following described territory: All of Tax Parcel 62-1.4 and that part of Tax
5	Parcel 62-1 that is north of a line starting 500 feet south of Rhodestown Road and
6	running a 50 degree line to the back of Tax Parcel 62-1, all tax parcels as stated by the
7	Onslow County records.
8	SECTION 3. This act is effective when it becomes law."
