2	AN ACT TO INCREASE THE MAXIMUM ANNUAL PENSION BENEFIT
3	PAYABLE THROUGH THE REGISTER OF DEEDS' SUPPLEMENTAL
4	PENSION FUND AND TO MAKE OTHER ADJUSTMENTS TO THE FUND.
5	The General Assembly of North Carolina enacts:
6	<b>SECTION 1.</b> G.S. 161-50.2 reads as rewritten:
7	"§ 161-50.2. Assets.
8	(a) On and after October 1, 1987, each County Commission shall remit monthly
9	to the Department of State Treasurer an amount equal to four and one-half percent
10	(4.5%) <u>nine-tenths of one percent (0.9%)</u> of the monthly receipts collected pursuant to
11	Article 1 of Chapter 161 of the General Statutes, to be deposited to the credit of the
12	Registers of Deeds' Supplemental Pension Fund, hereinafter referred to as the Fund, to
13	be used in making monthly pension payments to eligible retired registers of deeds under
14	the provisions of this Article and to pay the cost of administering the provisions of this
15	Article.
16	(b) The State Treasurer shall be the custodian of the Registers of Deeds'
17	Supplemental Pension Fund and shall invest its assets in accordance with the provisions
18	of G.S. 147-69.2 and G.S. 147-69.3."
19	<b>SECTION 2.</b> G.S. 161-50.4(b) reads as rewritten:
20	"(b) Each eligible retired register of deeds as defined in subsection (a), (a1), or
21	(a2) of this section relating to service and retirement status on January 1 of each
22	calendar year shall be entitled to receive a monthly pension under this Article beginning
23	with the month of January of the same calendar year. retirement."
24	<b>SECTION 3.</b> G.S. 161-50.5(a) reads as rewritten:
25	"(a) An eligible retired register of deeds shall be entitled to receive an annual
26	pension benefit, payable in equal monthly installments, equal to one share for each full
27	year of eligible service as register of deeds multiplied by his total number of years of
28	eligible service. The amount of each share shall be determined by dividing the total
29	number of years of eligible service for all eligible retired registers of deeds on

December 31 of each calendar year into the amount to be disbursed as monthly pension 1 payments in accordance with the provisions of G.S. 161-50.3. In no event, however, 2 3 shall a monthly pension under this Article exceed an amount, which when added to a 4 retirement allowance at retirement from the Local Governmental Employees' 5 Retirement System or an equivalent locally sponsored plan, and a determined life 6 annuity value of benefits payable at the time of retirement from contributions other than 7 his own and earnings thereon from the Supplemental Retirement Income Plan pursuant 8 to Chapter 135 of the General Statutes as determined by the Department of State 9 Treasurer and the Plan's Board of Trustees, is greater than seventy-five percent (75%) of 10 a register of deed's equivalent annual salary immediately preceding retirement computed 11 on the latest monthly base rate, to a maximum amount of one thousand two hundred 12 dollars (\$1,200). one thousand five hundred dollars (\$1,500)." 13 **SECTION 4.** This act becomes effective July 1, 2007.
