A BILL TO BE ENTITLED

2 AN ACT TO ELIMINATE THE PROHIBITION AGAINST CERTAIN SPOUSES OF  
3 MEMBERS OF THE BOARD OF GOVERNORS OF THE UNIVERSITY OF  
4 NORTH CAROLINA, MEMBERS OF THE BOARD OF TRUSTEES OF A  
5 CONSTITUENT INSTITUTION, OR MEMBERS OF THE STATE BOARD OF  
6 COMMUNITY COLLEGES FROM BEING EMPLOYEES OR OFFICERS OF  
7 THE STATE.

8 The General Assembly of North Carolina enacts:

9 **SECTION 1.** G.S. 116-7(b) reads as rewritten:

10 "(b) ~~From and after July 1, 1973, no~~No member of the General Assembly or  
11 officer or employee of the ~~State or of State, The University of North Carolina, or any~~  
12 constituent institution ~~or spouse of any such member, officer or employee~~ may be a  
13 member of the Board of Governors. No spouse of a member of the General Assembly,  
14 or of an officer or employee of The University of North Carolina, or of any constituent  
15 institution may be a member of the Board of Governors. Any member of the Board of  
16 Governors who is elected or appointed to the General Assembly or who becomes an  
17 officer or employee of the State or of any constituent institution or whose spouse is  
18 elected or appointed to the General Assembly or becomes ~~such an~~an officer or employee  
19 of The University of North Carolina or of any constituent institution shall be deemed  
20 thereupon to resign from his membership on the Board of Governors."

21 **SECTION 2.** G.S. 116-31(h) reads as rewritten:

22 "(h) ~~From and after July 1, 1973, no~~No member of the General Assembly or  
23 officer or employee of the ~~State or of State, The University of North Carolina, or any~~  
24 constituent institution ~~or spouse of any such member, officer or employee~~ shall be  
25 eligible for election or appointment as a trustee. No spouse of a member of the General  
26 Assembly, or of an officer or employee of a constituent institution may be a trustee of  
27 that constituent institution. Any trustee who is elected or appointed to the General

1 Assembly or who becomes an officer or employee of the ~~State or of~~State, The  
2 University of North Carolina, or any constituent institution or whose spouse is elected  
3 or appointed to the General Assembly or becomes ~~such an~~ officer or employee of that  
4 constituent institution shall be deemed thereupon to resign from his membership on the  
5 board of trustees."

6 **SECTION 3.** G.S. 115D-2.1(d) reads as rewritten:

7 "(d) No member of the General Assembly, no officer or employee of the State,  
8 and no officer or employee of an institution under the jurisdiction of the State Board ~~and~~  
9 ~~no spouse of any of those persons~~, shall be eligible to serve on the State Board. No  
10 spouse of a member of the General Assembly or of an officer or employee of the  
11 Community College System or of an institution under the jurisdiction of the State Board  
12 shall be eligible to serve on the State Board. ~~Furthermore, no~~No person who within the  
13 prior five years has been an employee of the Community Colleges System Office shall  
14 be eligible to serve on the State Board."

15 **SECTION 4.** G.S. 116-233(c) reads as rewritten:

16 "(c) No member of the General Assembly or officer or employee of the ~~State or~~  
17 ~~of~~State, ~~the School~~ School, The University of North Carolina, or of any constituent  
18 institution of The University of North Carolina, ~~or the spouse of any such member,~~  
19 ~~officer or employee~~, shall be eligible to be appointed to the Board of ~~Trustees;~~Trustees  
20 except as specified under subdivision (3) of subsection (a) of this section. No spouse of  
21 a member of the General Assembly, or of an officer or employee of the school may be a  
22 member of the Board of Trustees. and anyAny appointed trustee who is elected or  
23 appointed to the General Assembly or who becomes an officer or employee of the State,  
24 except as specified under subdivision (3) of subsection (a) of this section, of the School,  
25 ~~or of a constituent institution of The University of North Carolina~~, or whose spouse is  
26 elected or appointed to the General Assembly or becomes such an officer or  
27 ~~employee,~~employee of the School, shall be deemed thereupon to resign from his or her  
28 membership on the Board of Trustees. This subsection does not apply to ex officio  
29 members."

30 **SECTION 5.** This act is effective when it becomes law.
