5 The General Assembly of North Carolina enacts:

7 **PART I. INTRODUCTION AND TITLE OF ACT**

8
9 **INTRODUCTION**

10 **SECTION 1.1.** The appropriations made in this act are for maximum
11 amounts necessary to provide the services and accomplish the purposes described in the
12 budget in accordance with the State Budget Act. Savings shall be effected where the
13 total amounts appropriated are not required to perform these services and accomplish
14 these purposes, and the savings shall revert to the appropriate fund at the end of each
15 fiscal year, except as otherwise provided by law.

17 **TITLE OF ACT**

18 **SECTION 1.2.** This act shall be known as the "Current Operations and
19 Capital Improvements Appropriations Act of 2007."

24 **SECTION 2.1.** Appropriations from the General Fund of the State for the

36 **STATE BUDGET ACT APPLIES**

37 **SECTION 6.1.** The provisions of the State Budget Act, Chapter 143C of the
38 General Statutes, are reenacted and shall remain in full force and effect and are
39 incorporated in this act by reference.

41 **MOST TEXT APPLIES ONLY TO THE 2007-2009 FISCAL BIENNIUM**

42 **SECTION 6.2.** Except for statutory changes or other provisions that clearly
43 indicate an intention to have effects beyond the 2007-2009 fiscal biennium, the textual

1 provisions of this act apply only to funds appropriated for, and activities occurring
2 during, the 2007-2009 fiscal biennium.

4 **EFFECT OF HEADINGS**

5 **SECTION 6.3.** The headings to the parts and sections of this act are a
6 convenience to the reader and are for reference only. The headings do not expand,
7 limit, or define the text of this act, except for effective dates referring to a part.

8
9 **SEVERABILITY CLAUSE**

10 **SECTION 6.4.** If any section or provision of this act is declared
11 unconstitutional or invalid by the courts, it does not affect the validity of this act as a
12 whole or any part other than the part so declared to be unconstitutional or invalid.

13
14 **EFFECTIVE DATE**

15 **SECTION 6.5.** Except as otherwise provided, this act becomes effective
16 July 1, 2007.
