A BILL TO BE ENTITLED

1
2 AN ACT TO PERMIT THE COLUMBUS COUNTY BOARD OF ELECTIONS TO
3 USE A TRADITIONAL PRECINCT LINE ALONG THE BOUNDARY OF THE
4 BLACK CREEK SCHOOL DISTRICT AND TO PLACE ALL THE RESIDENTS
5 OF THE TOWN OF LAKE WACCAMAW IN THE SAME PRECINCT.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** Notwithstanding the provisions of G.S.163-132.3, the
8 Columbus County Board of Elections may designate precincts in Columbus County as
9 follows:

- 10 (1) Williams 1 Precinct: All of Williams 1 Precinct as shown on the
11 General Assembly's Redistricting Database on October 20, 2003,
12 minus the territory designated as part of South Williams Precinct in
13 subdivision (3) of this section.
- 14 (2) Williams 2 Precinct: All of Williams 2 Precinct as shown on the
15 General Assembly's Redistricting Database on October 20, 2003,
16 minus the territory designated as part of South Williams Precinct in
17 subdivision (3) of this section.
- 18 (3) South Williams Precinct: All of South Williams Precinct as shown on
19 the General Assembly's Redistricting Database on October 20, 2003,
20 and in addition the territory shown on that database as those parts of
21 Williams 1 Precinct and Williams 2 Precinct that lie south of the
22 boundary set for Williams and South Williams townships in Chapter
23 476 of the Session Laws of 1943, following what was commonly
24 known as the boundary of the Black Creek School District.

25 **SECTION 2.** Notwithstanding the provisions of G.S.163-132.3, the
26 Columbus County Board of Elections may designate precincts in Columbus County as
27 follows:

- 1 (1) Bogue Precinct: All of Bogue Precinct as shown on the General
2 Assembly's Redistricting Database on October 20, 2003, minus any
3 territory designated as part of Waccamaw Precinct in subdivision (3)
4 of this section.
- 5 (2) Bolton Precinct: All of Bolton Precinct as shown on the General
6 Assembly's Redistricting Database on October 20, 2003, minus the
7 territory designated as part of Waccamaw Precinct in subdivision (3)
8 of this section.
- 9 (3) Waccamaw Precinct: All of Waccamaw Precinct as shown on the
10 General Assembly's Redistricting Database on October 20, 2003, and
11 in addition the territory shown on that database as those parts of Bogue
12 Precinct and Bolton Precinct that lie within the municipal limits of the
13 Town of Lake Waccamaw on June 1, 2007.

14 **SECTION 3.** The Columbus County Board of Elections shall comply with
15 G.S. 163-132.5G. For purposes of compliance with that section, the precincts shall be
16 as the precincts were on January 1, 2007.

17 **SECTION 4.** This act is effective when it becomes law.
