A BILL TO BE ENTITLED

AN ACT TO MAKE TECHNICAL, CONFORMING, AND OTHER CHANGES TO
THE UNIFORM TRUST CODE AND OTHER RELATED STATUTES.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 28A-13-3(a)(5) reads as rewritten:

"(a) Except as qualified by express limitations imposed in a will of the decedent or a court order, and subject to the provisions of G.S. 28A-13-6 respecting the powers of joint personal representatives, a personal representative has the power to perform in a reasonable and prudent manner every act which a reasonable and prudent ~~man~~ person would perform incident to the collection, preservation, liquidation or distribution of a decedent's estate so as to accomplish the desired result of settling and distributing the decedent's estate in a safe, orderly, accurate and expeditious manner as provided by law, including ~~but not limited to~~ the powers specified in the following subdivisions:

...

(5) To deposit, as a fiduciary, funds of the estate in a bank, including a bank operated by the personal representative ~~upon compliance with the provisions of G.S. 36A-63.~~ pursuant to G.S. 53-163.1.

...."

SECTION 1.1. G.S. 32A-3 is amended by adding a new subsection to read:

"§ 32A-3. **Provisions not exclusive; reference to Chapter ~~32B.~~32B; limitations on authority.**

(a) The provisions of this Article are not exclusive and shall not bar the use of any other or different form of power of attorney desired by the parties concerned.

(b) A power of attorney under the provisions of this Article may refer to Chapter 32B as the same is set out in Chapter 626 of the 1983 Session Laws.

(c) Notwithstanding any other provision of this Chapter, no attorney-in-fact may exercise powers described in G.S. 36C-6-602A(a) to alter the designation of beneficiaries to receive property on the settlor's death under the settlor's existing estate

1 plan. This subsection shall not impair the authority of an attorney-in-fact to make gifts
2 of the principal's property, as provided in Articles 2A and 2B of this Chapter."

3 **SECTION 1.2.** G.S. 32A-14 is amended by adding a new subsection to read:

4 "**§ 32A-14. Powers of attorney executed under the provisions of G.S. 47-115.1;**
5 **reference to Chapter ~~32B~~32B; limitations on authority.**

6 (a) A power of attorney executed prior to October 1, 1988, pursuant to
7 G.S. 47-115.1 as it existed prior to October 1, 1983, shall be deemed to be a durable
8 power of attorney as defined in G.S. 32A-8.

9 (b) A power of attorney under the provisions of this Article may refer to Chapter
10 32B as the same is set out in Chapter 626 of the 1983 Session Laws.

11 (c) Notwithstanding any other provision of this Chapter, no attorney-in-fact may
12 exercise powers described in G.S. 36C-6-602A(a) to alter the designation of
13 beneficiaries to receive property on the settlor's death under the settlor's existing estate
14 plan. This subsection shall not impair the authority of an attorney-in-fact to make gifts
15 of the principal's property, as provided in Articles 2A and 2B of this Chapter."

16 **SECTION 1.3.** G.S. 36B-8 reads as rewritten:

17 "**§ 36B-8. Conflict with other law.**

18 To the extent that the provisions of this Chapter are inconsistent with the provisions
19 of either Chapter ~~36A~~ 36C or Chapter 55A, the provisions of this Chapter shall control.
20 The provisions of this Chapter shall not apply to the University of North Carolina."

21 **SECTION 2.** G.S. 36C-1-103 reads as rewritten:

22 "**§ 36C-1-103. Definitions.**

23 ~~In this~~ The following definitions apply in this Chapter:

- 24 (1) ~~"Action", with respect~~ Action. – When applicable to an act of a trustee,
25 includes a failure to act.
- 26 (2) ~~"Ascertainable standard" means a~~ Ascertainable standard. – A standard
27 relating to an individual's health, education, support, or maintenance
28 within the meaning of section 2041(b)(1)(A) or 2514(c)(1) of the
29 Internal Revenue Code.
- 30 (3) ~~"Beneficiary" means a~~ Beneficiary. – A person who:
31 a. Has a present or future beneficial interest in a trust, vested or
32 contingent, including the owner of an interest by assignment or
33 transfer; or
34 b. In a capacity other than that of trustee, holds a power of
35 appointment over trust property.
- 36 (4) ~~"Charitable trust" means a~~ Charitable trust. – A trust, including a
37 split-interest trust as described in section 4947 of the Internal Revenue
38 Code, created for a charitable purpose described in G.S. 36C-4-405(a).
- 39 (5) ~~"Environmental law" means a~~ Environmental law. – A federal, state, or
40 local law, rule, regulation, or ordinance relating to protection of the
41 environment.
- 42 (6) ~~"General guardian" means a general guardian as that term is~~ General
43 guardian. – As defined in G.S. 35A-1202(7).

- 1 (7) ~~"Guardian of the estate" means a guardian of the estate as that term is~~
2 Guardian of the estate. – As defined in G.S. 35A-1202(9).
- 3 (8) ~~"Guardian of the person" means a guardian of the person as that term~~
4 is Guardian of the person. – As defined in G.S. 35A-1202(10).
- 5 (9) ~~"Interests of the beneficiaries" means the~~ Interests of the beneficiaries.
6 ~~– The beneficial interests provided in the terms of the trust.~~
- 7 (10) ~~"Internal Revenue Code" means the~~ Internal Revenue Code. – The
8 Internal Revenue Code of 1986, as amended from time to time. Each
9 reference to a provision of the Internal Revenue Code shall include any
10 successor to that provision.
- 11 (11) ~~"Jurisdiction", with respect~~ Jurisdiction. – When applicable to a
12 geographic area, includes a state or country.
- 13 (12) ~~"Person" means an~~ Person. – An individual, corporation, business
14 trust, estate, trust, partnership, limited liability company, association,
15 joint venture, government; governmental subdivision, agency, or
16 instrumentality; public corporation, or any other legal or commercial
17 entity.
- 18 (13) ~~"Power of withdrawal" means a~~ Power of withdrawal. – A presently
19 exercisable general power of appointment other than a power:
20 a. Exercisable by a trustee and limited by an ascertainable
21 standard; or
22 b. Exercisable by another person only upon consent of the trustee
23 or a person holding an adverse interest.
- 24 (13a) Principal place of administration. – The trustee's usual place of
25 business where the records pertaining to the trust are kept or the
26 trustee's residence if the trustee has no usual place of business. In the
27 case of cotrustees, the principal place of administration is one of the
28 following:
29 a. The usual place of business of the corporate trustee if there is a
30 corporate cotrustee.
31 b. The usual place of business or residence of any of the cotrustees
32 if there is no corporate cotrustee.
- 33 (14) ~~"Property" means anything~~ Property. – Anything that may be the
34 subject of ownership, whether real or personal, legal or equitable, or
35 any interest therein.
- 36 (15) ~~"Qualified beneficiary" means a~~ Qualified beneficiary. – A living
37 beneficiary ~~who, to whom,~~ on the date the beneficiary's qualification is
38 determined; ~~determined,~~ any of the following apply:
39 a. Is a distributee or permissible distributee of trust income or
40 ~~principal;~~ principal.
41 b. Would be a distributee or permissible distributee of trust
42 income or principal if the interests of the distributees described
43 in sub-subdivision a. of this subdivision terminated on that date
44 without causing the trust to ~~terminate;~~ or terminate.

c. Would be a distributee or permissible distributee of trust income or principal if the trust terminated on that date.

(16) ~~"Revocable", as applied~~ Revocable. – When applicable to a trust, means revocable by the settlor without the consent of the trustee or a person holding an adverse interest.

(17) ~~"Settlor" means a~~ Settlor. – A person, including a testator, who creates, or contributes property to, a trust. If more than one person creates or contributes property to a trust, each person is a settlor of the portion of the trust property attributable to that person's contribution except to the extent another person has the power to revoke or withdraw that portion.

(18) ~~"Spendthrift provision" means a~~ Spendthrift provision. – A term of a trust that restrains both voluntary and involuntary transfer of a beneficiary's interest.

(19) ~~"State" means a~~ State. – A state of the United States, the District of Columbia, Puerto Rico, the United States Virgin Islands, or any territory or insular possession subject to the jurisdiction of the United States. The term includes an Indian tribe or band recognized by federal law or formally acknowledged by a state.

(20) ~~"Terms of a trust" means the~~ Terms of a trust. – The manifestation of the settlor's intent regarding a trust's provisions as expressed in the trust instrument or established in a judicial proceeding.

(21) ~~"Trust instrument" means an~~ Trust instrument. – An instrument executed by the settlor that contains terms of the trust, including any amendments to the instrument, and any modifications permitted by court order.

(22) ~~"Trustee" includes~~ Trustee. – Includes an original, additional, and successor trustee, and a cotrustee, whether or not appointed or confirmed by a court. The term does not include trustees in mortgages and deeds of trusts."

SECTION 3. G.S. 36C-1-105(b) reads as rewritten:

"(b) The terms of a trust prevail over any provision of this Chapter except:

- (1) The requirements for creating a trust;
- (2) The duty of a trustee to act in good faith and in accordance with the terms and purposes of the trust and the interests of the beneficiaries;
- (3) The requirement that a trust and its terms be for the benefit of its beneficiaries, and that the trust have a purpose that is lawful, not contrary to public policy, and possible to achieve;
- (4) The power of the court to modify or terminate a trust under G.S. 36C-4-410 through G.S. 36C-4-416;
- (5) The effect of a spendthrift provision and the rights of certain creditors and assignees to reach a trust as provided in Article 5 of this Chapter;
- (6) The effect of an exculpatory term under G.S. 36C-10-1008;

- 1 (7) The rights under G.S. 36C-10-1010 through G.S. 36C-10-1013 of a
2 person other than a trustee or beneficiary;
3 (8) Periods of limitation for commencing a judicial proceeding;
4 (9) The power of the court to take any action and exercise any jurisdiction
5 as may be necessary in the interests of justice; ~~and~~
6 (10) The subject-matter jurisdiction of the court and venue for commencing
7 a proceeding as provided in G.S. 36C-2-203 and ~~G.S. 36C-2-204.~~
8 G.S. 36C-2-204; and
9 (11) The requirement that the exercise of the powers described in
10 G.S. 36C-6-602A(a) shall not alter the designation of beneficiaries to
11 receive property on the settlor's death under that settlor's existing estate
12 plan."

13 **SECTION 4.** G.S. 36C-1-107 reads as rewritten:

14 "(a) The meaning and effect of the terms of a trust are determined ~~by:~~ by any of
15 the following:

- 16 (1) The law of the jurisdiction designated in the terms unless the
17 designation of that jurisdiction's law is contrary to a strong public
18 policy of the jurisdiction having the most significant relationship to the
19 matter at ~~issue;~~ ~~or~~ issue.
20 (2) In the absence of a controlling designation in the terms of the trust, the
21 law of the jurisdiction having the most significant relationship to the
22 matter at issue.

23 (b) Notwithstanding subsection (a) of this section, the rights of a person other
24 than a trustee or beneficiary are governed by G.S. 36C-10-1010 through
25 G.S. 36C-10-1013."

26 **SECTION 5.** G.S. 36C-1-109(a) reads as rewritten:

27 "(a) Subject to subsection (d) of this section, notice ~~Notice~~ to a person under this
28 Chapter or the sending of a document to a person under this Chapter must be
29 accomplished in a manner reasonably suitable under the circumstances and likely to
30 result in receipt of the notice or document.

- 31 (1) Permissible methods of notice or methods for sending a document
32 include first-class mail, personal delivery, delivery to the person's last
33 known place of residence or place of business, or a properly directed
34 electronic message.
35 (2) Notice shall be deemed to be given upon the occurrence of any of the
36 following:
37 a. When personally delivered by hand to the person.
38 b. When transmitted by facsimile.
39 c. When placed in the hands of a nationally recognized courier
40 service for delivery.
41 d. When received by the person if sent by registered or certified
42 United States mail, return receipt requested.

1 e. Three days after depositing the notice in a regularly maintained
2 receptacle for the deposit of United States mail if sent by
3 regular United States mail.

4 (3) Notice by any means other than those described in subdivision (2) of
5 this subsection shall be deemed to be given for all purposes upon the
6 date of actual receipt."

7 **SECTION 6.** G.S. 36C-2-203(a) reads as rewritten:

8 "(a) The clerks of superior court of this State have original jurisdiction over all
9 proceedings concerning the internal affairs of trusts. Except as provided in subdivision
10 (9) of this subsection, the clerk of superior court's jurisdiction is exclusive. Proceedings
11 concerning the internal affairs of the trust are those concerning the administration and
12 distribution of trusts, the declaration of rights, and the determination of other matters
13 involving trustees and trust beneficiaries, to the extent that those matters are not
14 otherwise provided for in the governing instrument. These include proceedings:

15 (1) To appoint or remove a trustee; trustee, including the appointment and
16 removal of a trustee pursuant to G.S. 36C-4-414(b).

17 (2) ~~To permit a trustee to resign or renounce; however, unless the trustee~~
18 ~~is required to account to the clerk of superior court, when the~~
19 ~~governing instrument names or provides a procedure to name a~~
20 ~~successor trustee, and the successor trustee is willing to serve, no~~
21 ~~trustee is required to initiate a proceeding to resign or renounce as~~
22 ~~trustee; To approve the resignation of a trustee.~~

23 (3) To review trustees' fees under Article 6 of Chapter 32 of the General
24 Statutes and review and settle interim or final accounts; accounts.

25 (4) To (i) convert an income trust to a total return unitrust, (ii) reconvert a
26 total return unitrust to an income trust, or (iii) change the percentage
27 used to calculate the unitrust amount or the method used to determine
28 the fair market value of the trust as provided in G.S. 37A-1-104.3;
29 G.S. 37A-1-104.3.

30 (5) To transfer a trust's principal place of administration; administration.

31 (6) To require a trustee to provide bond and determine the amount of the
32 bond, excuse a requirement of bond, reduce the amount of bond,
33 release the surety, or permit the substitution of another bond with the
34 same or different sureties; sureties.

35 (7) To make orders with respect to a trust for the care of animals as
36 provided in G.S. 36C-4-408; G.S. 36C-4-408.

37 (8) To make orders with respect to a noncharitable trust without an
38 ascertainable beneficiary as provided in G.S. 36C-4-409; and
39 G.S. 36C-4-409.

40 (9) To ascertain beneficiaries, to determine any question arising in the
41 administration or distribution of any trust, including questions of
42 construction of trust instruments, and to determine the existence or
43 nonexistence of trusts created other than by will and the existence or
44 nonexistence of any immunity, power, privilege, duty, or right. Upon

1 motion of a party, the clerk of superior court may determine that a
2 proceeding to determine an issue listed in this subdivision shall be
3 originally heard by the superior court division of the General Court of
4 Justice. Any party may file a notice of transfer of a proceeding
5 pursuant to this subdivision to the superior court division of the
6 General Court of Justice as provided in G.S. 36C-2-205(g1). In the
7 absence of a transfer to Superior Court, Article 26 of Chapter 1 of the
8 General Statutes shall apply to a trust proceeding pending before the
9 clerk of superior court to the extent consistent with this Article."

10 **SECTION 7.** G.S. 36C-2-203(c) reads as rewritten:

11 "(c) Nothing in this section affects the right of a person to file an action in the
12 Superior Court Division of the General Court of Justice for declaratory relief under
13 Article 26 of Chapter 1 of the General Statutes. ~~In the event either the petitioner or~~
14 ~~respondent in a trust proceeding requests declaratory relief under Article 26 of Chapter~~
15 ~~1 of the General Statutes, either party may move for a transfer of the proceeding to the~~
16 ~~superior court division of the General Court of Justice as provided in Article 21 of~~
17 ~~Chapter 7A of the General Statutes. In absence of removal to superior court, Article 26~~
18 ~~of Chapter 1 of the General Statutes shall apply to a trust proceeding to the extent~~
19 ~~consistent with this Article."~~

20 **SECTION 8.** G.S. 36C-2-204 reads as rewritten:

21 "**§ 36C-2-204. Venue.**

22 In any trust ~~proceeding or action, proceeding,~~ whether brought before the clerk of
23 superior court or the superior court division of the General Court of Justice, the
24 following rules apply notwithstanding any other applicable Rule of Civil Procedure or
25 provision of Chapter 1 of the General Statutes:

- 26 (1) If the trustee is required to account to the clerk of superior court, then
27 unless the terms of the governing instrument provide otherwise, venue
28 for proceedings under G.S. 36C-2-203 involving trusts is the place
29 where the accountings are filed.
- 30 (2) If the trustee is not required to account to the clerk of superior court,
31 then unless the terms of the governing instrument provide otherwise,
32 venue for proceedings under G.S. 36C-2-203 involving trusts ~~is:~~ is
33 either of the following:
- 34 a. In the case of an inter vivos trust, in any county of this State in
35 which the trust has its principal place of administration or
36 where any beneficiary ~~resides;~~ resides.
- 37 b. In the case of a testamentary trust, in any county of this State in
38 which the trust has its principal place of administration, where
39 any beneficiary resides, or in which the testator's estate was
40 administered.
- 41 (3) ~~Unless otherwise designated in the governing instrument, the principal~~
42 ~~place of administration of the trust is the trustee's usual place of~~
43 ~~business where the records pertaining to the trust are kept, or at the~~
44 ~~trustee's residence if the trustee has no such place of business. In the~~

1 ease of cotrustees, the principal place of administration, if not
2 otherwise designated in the governing instrument, is:

3 a. The usual place of business of the corporate trustee if there is
4 but one corporate or cotrustee; or

5 b. The usual place of business or residence of any of the
6 cotrustees.

- 7 (4) If a trust has no trustee, venue for a judicial proceeding for the
8 appointment of a trustee is in any county of this State in which a
9 beneficiary resides, in any county in which trust property is located, in
10 the county of this State specified in the trust instrument, if any county
11 is so specified, or if the trust is created by will, in the case of a
12 testamentary trust, in the county in which the decedent's estate was or
13 is being administered."

14 **SECTION 9.** G.S. 36C-2-205 is amended by adding a new subsection to
15 read:

16 "(g1) Notice of Transfer. – A notice to transfer a trust proceeding brought pursuant
17 to G.S. 36C-2-203(a)(9) must be served within 30 days after the moving party is served
18 with a copy of the pleading requesting relief pursuant to G.S. 36C-2-203(a)(9). Failure
19 to timely serve a notice of transfer of a trust proceeding is a waiver of any objection to
20 the clerk of superior court's exercise of jurisdiction over the trust proceeding then
21 pending before the clerk. When a notice of transfer is duly served and filed, the clerk
22 shall transfer the proceeding to the appropriate court. The proceeding after the transfer
23 is subject to the provisions of the General Statutes and to the rules that apply to actions
24 initially filed in the court to which the proceeding was transferred."

25 **SECTION 9.1.** G.S. 36C-2-205 is amended by adding a new subsection to
26 read:

27 "(i) Notice to Attorney General. – In every trust proceeding with respect to a
28 charitable trust, the Attorney General shall be notified and given an opportunity to be
29 heard."

30 **SECTION 10.** G.S. 36C-2-205(h) reads as rewritten:

31 "(h) Orders Upon ~~Consolidation/Joinder~~ Consolidation/Joinder/Transfer. – Upon
32 the consolidation of a trust proceeding and ~~civil action or a civil action~~, joinder of
33 claims under subsection (f) or (g) of this ~~section~~ section, or transfer to the Superior
34 Court Division of the General Court of Justice pursuant to subsection (g1) of this
35 section, the clerk of superior court or the judge may make ~~such~~ appropriate orders as
36 appropriate to protect the interests of the parties and to avoid unnecessary costs or
37 delay. Notwithstanding the ~~consolidation or joinder~~ consolidation, joinder of claims
38 under subsection (f) or (g) of this section, or transfer to the Superior Court Division of
39 the General Court of Justice under subsection (g1) of this section, the clerk of superior
40 court's exclusive jurisdiction as set forth in ~~G.S. 36C-2-203(a)~~ G.S. 36C-2-203(a)(1)
41 through (8) shall not be stayed unless so ordered by the court."

42 **SECTION 11.** G.S. 36C-3-303 reads as rewritten:

43 "**§ 36C-3-303. Representation by fiduciaries, parents, and other persons.**

1 To the extent that there is no conflict of interest between the representative and the
2 person represented or among those being represented with respect to a particular
3 question or ~~dispute~~: dispute involving a trust:

- 4 (1) A general guardian or a guardian of the estate may represent and bind
5 the estate that the guardian controls.
- 6 (2) ~~A guardian of the person may represent and bind the ward if a general~~
7 ~~guardian or guardian of the estate of the ward's estate has not been~~
8 ~~appointed.~~
- 9 (3) An agent under a power of attorney having authority to act with
10 respect to the particular question or dispute may represent and bind the
11 principal.
- 12 (4) A trustee may represent and bind the beneficiaries of the ~~trust~~: trust
13 unless the question or dispute involves the internal affairs of the trust.
- 14 (5) A personal representative of a decedent's estate may represent and bind
15 persons interested in the estate.
- 16 (6) A parent may represent and bind the parent's minor child if a general
17 ~~guardian, guardian or guardian of the estate, or guardian of the person~~
18 ~~estate~~ for the child has not been appointed. If a disagreement arises
19 between parents seeking to represent the same minor child, the parent
20 who is a beneficiary of the trust that is the subject of the representation
21 is entitled to represent the minor child or, if no parent is a beneficiary
22 of the trust that is the subject of the representation, a parent who is a
23 lineal descendant of the settlor is entitled to represent the minor child,
24 or if no parent is a lineal descendant of the settlor, a guardian ad litem
25 shall be appointed to represent the minor child.
- 26 (7) A person may represent and bind that person's unborn issue."

27 **SECTION 12.** G.S. 36C-3-304 reads as rewritten:

28 "**§ 36C-3-304. Representation by person having substantially identical interest.**

29 Unless otherwise represented under this Article, a minor, an ~~incapacitated~~
30 incompetent or unborn individual, or a person whose identity or location is unknown
31 and not reasonably ascertainable, may be represented by and bound by another having a
32 substantially identical interest with respect to the particular question or dispute, but only
33 to the extent that there is no conflict of interest between the representative and the
34 person ~~represented~~: represented with respect to the particular question or dispute."

35 **SECTION 13.** G.S. 36C-3-305(a) reads as rewritten:

36 "(a) If the court determines that an interest is not represented under this Article, or
37 that the otherwise available representation might be inadequate, the court may appoint a
38 guardian ad litem to receive notice, give consent, and otherwise represent, bind, and act
39 on behalf of a minor, ~~incapacitated~~ an incompetent or unborn individual, or a person
40 whose identity or location is unknown. A guardian ad litem may be appointed to
41 represent several persons or interests."

42 **SECTION 14.** G.S. 36C-4-401 reads as rewritten:

43 "**§ 36C-4-401. Methods of creating trust.**

44 A trust may be created ~~by~~: by any of the following methods:

- 1 (1) Transfer of property by a settlor to a person as trustee during the
2 settlor's lifetime or by will or other disposition taking effect upon the
3 settlor's ~~death;~~ death including either of the following:
4 a. The devise or bequest to the trustee of the trust as provided in
5 G.S. 31-47.
6 b. The designation of the trust as beneficiary of life insurance or
7 other death benefits as provided in G.S. 36C-4-401.1.
8 (2) Declaration by the owner of property that the owner holds identifiable
9 property as trustee unless the transfer of title of that property is
10 otherwise required by ~~law;~~ or law.
11 (3) Exercise of a power of appointment in favor of a trustee."

12 **SECTION 15.** G.S. 36C-4-409 reads as rewritten:

13 **"§ 36C-4-409. Noncharitable trust without ascertainable beneficiary.**

14 Except as otherwise provided in G.S. 36C-4-408 or by another statute, the following
15 rules apply:

- 16 (1) A trust may be created for a noncharitable purpose without a definite
17 or definitely ascertainable beneficiary or for a noncharitable but
18 otherwise valid purpose to be selected by the trustee. The trust may not
19 be enforced for more than 21 years. If the trust is still in existence after
20 21 years, the trust shall terminate. The unexpended trust property shall
21 be transferred in the following order:
22 a. As directed in the trust instrument.
23 b. If the trust was created in a preresiduary clause in the settlor's
24 will or in a codicil to the settlor's will, under the residuary
25 clause in the settlor's will.
26 c. If no taker is produced by the application of sub-subdivisions a.
27 or b. of this subdivision, to the settlor, if then living, otherwise
28 to the settlor's heirs as determined under Chapter 29 of the
29 General Statutes as of the date of the settlor's death.

25 nor more than five percent (5%), taking into account the intentions of the ~~grantor~~ settlor
26 of the trust as expressed in the governing instrument, the needs of the beneficiaries,
27 general economic conditions, projected current earnings and appreciation for the trust,
28 and projected inflation and its impact on the trust."

29 **SECTION 49.1.** G.S. 37A-1-104.7 is repealed.

30 **SECTION 50.** G.S. 37A-1-104.9 reads as rewritten:

31 **"§ 37A-1-104.9. Applicability.**

32 This Part shall apply to all trusts in existence on, or created after January 1, 2004,
33 unless (i) the governing instrument contains a provision clearly expressing the ~~grantor's~~
34 settlor's intention that the current beneficiary or beneficiaries are to receive an amount
35 other than a reasonable current return from the trust, (ii) the trust is a trust described in
36 section 170(f)(2)(B), section 664(d), section 2702(a)(3), or section 2702(b) of the Code,
37 (iii) the trust is a trust under which any amount is, or has been in the past, set aside
38 permanently for charitable purposes unless the income from the trust also is devoted
39 permanently to charitable purposes, or (iv) the governing instrument expressly prohibits
40 use of this Part by specific reference to this Part, or expressly states the ~~grantor's~~
41 settlor's intent that net income not be calculated as a unitrust amount. A provision in the
42 governing instrument that "the provisions of Part 2 of Article 1 of Chapter 37A of the
43 General Statutes or any corresponding provision of future law, shall not be used in the
44 administration of this trust." or "the trustee shall not determine the distributions to the

1 income beneficiary as a unitrust amount." or similar words reflecting that intent is
2 sufficient to preclude the use of this Part."

3 **SECTION 51.** G.S. 53-163.2 reads as rewritten:

4 **"§ 53-163.2. Investments in securities by banks or trust companies.**

5 Unless the governing instrument, court order, or a statute specifically directs
6 otherwise, a bank or trust company serving as trustee, guardian, agent, or in any other
7 fiduciary capacity may invest in any security authorized by this Chapter even if such
8 fiduciary or an affiliate thereof, as defined in G.S. 36A-60(1), thereof participates or has
9 participated as a member of a syndicate underwriting such security, if:

- 10 (1) The fiduciary does not purchase the security from itself or its affiliate;
11 and
12 (2) The fiduciary does not purchase the security from another syndicate
13 member or an affiliate, pursuant to an implied or express agreement
14 between the fiduciary or its affiliate and a selling member or its
15 affiliate, to purchase all or part of each other's underwriting
16 commitments."

17 **SECTION 52.** G.S. 35A-1251(24) reads as rewritten:

18 **"§ 35A-1251. Guardian's powers in administering incompetent ward's estate.**

19 In the case of an incompetent ward, a general guardian or guardian of the estate has
20 the power to perform in a reasonable and prudent manner every act that a reasonable
21 and prudent person would perform incident to the collection, preservation, management,
22 and use of the ward's estate to accomplish the desired result of administering the ward's
23 estate legally and in the ward's best interest, including but not limited to the following
24 specific powers:

- 25 ...
26 (24) To petition the court for ~~prior approval of transfers of assets of the~~
27 ~~ward of the exercise of any of the following powers with respect to~~
28 ~~a revocable trust executed by the ward that the ward, if competent, prior~~
29 ~~to the ward being declared incompetent, provided that the ward~~
30 ~~executed a paper writing with all the formalities required by the laws~~
31 ~~of North Carolina for the execution of a valid will prior to the ward~~
32 ~~being declared incompetent and that will directs that the assets that are~~
33 ~~being transferred to the trust are to be distributed to the trust at the~~
34 ~~ward's death or the revocable trust has the same dispositive provisions~~
35 ~~as the ward's will or provides that the assets in the trust are to be~~
36 ~~distributed to the ward's estate upon the death of the ward. The~~
37 ~~guardian may at any time withdraw any assets (or the proceeds of the~~
38 ~~sale of any assets) transferred by the guardian to the trust upon 30~~
39 ~~days' written notice to the trustee of the trust; provided, however, no~~
40 ~~assets which have been distributed or otherwise disposed of by the~~
41 ~~trustee (before the notice is received by the trustee) in accordance with~~
42 ~~the terms of the trust can be so withdrawn. could exercise as settlor of~~
43 ~~the revocable trust:~~

- 44 a. Revocation of the trust.

- 1 b. Amendment of the trust.
2 c. Additions to the trust.
3 d. Direction to dispose of property of the trust.
4 e. The creation of the trust, notwithstanding the provisions of
5 G.S. 36C-4-402(a)(1) and (2).

6 The exercise of the powers described in this subdivision (i) shall
7 not alter the designation of beneficiaries to receive property on the
8 ward's death under that ward's existing estate plan; and (ii) shall be
9 subject to the provisions of Articles 17, 18, and 19 of this Chapter
10 concerning gifts."

11 **SECTION 53.** This act becomes effective October 1, 2007, and applies to (i)
12 all trusts created before, on, or after that date; (ii) all judicial proceedings concerning
13 trusts commenced on or after that date; and (iii) all judicial proceedings concerning
14 trusts commenced before that date unless the court finds that application of a particular
15 provision of this act would substantially interfere with the effective conduct of the
16 judicial proceedings or prejudice the rights of the parties, in which case the law as it
17 existed on September 30, 2007, shall apply.
18
