A BILL TO BE ENTITLED

1 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE  
2 RECOMMENDATION OF THE SPEAKER OF THE HOUSE OF REPRESENTATIVES  
3 AND THE PRESIDENT PRO TEMPORE OF THE SENATE AND TO FILL AN  
4 UNEXPIRED TERM OF A MEMBER OF THE BOARD OF DIRECTORS FOR THE  
5 NORTH CAROLINA PARTNERSHIP FOR CHILDREN, INC., UPON THE  
6 RECOMMENDATION OF THE MAJORITY LEADER OF THE SENATE.

8 Whereas, G.S. 120-121 authorizes the General Assembly to make certain  
9 appointments to public offices upon the recommendation of the Speaker of the House of  
10 Representatives and the President Pro Tempore of the Senate; and

11 Whereas, the Speaker of the House of Representatives and the President Pro  
12 Tempore of the Senate have made recommendations; Now, therefore,  
13 The General Assembly of North Carolina enacts:
