GOVERNING BODY. 6 "Section 3.1. Structure of Governing Body; Number of Members. The governing body 7 of the Town of Archer Lodge is the Town Council and the Mayor. The Council has five 8 members. 9 "Section 3.2. Manner of Electing Council; Term of Office. The qualified voters of the 10 entire Town shall elect the members of the Council. Except as provided in this section, they shall serve four-year terms. In 2011, five members of the Council shall be elected. The three 11 12 persons receiving the highest numbers of votes shall be elected to four-year terms, and the two 13 persons receiving the next highest numbers of votes shall be elected to two-year terms. In 2013 14 and quadrennially thereafter, two members shall be elected to four-year terms. In 2015 and 15 quadrennially thereafter, three members shall be elected to four-year terms. Vacancies on the 16 Town Council shall be filled in accordance with G.S. 160A-63. 17 "Section 3.3. Manner of Electing Mayor; Term of Office; Duties. The qualified voters of 18 the entire town shall elect the Mayor. In 2011 and quadrennially thereafter, the Mayor shall be 19 elected for a term of four years. The Mayor shall attend and preside over meetings of the Town 20 Council and shall advise the Town Council from time to time as to matters involving the Town 21 of Archer Lodge. The Mayor may vote only on matters before the Council in order to break a 22 tie. 23 "Section 3.4. Manner of Electing Mayor Pro Tempore; Term of Office; Duties. The 24 Mayor Pro Tempore shall be elected from among the members of the Town Council at the 25 organizational meeting after the initial election in November 2011 and shall serve for a term of 26 two years. The Mayor Pro Tempore shall act in the absence or disability of the Mayor. If the Mayor and Mayor Pro Tempore are both absent from a meeting of the Town Council, the 27 28 members of the Town Council present may elect a temporary chairman to preside in the 29 absence. The Mayor Pro Tempore shall have the right to vote on all matters before the Town 30 Council and shall be considered a member of the Town Council for all purposes. 31 "Section 3.5. Compensation of Mayor and Town Council. The Mayor and members of 32 the Town Council may be reimbursed for ordinary and necessary expenses. 33 "ARTICLE IV. ELECTIONS. 34 "Section 4.1. Conduct of Town Elections. Elections shall be conducted on a nonpartisan 35 basis and results determined by a plurality as provided in G.S. 163-292. 36 "Section 4.2. Date of Election. Elections shall be conducted in accordance with Chapter 37 163 of the General Statutes, except that the first election shall be held on November 8, 2011. 38 "Section 4.3. Special Elections and Referenda. Special elections and referenda may be 39 held only as provided by general law or applicable local acts of the General Assembly. 40 "ARTICLE V. FORM OF GOVERNMENT. 41 "Section 5.1. Form of Government. The Town of Archer Lodge operates under the 42 mayor-council plan as provided in Part 3 of Article 7 of Chapter 160A of the General Statutes. 43 "ARTICLE VI. TAXES AND BUDGET. 44 "Section 6.1. Powers of the Town Council. The Town Council may levy those taxes and 45 fees authorized by general law. An affirmative vote equal to a majority of all the members of 46 the Town Council shall be required to change the ad valorem tax rate from the rate established 47 during the prior fiscal year. 48 "Section 6.2. Present Use Value. If an area described in this Ordinance includes 49 agricultural land, horticultural land, or forestland that on the effective date of incorporation is 50 land that is being taxed at present-use value, the land shall continue to be valued for tax 51 purposes at present-use value as long as the land so qualifies.

# "ARTICLE VII. ORDINANCES.

"Section 7.1. Ordinances. Except as otherwise provided in this Charter, the Town of
Archer Lodge is authorized to adopt such ordinances as the Town Council deems necessary for
the governance of the Town.

#### "ARTICLE VIII. MISCELLANEOUS.

6 "Section 8.1. **Conflicts of Interest.** No person, or member of the person's immediate 7 family, who is employed by or is an official, appointed or elected, of the Town of Archer 8 Lodge, shall do business with the Town unless such activity is approved by the Town Council. 9 All officials of the Town shall inform the Town Council of any conflicts of interest, and the 10 failure to so inform shall constitute grounds for immediate dismissal or removal for cause. No 11 official of the Town may accept any gratuity from any businessperson or other official if the 12 gratuity is related to that official's official duties.

13 "Section 8.2. Enlargement of Town Council. The qualified voters of the Town of Archer Lodge may seek to enlarge the number of members of the Town Council by submitting a 14 petition to that effect signed by twenty percent (20%) of the qualified voters. Upon passage of a 15 resolution as provided in G.S. 160A-102 or upon receipt of a valid petition, the Town Council 16 17 shall immediately take steps as provided in Part 4 of Article 5 of Chapter 160A of the General 18 Statutes to determine by referendum whether the number of members of the Town Council 19 should be increased. If a majority of the votes cast in the referendum are in the affirmative, a 20 special election shall be held at the earliest possible date to elect the additional members 21 required to enlarge the Town Council to the number set forth in the referendum.

22 "Section 8.3. Provision of Services and Administration of Functions. The Town Council 23 may enter into agreements with other governmental bodies and private enterprises for the 24 provision of services and the administration of corporate functions in order to provide the 25 services and administer the functions in the most efficient and cost-effective manner."

26 SECTION 2. From and after January 1, 2009, the citizens and property in the 27 Town of Archer Lodge shall be subject to municipal taxes levied for the year beginning 28 January 1, 2009, and for that purpose the Town shall obtain from Johnston County a record of 29 property in the area herein incorporated that was listed for taxes as of January 1, 2009, and the 30 businesses in the Town shall be liable for privilege license tax from the effective date of the 31 privilege license ordinance. For fiscal year 2009-2010, ad valorem taxes may be paid at par or 32 face amount within 90 days of adoption of the budget ordinance, and thereafter in accordance 33 with the schedule in G.S. 105-360 as if the taxes had been due and payable on September 1, 34 2009. The Town may adopt a budget ordinance for fiscal year 2009-2010 without following the 35 timetable in the Local Government Budget and Fiscal Control Act.

**SECTION 3.** The Johnston County Board of Elections shall conduct an election on November 3, 2009, for the purpose of submission to the qualified voters for the area described in Section 2.1 of the Charter of the Town of Archer Lodge the question of whether or not the area shall be incorporated as the Town of Archer Lodge. Registration for the election shall be conducted in accordance with G.S. 163-288.2.

**SECTION 4.** In the election, the question on the ballot shall be:

"[]FOR []AGAINST

Incorporation of the Town of Archer Lodge."

44 **SECTION 5.** In the election, if a majority of the votes are cast "FOR the 45 Incorporation of the Town of Archer Lodge," Sections 1 and 2 of this act shall become 46 effective on the date that the Johnston County Board of Elections certifies the results of the 47 election. Otherwise, Sections 1 and 2 of this act shall have no force and effect.

48 **SECTION 6.** Until members of the Council are elected in 2011 in accordance with 49 Section 4.1 of the Town Charter and the laws of North Carolina, Jeff Barnes, Clyde 50 Castleberry, Matt Mulhollem, John Perry, and Anne Taylor are appointed to serve as the 51 interim Council, and Mike Gordon is appointed the interim Mayor. They shall possess and

exercise the powers granted to the governing body until their successors are elected or 1 appointed and qualified pursuant to Articles III and IV of this Charter. If any person named in

- 3 this Charter is unable to serve, the remaining interim Council members shall, by a majority
- 4 vote, appoint a person to serve until the initial municipal election is held in 2011.
- **SECTION 7.** This act is effective when it becomes law. 5
