Short Title: Restore Contract Rights to State/Local. (Public)

1 **A BILL TO BE ENTITLED**

2 **AN ACT TO RESTORE CONTRACT RIGHTS TO STATE AND LOCAL ENTITIES.**

3 The General Assembly of North Carolina enacts:

4 **SECTION 1.** G.S. 95-98 is repealed.

5 **SECTION 2.** G.S. 135-18.8 reads as rewritten:

6 **"§ 135-18.8. Deduction for payments to certain employees' or retirees' associations
7 allowed.**

8 Any beneficiary who is a member of a domiciled employees' or retirees' association that has
9 at least 2,000 members, the majority of whom are active or retired employees of the State or
10 public school employees, may authorize, in writing, the periodic deduction from the
11 beneficiary's retirement benefits a designated lump sum to be paid to the employees' or retirees'
12 association. The authorization shall remain in effect until revoked by the beneficiary. ~~A plan of
13 deductions pursuant to this section shall become void if the employees' or retirees' association
14 engages in collective bargaining with the State, any political subdivision of the State, or any
15 local school administrative unit.~~"

16 **SECTION 3.** G.S. 143B-426.40A(g) reads as rewritten:

17 "(g) Payroll Deduction for Payments to Certain Employees' Associations Allowed. – An
18 employee of the State or any of its political subdivisions, institutions, departments, bureaus,
19 agencies or commissions, or any of its local boards of education or community colleges, who is
20 a member of a domiciled employees' association that has at least 2,000 members, 500 of whom
21 are employees of the State, a political subdivision of the State, or public school employees, may
22 authorize, in writing, the periodic deduction each payroll period from the employee's salary or
23 wages a designated lump sum to be paid to the employees' association. A political subdivision
24 may also allow periodic deductions for a domiciled employees' association that does not
25 otherwise meet the minimum membership requirements set forth in this paragraph.

26 An employee of any local board of education who is a member of a domiciled employees'
27 association that has at least 40,000 members, the majority of whom are public school teachers,
28 may authorize in writing the periodic deduction each payroll period from the employee's salary
29 or wages a designated lump sum or sums to be paid for dues and voluntary contributions for the
30 employees' association.

31 An authorization under this subsection shall remain in effect until revoked by the employee.
32 ~~A plan of payroll deductions pursuant to this subsection for employees of the State and other
33 associations members shall become void if the employees' association engages in collective
34 bargaining with the State, any political subdivision of the State, or any local school~~



1 ~~administrative unit.~~ This subsection does not apply to county or municipal governments or any
2 local governmental unit, except for local boards of education."

3 **SECTION 4.** Of the funds appropriated to the Office of State Personnel in fiscal
4 year 2009-2010, the sum of one hundred thousand dollars (\$100,000) shall be allocated to
5 develop a proposal for an employee negotiation process and to designate a coordinator of
6 employee negotiations for State employees. The Office of State Personnel in consultation with
7 the Director of the Budget shall establish the criteria for certification of employee organizations
8 to participate in the negotiation process and identify the appropriate employer representative.
9 The Office of State Personnel shall report on its proposal for a State employee negotiation
10 process to the Joint Legislative Commission on Governmental Operations on or before April 1,
11 2009.

12 **SECTION 5.** Section 4 of this act is effective when it becomes law. The remainder
13 of this act becomes effective July 1, 2009.
