Short Title: Study Comm./Youth Aging Out of Foster Care. (Public) Sponsors: Referred to:

A BILL TO BE ENTITLED AN ACT AUTHORIZING A JOINT LEGISLATIVE STUDY COMMISSION ON YOUTH TRANSITIONING OUT OF FOSTER CARE.

The General Assembly of North Carolina enacts:

SECTION 1.(a) There is created the Joint Legislative Study Commission on Youth Transitioning Out of Foster Care. The Commission shall consist of 12 members appointed as follows:

- (1) Six members appointed by the Speaker of the House of Representatives, to include:
 - Four members of the House of Representatives. a.
 - Two members of the general public, one of whom is a youth who has b. aged out of foster care.
- Six members appointed by the President Pro Tempore of the Senate, to (2) include:
 - Four members of the Senate. a.
 - Two members of the general public, one of whom is a person who b. provides transitional living services to youths aging out of foster care.

The Speaker of the House of Representatives and the President Pro Tempore of the Senate shall each appoint a cochair for the Commission. Vacancies on the Commission shall be filled by the same appointing authority who made the initial appointment. The Commission may meet at any time upon the joint call of the cochairs. The Commission may meet in the Legislative Building or the Legislative Office Building. The Commission may contract for consultant services as provided by G.S. 120-32.02.

SECTION 1.(b) The Commission, while in the discharge of its official duties, may exercise all powers provided for under G.S. 120-19 and G.S. 120-19.1 through G.S. 120-19.4, including the power to request all officers, agents, agencies, and departments of the State to provide any information, data, or documents within their possession, ascertainable from their records, or otherwise available to them and the power to subpoena witnesses.

SECTION 1.(c) The Legislative Services Commission, through the Legislative Services Officer, shall assign professional staff to assist the Commission in its work. The House of Representatives and Senate's Directors of Legislative Assistants shall assign clerical staff to the Commission, and the expenses relating to the clerical employees shall be borne by the Commission. Members of the Commission shall receive subsistence and travel expenses at the rates set forth in G.S. 120-3.1, 138-5, or 138-6, as appropriate.
